## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of United Dairy, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of United Dairy, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE 1 - DESCRIPTION OF THE PLAN**

---

The following description of the United Dairy, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan and is referred to as a “safe harbor 401(k) plan,” covers all eligible employees of United Dairy, Inc. (the “Company”) who have one year of service and are age eighteen or older. Effective January 1, 2022, the Plan was restated with respect to provisions for the appropriate laws commonly known as a Cycle 3 restatement as well as crediting services for those employees from Prairie Farms. The Plan is subject to the provisions of the Employee Retirement Income Act of 1974 (“ERISA”). The Administrative Committee oversees governance of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

**Contributions**

Each year, participants may elect to defer a percentage of pre-tax annual compensation limited to certain dollar amounts, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes automatic deferral provisions for new hires effective January 1, 2020, and after, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Participants that are automatically enrolled in the Plan will be deemed to have elected a salary deferral contribution of 3% of eligible compensation and their contributions invested in a designated balance fund until changed by the participant. Previously, the automatic enrollment escalation increased by 1% each subsequent year to a maximum of 6%. The Plan was amended January 1, 2024 to remove the automatic escalation feature. The Company's contributions consist of a safe harbor amount equal to 3% of compensation. Additional discretionary contributions may be contributed at the option of the Company’s Board of Directors. There were no additional discretionary contributions made during 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, Company's safe harbor contributions, discretionary contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their contributions, the Company's 3% safe harbor contribution, plus actual earnings thereon. Vesting in the Company's discretionary contributions is based on years of continuous service with full vesting after six years of credited service or the earlier of attaining normal retirement age, early retirement age, death, or disability.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% over the prime rate, as defined. Principal and interest are paid ratably through bi-weekly payroll deductions.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, annuity, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution. Inservice distributions are also permitted for participants that have attained age 59 ½.

**Forfeiture**

A forfeiture results from the non-vested portion of the employer discretionary account of a terminating participant. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$7,429 and \$6,893, respectively. These accounts may be used to offset the Company's safe harbor contributions or offset Plan expenses; however, no forfeitures were used during 2024.

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisor. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses in investments bought and sold as well as held during the year.

**Investment Concentrations**

**Contributions**

Contributions from Plan participants and the safe harbor contributions from the Company are recorded in the year in which the participant contributions are withheld from compensation.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan agreement.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 10, 2025 the date the financial statements were available to be issued.

The Plan was amended effective April 1, 2025 to eliminate the automatic enrollment feature. In addition, effective July 2025, the Plan permits Roth contributions.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

---

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices to active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. **NOTE 4 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

---

Certain plan investments as of December 31, 2024 and 2023 are shares of mutual funds and a common collective trust of JP Morgan Asset Management, the Plan's recordkeeper. The Plan also pays fees to the trustee and investment advisor thereby qualifying as parties-in-interest.

**NOTE 5 - PLAN TERMINATION**

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer discretionary contributions.

**NOTE 6 - TAX STATUS**

---

The Company has adopted a non-standardized pre-approved profit-sharing plan with CODA sponsored by Great West Trust Company, LLC. The non-standardized pre-approved profit-sharing plan received an opinion letter on November 14, 2022, that the non-standardized pre-approved profit-sharing plan was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believe the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 - CERTIFIED INVESTMENTS**

---

Certain information in the accompanying financial statements and ERISA-required supplemental schedules, related to investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (the trustee of the Plan).

**NOTE 8 - RISKS AND UNCERTAINTIES**

---

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and amounts reported in the statements of net assets available for benefits.

**NOTE 9 - OTHER EMPLOYER CONTRIBUTIONS RECEIVABLE**

---

During the years ended December 31, 2024, 2023 and 2022, the Plan had multiple operational errors including failure to pay certain participant contributions based on the plan document auto-escalation feature with an increased deferral percentage up to a maximum of 6% and employer match computation errors. Due to these operational errors, the Plan is in the process of taking the necessary corrective actions and is calculating the missed earnings on the contribution amounts. An other employer contribution receivable in the amounts of \$14,942 and \$8,341 were recorded at December 31, 2024 and 2023, respectively, and are reflected on the statements of net assets available for benefits. Operational errors of \$6,601 are included in the statement of changes in net assets available for benefits as of December 31, 2024.

**NOTE 10 - PROHIBITED TRANSACTIONS**

---

Delinquent contributions from prior years are still in the process of being corrected at December 31, 2024 and 2023 in the amount of \$14,975. Delays in remitting payments to the record keeper were due to administrative errors. Lost earnings on the delinquent contributions were deemed to be not material.
