As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, as described in Note 2 of the financial statements; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. 1. Description of the Plan

The following description of HF Rubber Machinery 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all nonunion and nonresident alien employees of HF Rubber Machinery, Inc. (the Company) who have completed one month of service and are age 18 or older, excluding temporary employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator is responsible for oversight of the Plan.

Contributions

Participants may elect to have the Company contribute (pre-tax or Roth) up to 60% of their eligible compensation as defined in the Plan. Effective January 1, 2023, the Plan was amended to implement an automatic deferral procedure for new participants at 6% of the participant's eligible compensation each payroll period and contribute that to the Plan unless the participant elects otherwise. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Contributions are subject to certain IRS limitations.

In 2024 and 2023, the Company elected to make safe harbor matching contributions equal to 100% of the first 6% of a participant's eligible compensation. The Plan document specifies that the safe harbor matching contributions are to be based on each plan year; however, the Company calculates the match based on each payroll period. As a result, there is generally a true-up match contribution that is required to be made each year. During 2024, the Company made a true-up match contribution for the 2023 plan year in the amount of \$7,439, which is included in employer contributions. During 2023, the Company made a true-up match contribution for the 2022 plan year in the amount of \$4,992, which is included in employer contributions.

The Plan also allows for a discretionary employer contribution each year. To be eligible for the discretionary employer's contribution, the participant must be an eligible employee, performed at least 1,000 hours of service during the Plan year, and be employed by the Company on the last day of the contribution period. The Company did not make a discretionary contribution during 2024 or 2023.

Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a stable value fund as investment options for the participants.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, an allocation of the Company's discretionary contributions and plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. **Description of the Plan** (continued)

Vesting

Participants are immediately vested in their contributions and Company matching contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after four years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The current loan interest rate is set at 2% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

The Plan provides for payment of benefits upon death, disability, retirement, or termination of employment. The participant may also elect to receive a distribution upon reaching age 59½. The Plan allows for benefits to be paid by a lump sum distribution, installment payments, and partial withdrawals. A separated participant with a vested balance exceeding \$5,000 may elect to defer receipt of their distribution until a later date. The Plan automatically distributes accounts less than \$5,000 upon participant separation.

Forfeited Accounts

Forfeitures are retained in the Plan and are first used to pay administrative expenses. Any remaining amounts are used to reduce future Company contributions payable under the Plan. There were forfeited account balances at December 31, 2024 and 2023 of \$120 and \$74, respectively.

2. **Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the modified cash basis of accounting. The modified cash basis is used for the Plan's financial reporting under ERISA. The modified cash basis of accounting adopted by the Plan differs from the accrual basis in that revenues, except for unrealized gains and losses on investments, are recognized when received rather than when earned, and expenses are recognized when paid rather than when the obligation is incurred. Gains and losses on investments are recognized as revenue or expense whenever fluctuations in the market value occur.

Use of Estimates

The preparation of financial statements in accordance with the modified cash basis of accounting requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. **Summary of Significant Accounting Policies** (continued)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded when received. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded when received. Related fees are recorded as administrative expenses and are expensed when they are paid. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

3. **Information Prepared and Certified by the Plan's Trustee**

Certain information related to the investments disclosed in the accompanying financial statements was obtained or derived from information supplied by the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include: quoted prices for similar assets in active markets; quoted prices for identical or similar assets in inactive markets; inputs other than quoted prices that are observable for the asset; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- *Money market and mutual funds* – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Common stocks* – Valued at the closing price reported on the active market on which the individual securities are traded.
- *Stable value collective trust fund* – A stable value fund that is comprised primarily of fully benefit-responsive investment contracts that are valued at the net asset value of units as provided by Fidelity Investment Trust Company. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the Plan is required to provide a redemption notice in order to ensure that securities liquidations will be carried out in an orderly business manner.

4. Fair Value Measurements (continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

Plan management evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of Levels 1, 2 or 3.

5. Related Party Transactions and Party-in-Interest Transactions

Certain plan investments are shares of mutual funds managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation/depreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

Additionally, notes receivable from participants are also considered party-in-interest transactions.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Participants are 100% vested in employee and employer matching contributions at all times. In the event of plan termination, participants would become 100% vested in any Company discretionary contributions.

7. Tax Status

The Company adopted a Pre-Approved Defined Contribution Plan (formerly known as Volume Submitter Profit Sharing Plan with CODA), which received a favorable opinion letter from the IRS on June 30, 2020. The letter states that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has since been amended. However, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan sponsor is part of a controlled group of companies. Minimum coverage discrimination testing was not performed for 2024 because the Plan sponsor did not have complete information with respect to leased employee counts included in the controlled group. The failure to perform this testing could be treated by the IRS as a qualification failure. Management plans to take the appropriate steps to correct this issue and accordingly believes that the Plan will retain its tax-qualified status.

Accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market fluctuation, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and statement of changes in net assets available for benefits.

9. Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, the date that the financial statements were available to be issued.
