**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Farella Braun + Martel LLP Profit Sharing and 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document, as amended, for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan originally established January 1, 1974. The Plan was last restated effective January 1, 2022, and the most recent amendment was executed on December 23, 2024 with an effective date of January 1, 2025. The Plan covers substantially all employees of Farella Braun + Martel LLP (the Company) except associate attorneys, employees covered under an employment arrangement that specifically excludes them from participation in the Plan, leased and nonregular employees, and employees who are nonresident aliens, treated as independent contractors, covered under a collective-bargaining agreement, or partners whose status is considered by the Employer to be "Of Counsel II". Employees are eligible to participate immediately upon hire. The Company is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the Plan Sponsor, as defined by ERISA. The trustee is the fiduciary responsible for the general operation and administration of the Plan as well as the management and control of Plan assets.

**Contributions**

The Plan includes a cash or deferred arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) or Roth contributions. The Plan allows catch-up contributions for those participants age 50 or older.

The Company may make profit sharing contributions to the Plan on a discretionary basis. The contributions to the Plan are allocated among designated groups of participants based on each participant's annual compensation compared to the total annual compensation of all participants in that group. The Plan accrued \$3,889,721 and \$3,830,069 of profit sharing contributions for the years ended December 31, 2024 and 2023, respectively, and remitted \$3,830,069 of prior year's profit sharing contribution during the year ended December 31, 2024.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, allocations of the Employer's contributions, and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their deferral and rollover contributions plus actual earnings thereon. Vesting in the Company profit sharing contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant is 100% vested after three years of credited service. A year of credited service is defined as a calendar year in which the employee completes at least 1,000 hours of service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance less the largest outstanding balance in the last 12 months. The notes are secured by the balance in the participant's account and bear interest at a rate of the prime rate plus 1%. Principal and interest is paid ratably through payroll deductions or payment coupons.

**Payment of Benefits**

A participant who terminates his or her employment before retirement will be entitled to receive the vested balance in his or her account on any distribution date following the participant's separation from service with the Company. If the termination is due to death of participant, the Plan will distribute the balance of the participant's account to his or her beneficiaries. If the termination is due to disability, the Plan will distribute in a lump-sum amount, the vested balance to the participant on the distribution date following the participant's separation from service with the employer.

The mandatory distribution (including rollovers) at severance from employment is \$1,000 or less. If a terminated participant's vested account is greater than \$5,000, he or she may leave his or her amount in the Plan until the participant elects to commence distribution as of any distribution date, following the participant's termination from employment. If the terminated participant's vested account is equal to or less than \$1,000, the Company may elect to distribute the participant's amount without his or her consent. If the terminated participant's vested account is more than \$1,000 and less than \$5,000, the Company may automatically rollover the amount into an individual retirement account.

A participant may withdraw all or any portion of his or her rollover account at any time. After reaching age 59½, a participant may withdraw all or any portion of his or her pre-tax salary deferral and Roth accounts. After reaching age 59½, (age 62 prior to January 1, 2020), a participant may withdraw all or a portion of his or her Pension Transfer Account. After reaching age 59½ and completing three years of service, a participant may withdraw all or a portion of the vested amounts in his or her profit-sharing account.

**Forfeited Accounts**

If participants terminate employment before completing three years of service, their nonvested profit sharing accounts will be forfeited and, in the sole discretion of the Company, either used to pay reasonable plan expenses or to reduce employer contributions or allocated among remaining participants. At December 31, 2024 and 2023, the forfeited nonvested accounts amounted to \$35,653 and \$1,495, respectively. Forfeitures in the amount of \$1,495 were used to offset the 2023 Company's employer contributions during the year ended December 31, 2024.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Benefit Payments**

Benefits are recorded when paid.

**Contributions**

Employee contributions from participants are recorded in the year in which the employee compensation is paid and the deferrals are withheld. Employer profit sharing contributions are recorded in the year in which the related employee compensation is paid.

**Administrative Expenses**

Certain asset management fees are paid from the Plan. The Company may pay reasonable administrative expenses of the Plan relating to third-party administration; to the extent such fees are for the ordinary and necessary administration and operation of the Plan. Reasonable expenses will be paid from the Plan if the Company, for any reason, fails to pay such expenses. Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. The Plan pays for investment counsel and management fees which are accrued as incurred. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, Vanguard Fiduciary Trust Company, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants presented on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included with Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-Directed Brokerage Accounts* – Valued at the closing price reported on the active market on which the individual securities are traded.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their Company contributions.

**NOTE 7 PLAN TAX STATUS**

The Plan is placing reliance on the determination letter dated September 21, 2022, received from the IRS indicating that the Plan is qualified under section 401 of the IRC and is, therefore, not subject to tax under current income tax law. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

Certain investment fund options, and certain investment funds purchased through participant directed brokerage accounts, are managed by The Vanguard Group, Inc., the parent company of Vanguard Fiduciary Trust Company (VFTC). VFTC is the trustee and asset custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management and advisory services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing. During 2024, the Plan made direct payments to the trustee of \$28,442, which relates to brokerage account and loan service fees not covered by revenue sharing. The Company provides to the Plan certain accounting and administrative services for which no fees are charged.

**NOTE 9   TRANSFERS FROM AFFILIATED PLAN**

Certain events could occur which may require transfer of funds to and from another retirement plan of the Company. During the year ended December 31, 2024, \$188,523 was transferred from the Farella Braun and Martel LLP Associates' 401(k) Plan into the Plan and is reflected in the statement of changes in net assets available for benefits as Transfer from Affiliated Plan.
