## INDEPENDENT AUDITOR'S REPORT

To the Board of Directors

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of SouthEast Alaska Regional Health Consortium (SEARHC) 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on August 10, 2020 as a defined contribution plan covering all employees of SouthEast Alaska Regional Health Consortium (SEARHC, or Plan Sponsor). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants aged 19 and older may contribute up to the legal limit of pretax annual compensation as defined in the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. SEARHC contributes 100% of the first 5% of eligible compensation that a participant contributes to the Plan. Eligible participants, as defined by the Plan, are eligible to receive employer contributions starting on their date of hire. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and SEARHC matching contributions and Plan earnings. Allocations are based on SEARHC's contribution for each participant and their account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Distributions from the Plan are made when a participant retires, dies (in which case, payment shall be made to his or her beneficiary, or if none, his or her legal representatives), incurs a disability, or otherwise terminates employment with SEARHC. Hardship withdrawals are permitted under certain circumstances.

NOTES TO FINANCIAL STATEMENTS

Vesting

Participants are immediately vested in their contributions and employer non-elective contributions, plus actual earnings thereon. Participants hired before October 1, 2024 will have no vesting of employer matching contributions and earnings thereon until they have had 2 years of service at which point, they will be 50% vested in the employer matching contributions and earnings thereon, and will become fully vested in employer matching contributions and earnings thereon after 3 years of service. See amended vesting schedule below for participants hired on or after October 2024. An employee's service under the Plan also includes all service the employee earned with companies designated in the Plan.

Payment of Benefits

Upon hardship, or termination of service due to death, disability or retirement, a participant may elect to receive benefits by various methods. Participants should consult the Plan agreement for detailed information concerning distribution options.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested accrued benefit. Participants may have one outstanding note receivable at a time. The loan is secured by the balance in the participant's account and bears interest at rates ranging from 5.25% to 10.5%. The loan term may generally not be longer than five years. Principal and interest is paid ratably through payroll deductions.

Forfeitures

SEARHC may decide in its discretion how to treat forfeitures under the Plan. Forfeited nonvested accounts totaled \$305 and \$117 for the years ended December 31, 2024 and 2023, respectively.

Plan Termination

Although it has not expressed intent to do so, SEARHC has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all Plan benefits previously earned by the participants and any unused discretionary employer contributions would be non-forfeitable.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

### NOTES TO FINANCIAL STATEMENTS

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Management considers the notes receivable to be fully collectible at year-end. Accordingly, no allowance for credit losses has been recorded.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees are related to certain administration items, including notes receivable from participants, are charged directly to the participant's account, and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### Payments of Benefits

Benefits are recorded when paid or are accrued at year-end if approved but not disbursed.

#### Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect the amounts in the financial statements and the accompanying notes. Accordingly, actual results may vary from these estimates.

#### Date of Subsequent Review

Management has evaluated subsequent events through the date of the Independent Auditor's Report, which is the date the financial statements were available to be issued.

### **NOTE 3 – FAIR VALUE MEASUREMENT**

FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosure*, defines fair value as the exchange price that would be received on the measurement date to sell an asset, or the price paid to transfer a liability in the principal or most advantageous market available to the entity in an orderly transaction between market participants. FASB ASC 820 also establishes a three-level fair value hierarchy that describes the inputs that are used to measure assets and liabilities. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are generally open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money Market:* Valued at accumulated cash contributions plus accrued interest.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 – TAX STATUS**

The IRS has determined and informed SEARHC by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 – CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company (the custodian of the Plan).

**NOTE 6 – TRANSACTIONS WITH RELATED PARTIES OR PARTIES-IN-INTEREST**

Certain Plan investments are managed by Vanguard Fiduciary Trust Company (Vanguard). Vanguard is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services amounted to \$194,744 for the year ended December 31, 2024.

**NOTE 7 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 – SECURE 2.0**

On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as "SECURE 2.0". These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system and finding ways for them to accumulate more assets. These changes have various effective dates starting in 2023 and forward. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.
