## **Independent Auditor's Report**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Apex Piping Systems, Inc. 401(k) Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### Note 1 - Description of the Plan

The following description of the Apex Piping Systems, Inc. 401(k) Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan was adopted on January 1, 1996. The Plan is a defined-contribution plan under Section 401(k) of the Internal Revenue Code covering all employees of Apex Piping Systems, Inc. and Apex Nuclear Equipment, LLC (the Companies) who have reached the age of twenty-one and have completed one year of service. Apex Piping Systems, Inc. amended its incorporation in May 2020 to change its name to Apex Mechanical & Fabrication, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Each year, participants may contribute a percentage of their annual earnings as a pre-tax contribution, subject to the limitations under applicable provisions of the Internal Revenue Code. Also, participants may designate all or a portion of their deferral contributions as an after-tax contribution into a Roth 401(k) account. Employees will automatically contribute 3% of eligible compensation into the Plan upon meeting the eligibility requirements, unless the employees elect not to contribute to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). The Companies may make discretionary matching contributions based upon a percentage of participant deferrals and their compensation. The Companies may also make discretionary profit sharing contributions and qualified non-elective contributions. For the year ended December 31, 2024, the employer matching contribution totaled \$80,221 and there was no discretionary profit sharing contribution.

Participants direct the investment of all contributions into various investment options offered by the Plan. Participants may change their investment options at any time throughout the year.

### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Companies' contributions and Plan earnings, benefit payments, and charged with an allocation of administrative expenses. Allocations are based on participant earnings and contributions or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately vested in their salary deferral contributions, rollover contributions and qualified non-elective contributions plus actual earnings thereon. Vesting in the Companies' discretionary matching and discretionary profit sharing contributions is graded based on the following schedule:

<u>Years of Service</u>	<u>Percentage Vested</u>
Less than 1	0%
1 but less than 2	20%
2 but less than 3	40%
3 but less than 4	60%
4 but less than 5	80%
5 or more	100%

### Notes Receivable from Participants

Loans from the Plan may be made to participants. The minimum loan amount available is \$1,000. A maximum of one loan may be outstanding at any one time for any eligible participant, with a maximum loan amount available of the lesser of 50% of the participant's vested account or \$50,000. Within each eligible participant's account, a loan sub-account is maintained in order to track principal and interest amounts owed by the participant. The loans bear interest at a reasonable rate determined by the Plan Administrator which is the Prime Rate plus 2%. Interest rates range from 5.50% to 10.50% at December 31, 2024. Interest rates range from 5.25% to 10.25% at December 31, 2023. Principal and interest are paid ratably through weekly payroll deductions and generally, loans must be repaid within five years.

### Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant becomes 100% vested in all of his or her accounts. For reasons other than death, disability, or normal retirement, a participant will be entitled to receive only the vested portion of his or her account.

Participants may receive distributions while employed. In addition, if a participant suffers a financial hardship, they may request a hardship distribution from their 401(k) account. The amount disbursed cannot exceed their contributions to date (excluding investment income) or the amount actually needed, whichever is less. In addition, participants may receive a distribution after they reach the age of 59 ½ from their vested portion of all their accounts. Rollover contributions can be distributed at any time.

A participant or beneficiary may elect to receive a distribution from the Plan in the form of a single lump sum, partial payments, or request that the payment be directly transferred to an individual retirement account. If a terminated participant's vested account balance exceeds \$5,000, he or she may leave the balance in the Plan and continue participating in the Plan's investments based on the provisions of the Plan. If the value of a terminated participant's vested interest in their account is between \$5,000 and more than \$1,000, the Plan Administrator will notify them of the cash out rules and give them the opportunity to elect whether to (1) receive payment or (2) have the payment rolled over directly to an IRA or other eligible plan that they select. If they do not make an election within the period prescribed by the Plan Administrator and the distribution of their account is to be made before their normal retirement date, their vested interest in their account will be rolled over directly to an IRA maintained by a provider selected by the Plan Administrator (an automatic rollover IRA).

If the value of a terminated participant's vested interest in their account is \$1,000 or less, and they do not make an election, payment will be made directly to them.

### Forfeited Accounts

As of December 31, 2024 and 2023, amounts available from forfeiture of non-vested accounts are \$9,373 and \$14,729, respectively. Any portion of a terminated participant's account balance that is not vested at the date of termination will be used to offset future Plan expenses. Plan expenses at December 31, 2024 have been reduced by \$6,283 from forfeited non-vested accounts.

### Note 2 - Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Administrative Expenses

Administrative expenses of the Plan are paid directly by the employer, as provided by the Plan document. Advisor expenses of the Plan are paid directly from participant's accounts, as provided by the Plan document. Certain administrative functions are performed by the employees of the Companies. No such employees receive compensation from the Plan.

#### Payment of Benefits

Benefits are recorded when paid.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to

Note 4 - Fair Value Measurements

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the framework are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common Collective Trust Fund: Valued based on the net asset value (NAV) of shares of the underlying fund, the fund's dividends and the trust fund's account charges. Fair value approximates contract value. The investment is measured at NAV as a practical expedient for fair value.

Mutual Funds and Exchange Traded Funds: Valued at quoted prices as reported on the active market in which the investments are traded.

### Note 5 - Risk and Uncertainties

The Plan provides for investment options in various combinations of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to levels of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

### Note 6 - Income Tax Status

The Plan adopted a prototype plan sponsored by Ascensus. The prototype plan has received a favorable opinion letter dated June 30, 2020 from the Internal Revenue Service as to the prototype plan's qualified status. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

### Note 8 - Party-In-Interest

Certain Plan investments managed by Ascensus Trust Company hold the Plan's assets, invests interest and dividend income and cash received and initiates distributions to participants. Ascensus Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions, which are exempt from prohibited transactions rules.

Note 9 - Partial Plan Termination

In 2022, Apex Mechanical & Fabrication, Inc. downsized its operations which resulted in a partial plan termination as defined under ERISA. As a result, all affected participants became 100% vested in their accounts during the year ended December 31, 2022. This event affected 30 participants, 7 of whom were not fully vested prior to the partial plan termination. During the years ended December 31, 2024 and 2023, distributions to the affected participants who were not fully vested prior to the partial plan termination totaled \$814 and \$12,715, respectively. During the years ended December 31, 2024 and 2023, forfeitures initially associated with these distributions totaled \$0 and \$1,695, respectively. As of October 9, 2025, approximately \$4,049 remains in the Plan for the affected participants who were not fully vested prior to the partial plan termination.

Note 10 - Subsequent Events

The Plan Administrator has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.
