Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Security Police Fire Professionals of America Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by qualified institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of the Plan

The following description of the Security Police Fire Professionals of America Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a multiemployer defined contribution plan. Eligibility requirements are defined by collective-bargaining agreements between participating employers and the International Union, Security Police Fire Professionals of America (SPFPA or the Union) representing covered employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Custodian and Administration of the Plan

The Plan is administered by a Board of Trustees (the Board) composed of an equal number of Union and employer trustees. Principal Trust Company (Principal) serves as recordkeeper and custodian of the Plan. The Board engages an investment advisor, Western International Securities, Inc. (WIS), to help determine the appropriateness of the Plan's investment offerings and monitor investment performance. The Plan and the related Security Police Fire Professionals of America and Participating Employers Health and Welfare Plan (H&W Plan) engage Lawrence C. Musgrove Associates, Inc. to serve as Third-Party Administrator (TPA).

Contributions

Required participating employer contributions are based on collective-bargaining agreements in effect between the participating employers and the Union. The Plan also allows for elective deferrals, employer matching contributions, employer non-elective contributions, and employer discretionary contributions, as defined in the Plan document. Participants are also permitted to make rollover contributions of amounts received from other tax-qualified, employer-sponsored retirement plans, but only for those employees eligible to participate in the Plan.

Contributions are collected by the H&W Plan and are then remitted to the Plan by the TPA. Employer contributions include required participating employer contributions, employer matching contributions, and 401(k) excess contributions. 401(k) excess contributions are amounts based on health and welfare earnings, credited to those participants enrolling as employee-only coverage in the H&W Plan, in excess of the cost of benefits elected by the H&W Plan participants, if provided within the applicable collective-bargaining agreement. 401(k) excess contributions are not considered to be employee-elective deferrals.

Participant Accounts

Each participant's account is credited with the participant's contributions; the participating employers' required contributions; the employers' discretionary contributions, if any; and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts. The Plan accounts are 100% participant directed.

Participant Loans

Participant loans are not permitted under the Plan.

Vesting

Participants are immediately 100% vested in all contributions made to the Plan.

Investment Options

Contributions to the Plan are allocated among investment options with Principal. In the absence of an investment election by the participant, contributions credited to the participant's account are defaulted to a target date fund based on the participant's age.

Payments of Benefits

A participant's entire interest in the Plan is payable upon death, attainment of normal retirement age, becoming disabled (as defined), or termination of service. A participant may elect to receive a lump-sum amount, receive installment payments as described in the Plan document, leave the account in the Plan, or roll over the vested balance to another qualified retirement plan or Individual Retirement Account (IRA).

Forfeited Accounts

Forfeitures, at the election of the Board, may be used to pay administrative expenses incurred by Plan. The amount of forfeiture not used to pay administrative expenses will be allocated according to the Plan provisions. For the year ended December 31, 2024, no forfeitures were used to fund employer contributions. As of December 31, 2024 and 2023, there was a forfeiture balance of \$0 and \$13,870, respectively.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on an accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board determines the Plan's valuation policies utilizing information

provided by the investment advisor and custodian. See Note 4 for a discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Dividend and interest income is recorded as earned. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions Receivable

Participant contributions and any related employer contributions are recognized in the period during which the participating employer makes the respective payroll deduction from the participant's compensation.

Payment of Benefits

Benefits are recorded when paid.

Expenses

All administrative operating expenses of maintaining the Plan are the responsibility of the Plan. Investment-related expenses are included in net appreciation in fair value of investments.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, related to investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal, a qualified institution.

4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.

- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Mutual funds are valued at the daily closing price, as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trust (CIT) - The CIT is valued at the NAV of units of a collective investment trust. The NAV, as provided by the trustee of the CIT, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investment's trust less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. There are no unfunded commitments for these investments, and they may be redeemed daily. There is a 12-month notice period and there are no participant redemption restrictions; the redemption notice period is applicable only to the Plan.

5. Due to SPFPA Health and Welfare Plan

As discussed in Note 1, the Plan receives contributions from the H&W Plan, which is administered by the TPA.

During 2023, the Plan and the H&W Plan employed a Plan director whose salary and benefits are initially paid by the H&W Plan. The Plan's portion of the expense for the year ended December 31, 2023 was \$71,907, which is the total amount due to the H&W Plan as of December 31, 2024 and 2023. This amount was paid to the H&W Plan during 2025.

Fees and expenses relating to the administration of the Plan are generally the responsibility of the Plan.

7. Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by Principal or its subsidiaries and affiliates. Participant distribution processing fees are paid to Principal by participants. The Plan paid for TPA fees, investment advisory, legal, Plan audit fees, and trustee travel and education, which qualify as party-in-interest transactions. Certain management fees in the form of an expense ratio charged to each investment option are paid by the Plan and deducted from earnings on

investments. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

8. Tax Status

The Plan has received a determination letter from the Internal Revenue Service (IRS), dated April 12, 2016, stating that the Plan and related trust, as amended, are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan's management believes that the Plan, as amended, is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

On January 13, 2023, the Department of Labor (DOL) commenced a review of the Plan for the period from January 1, 2020 to the date of the DOL's letter. On June 18, 2024, the Plan received a letter from the DOL stating that the review has been concluded and no further action would be taken.

9. Plan Termination

Although it has not expressed any intent to do so, the Board has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. Participants are 100% vested in their balances.

10. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

11. Delinquent Participant Contributions

During the Plan year ended December 31, 2024, participant contributions totaling \$119,268 were not remitted to the Plan by the contributing employer within the period prescribed by DOL regulations. During prior plan years, participant contributions totaling \$464,932 were not remitted to the Plan within the period prescribed by DOL regulations. These transactions constitute prohibited transactions, as defined by ERISA.
