As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1. Plan Description

The following description of Kaufman Dolowich, LLP Retirement Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan was established on July 1, 1986, and was amended and restated on June 23, 2022, is a defined contribution profit sharing plan covering eligible employees of Kaufman Dolowich, LLP (Company). Employees are eligible to participate in the Plan following the date the participant attains age 21 and 83 1/3 hours of service is completed for a one-month period; provided the participant is an eligible employee at the end of that period. As of November 1, 2023, the Plan was amended to include all eligible employees of ClaimsFirst Services LLC. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Contributions

Participants in the Plan may contribute pre-tax deferral contributions up to the maximum amount permitted by the Internal Revenue Service (IRS) each calendar year, which is \$23,000 for the calendar year ended December 31, 2024. Employees over the age of 50 can elect to contribute an additional \$7,500 for the calendar year ended December 31, 2024. Participants may also make rollover contributions from other qualified plans. Effective January 1, 2016, participants may elect to contribute Roth deferrals.

The Company may make discretionary profit-sharing contributions to eligible participants who have completed 1,000 service hours and who are invested in a portfolio of investments as directed by the Company. During the year ended December 31, 2024, the Company contributed \$679,048 of discretionary profit-sharing contributions. During the year ended December 31, 2023 the Company contributed \$586,515 of discretionary profit-sharing contributions.

Notes Receivable from Participants

Participants may borrow amounts greater than \$1,000 from their respective vested accounts up to the lesser of either (i) \$50,000 or (ii) 50% of the vested amount of the participant's account balance. Participants are allowed a maximum of one outstanding loan at one time. Loans are secured by the balance in the participant's account and bear interest at the prevailing prime rate plus 1% on the origination date of the loan (rates ranged from 4.25% to 9.50% per annum at December 31, 2024). Loans shall be repaid over a period of up to five years unless the loan is for the purchase of a primary residence for which the loan can be repaid over a period of thirty years. Loans are repaid through payroll deductions.

Vesting

Participants are immediately vested in their contributions and the actual earnings thereon. Participants vest in the Company's discretionary profit-sharing contributions plus actual earnings thereon based on the following schedule:

Participant Investment Account Options

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Individual participant accounts are credited with applicable participant contributions, an allocation of the Company's contributions, and investment earnings or losses, and are charged with an allocation of administrative expenses. Allocations are based upon participant earnings or account balances, as defined in the Plan Document. The benefit to which a participant is entitled is equal to the vested portion of the participant's account.

Forfeitures

A participant who terminates employment and is less than 100% vested forfeits the non-vested portion of his/her account. Forfeitures attributable to profit sharing contributions are used to reduce employer contributions or pay Plan expenses. There were forfeitures in the amount of \$2,015 during the year ended December 31, 2024. There were forfeitures used in the amount of \$14,464 during the year ended December 31, 2023. The unallocated forfeiture balance at December 31, 2024 and 2023, amounted to \$16,153 and \$28,128, respectively.

Distributions

Distributions from the Plan are permitted under the following circumstances: (i) attainment of age 59½, (ii) termination of employment, (iii) death or permanent disability, (iv) normal retirement age of 65, and (v) a proven hardship. Distributions from a participant's account are made in the form of a lump-sum payment.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements have been prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines its valuation policies utilizing information provided by trustee. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Benefit Payments

Benefit payments are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements while other expenses may be paid from the assets of the Plan. The expenses that are paid from the Plan's assets will either be shared by all participants or will be charged directly to the account of the participant on whose sole behalf the expense is incurred. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events

The Plan has evaluated subsequent events for recognition or disclosure in the financial statements through October 9, 2025, the date the financial statements were available to be issued.

Note 3. Certification of the Plan Trustee

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Capital Bank and Trust Company, a qualified institution, has certified the following investment and notes receivable from participants information included in the accompanying financial statements and ERISA required supplemental schedule is complete and accurate.

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024, and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA- required supplemental schedule.

Note 4. Disclosure about Fair Value Measurements of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value.

- Level 1** Quoted prices in active markets for identical assets or liabilities.

Level 2 Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The plan had no Level 2 or Level 3 investments at December 31, 2024 and 2023.

Note 5. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments were shares of funds managed by Capital Bank and Trust Company, the Trustee of the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the Trustee for administrative services amounted to \$92,050 for the year ended December 31, 2024, and are included in administrative expenses on the statement of changes in net assets available for benefits. The Company provides certain administrative services at no cost to the Plan.

Note 6. Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, The Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more

likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities may occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue and to terminate the Plan subject to the provisions of ERISA.
