### Opinion

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

#### Note 1. Description of the Plan

The following description of the Triad Technologies LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document and plan amendments for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of Triad Technologies, LLC (the Employer or Plan Sponsor). Such employees are eligible to enter the Plan the first day of the quarter following their hire date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions:** Participants may contribute a portion of their compensation subject to limitations stipulated by the Internal Revenue Code. For 2024 and 2023, the Employer provided a fixed matching contribution equal to 50% of the first 5% of annual compensation contributed by the Plan participants. The Plan also allows for additional discretionary profit sharing contributions by the Employer. Contributions are subject to certain limitations. Aggregate contributions may not exceed the maximum amount allowable as a deduction for federal income tax purposes.

**Rollovers:** The Plan accepts rollovers from qualified retirement plans of a prior employer with approval from the Plan Sponsor.

**Participant accounts:** Each participant's account is credited with the participant's contribution, Employer's matching contribution, Employer's discretionary profit sharing contribution, and an allocation of plan earnings. Allocations are based on participant account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their participant contributions, plus earnings thereon. Vesting in the Employer matching contribution, Employer discretionary profit sharing contribution, and non-elective contributions is based on years of service. The participant is 25% vested after one year of service, and an additional 25% vested per year of service thereafter. A participant is fully vested after four years of credited service.

**Payment of benefits:** On termination of service due to retirement, disability, or death, a participant will become fully vested. Distributions are made in a lump sum, in installments not to exceed the participant's assumed life expectancy, ad hoc, or through various annuity options available to the participants.

A participant's beneficiary will receive the participant's account balance in the event of a participant's death. Participants may withdraw their vested interest in the Plan under certain hardship conditions as defined in the Plan agreement. Such financial hardship withdrawals are subject to approval of the Plan Sponsor. Terminated participants will be paid their vested interest in the Plan.

**Notes receivable from participants:** Loans to participants are treated as a separate fund. Interest charged to participants is reviewed by the Plan Sponsor and is based upon prevailing interest rates for similar loans in the surrounding community. Loans may not be granted for less than \$1,000, and a participant can have only one loan currently outstanding from the Plan. Loans may not exceed the lesser of \$50,000 or 50% of a participant's vested account balance, and the repayment period shall not exceed five years (unless proceeds are used to acquire a principal residence). Each loan is collateralized by the remaining balance in the participant's account. Interest rates on participant loans ranged from 4.25% to 9.50% as of December 31, 2024 and 2023.

**Forfeited accounts:** Forfeited, non-vested accounts totaled \$9,550 and \$21,869 at December 31, 2024 and 2023, respectively. These amounts are periodically allocated to participants, used to reduce future Employer matching contributions, or pay plan expenses. Forfeitures of \$15,399 were utilized to reduce Employer matching contributions during 2024.

#### Note 2. Summary of Significant Accounting Policies

**Basis of presentation:** The accompanying financial statements are prepared on the accrual basis in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) in accordance with the Financial Accounting Standards Board Accounting Standards Codification.

**Contributions:** Participant contributions are recognized when earned. Employer matching contributions are recognized concurrently with participant contributions. Employer discretionary profit-sharing contributions are recognized on an annual basis. There were no Employer discretionary profit-sharing contributions in 2024.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document.

**Payment of benefits:** Benefits are recorded when paid.

**Administrative expenses:** The Plan provides that administrative expenses of the Plan are to be paid by the Plan or by the Employer, at the Employer's discretion. Administrative expenses that are paid by the Employer are excluded from these financial statements.

**Use of estimates:** The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the amounts and disclosures reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value (except for the fully-benefit responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan provides for investments in pooled separate accounts and a fixed annuity investment contract as of December 31, 2024.

Because the fixed annuity investment contract is fully-benefit responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to the fixed annuity investment contract. The fixed annuity investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Voya Retirement Insurance and Annuity Company (Plan's trustee), represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Capital gain distributions are included in interest income.

**Subsequent events:** The Plan has evaluated subsequent events for potential recognition and/or disclosure through October 13, 2025, the date the financial statements were available to be issued.

#### Note 3. Information Certified by the Plan's Trustee

The information related to investments that is included throughout the Plan's financial statements and supplemental schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024, was prepared by or derived from information provided by Voya Retirement Insurance and Annuity Company, the Plan's trustee, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Plan's trustee that information provided to the Plan Administrator by the Plan's trustee related to these plan assets is complete and accurate.

#### **Note 3. Information Certified by the Plan's Trustee (Continued)**

Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the investment information in Note 7 and the supplemental schedule related to the Plan's assets.

Voya Retirement Insurance and Annuity Company also certified to the completeness and accuracy of \$2,809,584 of net appreciation in fair value of investments for the year ended December 31, 2024.

#### **Note 4. Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become fully vested in their accounts.

#### **Note 5. Income Tax Status**

The Plan adopted a standardized form of a prototype plan sponsored by CCH Incorporated, DBA ftwilliam.com. The prototype plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020, as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

The Plan Administrator evaluated the Plan's tax positions and concluded that there are no uncertain tax positions that require recognition or disclosure in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by taxing authorities for years before 2021.

#### **Note 6. Investment Contract With Insurance Company**

The Plan has a fixed annuity investment contract with Voya Retirement Insurance and Annuity Company, the Voya Fixed Account, as of December 31, 2024 and 2023. Voya Retirement Insurance and Annuity Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fixed annuity investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Certain events limit the ability of the Plan to transact at contract value with Voya Retirement Insurance and Annuity Company. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable. The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**Note 7. Fair Value Measurements**

The Plan has determined the fair value of certain assets through application of accounting guidance that establishes a framework for measuring fair values. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under this standard are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Pooled separate accounts:** Primarily valued at net asset value (NAV) per share based on quoted market prices of underlying investments. The NAV is used as a practical expedient to estimate fair value. Accordingly, since all investments measured at fair value use NAV, the fair value leveling table is not necessary. The underlying investments of the pooled separate accounts consist of mutual funds.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 8. Related-Party and Parties-in-Interest Transactions**

Certain plan investments are pooled separate accounts and funds held in insurance general funds which are managed by Voya Retirement Insurance and Annuity Company. Since Voya Retirement Insurance and Annuity Company is the current trustee as defined by the Plan, these transactions qualify as parties-in-interest. Fees paid by the Plan for trustee services amounted to \$39,326 for the year ended December 31, 2024.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The guaranteed fixed account has been certified at contract value, which approximates fair value, as reported to the Plan by Voya Retirement Insurance and Annuity Company. In subsequent periods, if market conditions change, such as the insurance company credit rating or interest rate environment, the difference between contract value and fair value could become significant, causing the financial statements to become materially misstated.
