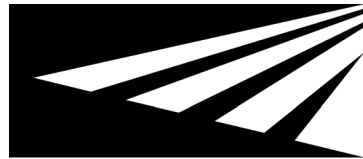

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Knox School 403(b) DC Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS**

(1) Plan Description:

The following description of the Knox School 403(b) DC Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

Background -

Knox School (the “School” or “Plan Administrator”) established the Plan to provide employees with a systematic means of saving and investing for the future. All permissible employees of the School, as defined in accordance with the universal availability standards, are eligible to enroll on their date of hire. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Contributions -

Participants may contribute pre-tax compensation, as defined in the Plan, subject to the Internal Revenue Service (“IRS”) statutory limitations, by means of payroll deductions. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of the contributions into various investment options offered by the Plan.

The School contributes a nondiscretionary contribution to the Plan equal to 2% of the participant’s eligible compensation provided their elective deferral equals or exceeds 2% of compensation. Contributions are subject to certain limitations.

Participant Accounts -

Each participant’s account is credited with the participant’s contributions, the School’s contributions, Plan gains or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant’s account.

Vesting -

Participants are immediately vested in their contributions, the School’s contributions, and actual earnings, thereon.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

Payment of Benefits -

If a participant terminates employment with the School for any reason other than death, the participant can elect to leave the vested account balance in the Plan or roll over the balance into another qualified retirement plan. Upon retirement, the account can be distributed in the form of a lump-sum, installment payments, or an annuity contract. Account balances of \$1,000 or less may only be paid as a lump sum. Participants are required to begin distributions when the age of 72 is attained. In the case of death of a participant, the beneficiary designated by the participant shall be paid the deceased employee's vested account balance immediately or in certain circumstances, paid over the life expectancy of a designated beneficiary. If the designated beneficiary is the participant's spouse, payment of benefits may be deferred until they reach the age 72. Participants who reached the age of 73 during the year ended December 31, 2023 were required to begin distributions during 2024 in accordance with the SECURE 2.0 Act.

Notes Receivable from Participants -

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000, reduced by the highest outstanding loan balance incurred during the one-year period ending on the day before the date of the new loan, or 50% of their vested account balance. A maximum of three loans may be outstanding at one time. Loan terms may not exceed five years, unless it is for the purchase of a principal residence, in which case the loan term may not exceed 10 years. The loans are secured by the participant's account. The effective interest rate assumed is the prime rate plus 1% (9.00% to 9.25% and 4.25% for the years ended December 31, 2024 and 2023, respectively). Principal and interest is paid monthly through debits to the participant's bank account.

Plan Loans -

Plan loans were issued as separate contracts by TIAA-CREF, the Plan servicer ("servicer"), as contemplated under Internal Revenue Code ("IRC") Section 72(p)(5), and do not represent plan assets. As of December 31, 2021, this type of loan is no longer offered. Loans are collateralized using a participant's TIAA Traditional account balance in an amount equal to 110% of the outstanding loan balance. Participants could borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 45% of their TIAA Traditional account balance subject to annuity contract and plan provisions. Loan terms range from one to five years (up to ten years for the purchase of a principal residence). Principal and interest is paid by the participant to the servicer through payroll deductions and each payment will reduce amounts collateralized by the borrowing participant's TIAA Traditional account balance. At December 31, 2024 and 2023, Plan loans amounted to \$17,957 and \$25,866, respectively. Interest rates range from 4.08% to 5.73%.

(2) Summary of Significant Accounting Policies:

Basis of Accounting -

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles.

Use of Accounting Estimates -

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect reported amounts and disclosures. Accordingly, the actual amounts could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

Investment Valuation and Income Recognition -

Investments are reported at fair value. Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date.

Net appreciation includes realized and unrealized gains and losses on the fair value of investments held by the Plan. Purchases and sales of investments are recorded on a trade date basis. Dividends are recorded at the ex-dividend date. Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net investment income.

Notes Receivable from Participants -

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits -

Benefits are recorded when paid.

Plan Expenses -

Certain expenses of maintaining the Plan are paid directly by the School and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

(3) Fair Value Measurements and Investments

U.S. generally accepted accounting standards establish a fair value hierarchy, which require an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the reported entity has the ability to access at the measurement date.
- Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.
- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Non benefit-responsive investment contracts: The Trustee has determined that contract value approximates fair value. Contract value equals the accumulated cash contributions, interest credited to the plan's contracts, and transfers (if any) less any withdrawals.

Pooled separate account: Value is derived from the market value of the underlying holdings. This fund invests in real estate properties or real estate-related investments. The fund is listed on the NASDAQ stock exchange and is valued at the daily closing price.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The investment contracts with the insurance company are not actively traded and significant other observable inputs are not available. Thus, the fair value of the guaranteed investment contract is determined by discounting (at risk-free rate) the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer.

For the years ended December 31, 2024 and 2023, issuances of Level 3 investments were \$9,711 and \$9,509, respectively. For the years ended December 31, 2024 and 2023, transfers into Level 3 investments were \$15,949 and \$112,271, respectively. For the years ended December 31, 2024 and 2023, transfers from Level 3 investments to Level 1 investments were \$27,388 and \$131,987, respectively. Transfers represent fund allocation changes by participants.

(4) Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

(5) Information Prepared and Certified by Trustee

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by the Trustee, TIAA-CREF. All investments are participant directed.

(6) Income Tax Status

U.S. generally accepted accounting principles require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator believes there are no such positions, and therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan is subject to routine audits by tax authorities; however there are currently no audits for tax periods in progress.

(7) Plan Termination

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.

(8) Related Party Transactions and Parties-In-Interest Transactions

The Plan invests in allocated mutual funds and an investment contract with an insurance company sponsored by TIAA-CREF, the Trustee, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. TIAA-CREF also provides investment management and recordkeeping services for the Plan. Fees paid by the Plan for investment management and recordkeeping amounted to \$16,794 for the year ended December 31, 2024.

(9) Subsequent Events

Management of the Plan evaluated subsequent events through October 2, 2025, which is the date these financial statements were available to be issued.
