### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Carr, Allison, Oliver & Sisson, P.C. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**Note A - Description of Plan**

The following description of the Carr, Allison, Oliver & Sisson, P.C. (the Company) 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Carr, Allison, Oliver & Sisson, P.C. who meet the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Consolidated Appropriations Act of 2023 was signed into law on December 29, 2022, which includes the Setting Every Community Up for Retirement Enhancement Act ("SECURE Act") 2.0. SECURE Act 2.0 contains over 90 new provisions related to retirement, with varying effective dates through 2027. As these provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. Accordingly, there was no material impact on the Plan for these financial statements.

Eligibility

The Plan is open to all full-time employees age 21 and over, after one year of service. Once the age and service requirements are met, the employee may enroll on the next January 1 or July 1.

Contributions

Eligible employees may elect to contribute a maximum of 100% of compensation to the Plan, subject to annual deferral limits imposed by the tax code. Participants age 50 and over may make an additional deferral classified as a "catch up contribution". The employer's contribution (which qualifies as a Safe Harbor Non-elective Contribution under the Internal Revenue Code) is 3% of each participant's compensation. The Company may also contribute an additional discretionary profit-sharing amount.

Participant Accounts

The Company remits contributions to the Plan custodian, Fidelity Management Trust Company (Fidelity), who holds the plan assets and executes investment transactions as directed. Fidelity maintains the records of participant data and activity. Participants direct the investment of their account through a choice of mutual funds.

## **Note A - Description of Plan - Continued**

Each participant's account is credited with the participant's contributions, employer contributions, an allocation of the Plan's earnings and a pro-rata charge for administrative expenses. Earnings are allocated daily based on a participant's account balances. The plan document provides for allocation provisions and the disposition of forfeitures.

### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested balance. Loans are secured by the vested balance of the participant's account, bearing interest at rates commensurate with local prevailing rates as determined by the Plan Administrator. The interest rates on loans outstanding at December 31, 2024 and 2023 ranged from 4.25% to 9.5%. Principal and interest are paid ratably through payroll deductions within five years. There may only be two outstanding loans at a time, and no loan may be refinanced.

### Vesting

Vesting is based on years of service, as defined by the Plan. Company discretionary profit-sharing contributions to a participant's account do not fully vest until the completion of six years of service. Participants are immediately vested in their employee deferral contributions and the Safe Harbor Non-elective contributions. Amounts not vested at the time a covered employee ceases to participate in the Plan are forfeited and used to reduce the amount of employer contributions. Forfeitures available to apply to employer contributions as of December 31, 2024, and 2023 were \$74,477 and \$32,577, respectively. Forfeitures of \$74,000 will be applied to 2024 contributions.

### Payment of Benefits

A participant's account becomes fully vested upon the participant's death, disability or attaining normal retirement age. Upon the participant's termination, death, disability or retirement, the vested benefits allocated to the participant's account may be paid in a lump sum or installments.

## **Note B - Summary of Significant Accounting Policies**

### Date of Management's Review

Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued, and there were no events or transactions during that period requiring recognition or disclosure in the financial statements.

### Basis of Accounting

The financial statements of Carr, Allison, Oliver & Sisson, P.C. 401(k) Profit Sharing Plan have been prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America.

## **Note B - Summary of Significant Accounting Policies (continued)**

### Financial Statement Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Administrative Expenses

The Company or the Plan may pay expenses of the Plan. Plan expenses paid directly by the Company are excluded from these financial statements. Investment related expenses are included in net depreciation of fair value of investments.

### Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses is considered necessary as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### Contributions

Employer and employee contributions are reported in the year services are rendered to the company by Plan participants.

### Benefits

Benefits are reported in the year paid.

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting Disclosure under ERISA. Accordingly, Fidelity Management Trust Company has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

- Investments, at fair value
- Notes receivable from participants
- Dividends and interest
- Net appreciation/depreciation in fair value of investments
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### **Note D - Fair Value Measurements**

FASB ASC Section 820 - *Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three broad levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

## Note D-Fair Value-Continued

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds - Valued at the daily closing price which represent the net asset value (NAV) of the shares held reported on the active market on which the individual securities are traded.

Collective trust – Valued using NAV per share practical expedient where the NAV of units held by the Plan are based on the fair value of the underlying investments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(a) Certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits. There are no unfunded commitments for these investments, they are valued daily, and there are no redemption restrictions.

#### **Note E - Related Party and Party-In-Interest Transactions**

Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity is the record-keeper of the Plan, and therefore, these transactions qualify as party-in-interest.

#### **Note F - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

#### **Note G - Plan Tax Status**

The Plan is exempt from federal income taxes under Section 401(a) of the Internal Revenue Code. The Plan uses a volume submitter plan document that was pre-approved by the IRS. The Plan is required to operate in conformity with the Code to maintain its qualification. The Company believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Company has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS audits for any tax periods in progress.
