## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
Rochester Ambulatory Surgery Center 401(k) Retirement Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Rochester Ambulatory Surgery Center 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Rochester Ambulatory Surgery Center 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

**Note 1. Description of Plan** - The following description of the Rochester Ambulatory Surgery Center 401(K) Retirement Savings Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General** - The Plan is a participant-directed, defined contribution plan covering substantially all eligible employees of Rochester Ambulatory Surgery Center ("RASC" or "the Company") and employees of 360 Services Organization, LLC. The original effective date of the Plan is January 1, 1992. As of June 2023 the Plan was amended. The amendment allows for employees from the Westfall Surgery Center to have their years of service count for eligibility, allocation, and vesting purposes. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** - Participants may make pre-tax and post-tax contributions from their annual compensation, up to amounts permissible under ERISA and the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Eligible participants may defer up to 100% of their annual compensation, as defined in the Plan, as a qualified contribution subject to maximum annual dollar contribution restrictions of ERISA and the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company offers a discretionary Employer matching contribution to eligible employees, as described above. For the years ended December 31, 2024 and 2023 the Company matched 50% of an employee's contribution up to 8%. The Employer matching contribution is outlined in the employee handbook and any change to the matching contribution would need to be approved by the governing board.

**Participant Accounts** - Each participant's account is credited with the participant's contribution and allocations of the Plan earnings (losses), as well as, the RASC's matching contribution. Participant accounts are charged with an allocation of administrative expenses that are paid by the plan. Allocations are based on participant account balances or evenly distributed among all participants, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting for employer contributions is based on years of service with participants becoming fully vested after five years of vesting service. Additional vesting breakdowns can be found in the plan document.

**Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest commensurate with similar types of loans by other lenders. Principal and interest is paid ratably through payroll deductions. Outstanding loans on December 31, 2024 and 2023 totaled \$17,419 and \$16,739, respectively.

**Payment of Benefits** - On termination of service due to death, disability, or retirement a participant with a vested account balance that exceeds \$5,000 may elect to receive a lump-sum amount or partial withdrawals. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Vested amounts less than \$5,000 are distributed in a single lump-sum payment.

**Forfeited Accounts** - Forfeited non-vested accounts totaled \$7,779 and \$5,208 at December 31, 2024 and 2023, respectively. These accounts will be used to reduce future employer contributions or plan expenses. In 2024 and 2023, employer contributions were reduced by \$6,280 and \$5,518 respectively, from forfeited non-vested accounts. During the year ended December 31, 2024, forfeitures were used to offset employer contributions or administrative expenses.

**Note 2. Summary of Significant Accounting Policies**

**Method of Accounting** - The financial statements of the Plan are prepared using the accrual method of accounting.

**Use of Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payments of Benefits** - Benefits are recorded when paid.

**Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events** - Management has evaluated subsequent events through the date of the report which is the date these financial statements were available to be issued.

**Note 3. Certified Investments**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information-certified as complete and accurate by Nationwide Trust Company (the trustees of the Plan), a qualified institution.

**Note 4. Party-in-Interest Transactions**

During 2023, Plan investments were managed by Transamerica Retirement Solutions ("Transamerica") and Nationwide Retirement Solutions ("Nationwide"). The Plan's trustees were Transamerica for the period January 1, 2023 to June 9, 2023, and Nationwide for the period June 10, 2023 to December 31, 2023; therefore, these transactions qualify as allowable party-in-interest transactions. Fees paid by the Plan for investment and administrative services amounted to \$10,003 for the year ended December 31, 2023.

During 2024, Plan investments were managed by Nationwide Retirement Solutions (“Nationwide”). Nationwide had entered a strategic partnership with SS&C Technologies, Inc. in 2020 which resulted in rebranding and a name change in 2024. Nationwide became SS&C GIDS, Inc’s Retirement Services (“SS&C”). Fees paid by the Plan for investment and administrative services amounted to \$28,671 for the year ended December 31, 2024.

**Note 5. Fair Value Measurements**

ASC 820-10, *Fair Value Measurements*, establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The standard describes three levels of inputs that may be used to measure fair value:

**Level 1:** Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

**Level 2:** Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

**Level 3:** Significant unobservable inputs that reflect a reporting entity’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The following is a description of the valuation methodologies used for investments measured at fair value:

**Interest Bearing Cash** - Valued at the closing price reported on the active market on which the individual money market funds are traded (Level 1).

**Mutual Funds** - Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1).

**Fixed Select Contract** - Valued at the net asset value (NAV) of units of the general account. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

**Note 8. Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since applying for the advisory opinion letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Company has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions and the Department of Labor; however, there are currently no audits for any tax periods in progress.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Certain employee and employer contributions were not remitted to the Plan within the time frame specified by the Department of Labor's Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and the Company for the years ended December 31, 2024 and 2023. As of the date of this report management is calculating the exact amount of these contributions.
