### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Worcester Polytechnic Institute Defined Contribution Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits (modified cash basis) as of December 31, 2024, and the related statement of changes in net assets available for benefits (modified cash basis) for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by banks or similar institutions or insurance carriers that are regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the banks or similar institutions or insurance carriers in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Management has obtained certifications from qualified institutions as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section:

- The amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2 to the financial statements.
- The information in the 2024 financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion on the 2024 Financial Statements**

We conducted our audit in accordance with U.S. generally accepted auditing standards (U.S. GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Basis of Accounting**

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The 2024 financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than U.S. generally accepted accounting principles. Our opinion is not modified with respect to that matter.

### **Responsibilities of Management for the 2024 Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting. This includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with U.S. GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

### 1. Description of Plan

The following description of Worcester Polytechnic Institute Defined Contribution Plan (the Plan) provides only general information. Participants should refer to the Plan provisions for more information.

#### General

The Plan is a tax-exempt, defined contribution retirement plan sponsored by Worcester Polytechnic Institute (the University). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). TIAA and CREF and Fidelity Management Trust Company (Fidelity) (collectively, the custodians) are the recordkeepers and custodians of the Plan.

#### Eligibility

The Plan is available to all employees of the University who are age 18 or older and have completed one year of service at the University or another institute of higher education. Participation is mandatory for faculty and exempt employees and voluntary for non-exempt employees. The employer matching contribution is available to eligible participants who meet the one year of service requirement and are age 21 or older.

#### Vesting

Participants are fully vested in their account balances.

#### Contributions

Participants are required to contribute 5% of their pretax annual compensation, as defined in the Plan. The University contributes a match equal to a percentage of eligible compensation. The employer matching percentage was equal to 9.5% effective for the plan year ended December 31, 2024.

Each year, eligible employees may make contributions to the Plan through salary deferrals on a pre-tax basis up to 100% of eligible compensation, as defined in the Plan. The maximum amount that a participant may contribute is limited by provisions of the Internal Revenue Code (the Code).

#### Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's and employer's contributions and an allocation of investment income. A participant's account shall be reduced by any distributions, investment losses, and certain administrative expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

### **Notes Receivable from Participants**

Participants may borrow up to the lesser of 50% of their participant account balance or \$50,000, subject to certain limitations as set forth in the Plan document.

### **Plan Loans**

Participants may borrow up to the lesser of 50% of their individual account balance or \$50,000. Plan loans taken by TIAA and CREF participants are issued directly from the funds owned by TIAA and CREF instead of being removed from the participant's account balance. These loans are collateralized by 110% of the participant's account, which is required to be maintained in the TIAA Traditional Annuity investment. As the loans are paid off, participants may reinvest their funds as they choose. Investments underlying defaulted loan balances are reflected in the statements of net assets available for benefits until a distribution event occurs, at which time TIAA and CREF will draw the funds from the participant's account to cover the remaining loan balance.

Participants had outstanding Plan loan balances due to TIAA and CREF amounting to \$8,468 and \$12,318 as of December 31, 2024 and 2023, respectively. As of December 31, 2024 and 2023, \$9,315 and \$13,550, respectively, of the TIAA Traditional Annuity investment serves as collateral for the Plan loans. There were no Plan loans in default as of December 31, 2024 and 2023.

### **Investments**

Upon enrollment in the Plan, a participant may direct his or her account balance among the various investments offered by the Plan. The Plan currently offers investments in shares of registered investment companies, a pooled separate account, and a guaranteed annuity account.

### **Payments of Benefits**

Participants shall become eligible to receive their vested account balances upon retirement (normal retirement age is 65), death, disability or termination. Participants may withdraw their account balances upon reaching age 59½. Participants may receive their benefit payments in a single lump-sum payment or a monthly annuity. In addition, participants may withdraw their pretax contributions upon demonstration to the plan administrator that they are suffering a hardship, as defined in Section 403(b) of the Code.

## 2. **Summary of Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements have been prepared on the modified cash basis of accounting. Accordingly, certain revenue and related assets are recognized when received, rather than when earned, and certain expenses are recognized when paid, rather than when incurred.

### **Use of Estimates**

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, and changes therein, and disclosure of contingent assets and liabilities, at the date of the financial statements. Actual results could differ from those estimates.

### **Investments**

Investments are reported at fair value, except for the nonbenefit-responsive and fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the cash basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are valued using the unpaid principal balance. Interest income on notes receivable from participants is recorded when it is received. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

### **Administrative Expenses**

Certain administrative expenses are paid by the University. Certain investment expenses are paid to TIAA and CREF through the Plan's investments as eligible indirect compensation, which includes fees or expense reimbursement payments charged to investment funds and reflected in the value of the investment or return on investment of the Plan. Total eligible indirect compensation paid to TIAA and CREF through the Plan for 2024 was \$1,199,528.

### **Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

### **3. Guaranteed Annuity Account**

Investments in the TIAA Traditional Annuity are in a guaranteed annuity account. Contributions to this investment buy contractual or guaranteed amounts of future benefits for the participant. Interest credited to the investments includes a guaranteed rate plus additional amounts established on a year-by-year basis. The contracts are included in the financial statements at contract value as reported to the Plan by TIAA and CREF. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value.

The investments provide for nonbenefit-responsive and fully benefit-responsive contracts. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The nonbenefit-responsive contracts do not allow for lump-sum withdrawals. In addition, participant-initiated transfers may only be made in ten annual installments. Due to these liquidity restrictions, the contracts are nonbenefit-responsive. There are no liquidity restrictions for the fully benefit-responsive contracts, with the exception of for certain Retirement Choice Plus contracts, a 90-day equity wash applies if competing funds exist. Transfers from the TIAA Traditional Annuity can only be made to noncompeting funds.

#### 4. **Income Tax Status**

The Plan sponsor adopted a volume submitter 403(b) plan, which received a favorable advisory letter on August 7, 2017, in which the Internal Revenue Service stated that the volume submitter plan as then designed, was in compliance with the applicable requirements of the Code. The volume submitter plan has been amended since receiving the advisory letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

#### 5. **Information Prepared and Certified by Custodians**

The investments, notes receivable from participants, investment transactions, net appreciation in fair value of investments, and interest and dividend amounts were obtained by management and agreed to or derived from the information certified by the custodians as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits (Modified Cash Basis);
- Statement of Changes in Net Assets Available for Benefits (Modified Cash Basis); and
- Schedule H, line 4i - Schedule of Assets (Held at End of Year).

#### 6. **Parties-In-Interest**

Certain Plan investments are managed by the custodians; therefore, these transactions qualify as party-in-interest transactions. The administrative expenses paid by the Plan for 2023 were \$203,816, and qualify as party-in-interest transactions as they are related to recordkeeper, investment advisory and auditor fees incurred by the Plan.

#### 7. **Plan Termination**

Although it has not expressed any intent to do so, the University has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).

### 9. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Registered investment companies:* Valued using market quotations.

*Pooled separate account:* Derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion using market and income approaches.

### 10. Subsequent Events

Management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

Subsequent to December 31, 2024, the Plan initiated and completed a transfer of assets from Fidelity to TIAA. All funds with Fidelity were liquidated, with the proceeds invested in TIAA sponsored funds. This change in service provider reflects a strategic decision by the Plan's fiduciaries to align investment offerings and administrative services with participant needs. The transfer was executed in accordance with ERISA guidelines and did not impact participant account balances or Plan operations.
