Opinion

We have audited the financial statements of Modern Drop Forge Company Employee Welfare Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and plan benefit obligations as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits and changes in plan benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

Notes to Financial Statements

December 31, 2024 and 2023

Note 1 - Plan Description

The following description of Modern Drop Forge Company Employee Welfare Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan provides health and other benefits to all eligible employees of Modern Drop Forge Company, LLC, as well as its subsidiaries, Modern Forge Services, LLC; Modern Forge Indiana, LLC; Modern Forge Tennessee, LLC; Rockford Process Control; Modern Forge Texas, LLC; and Modern Advanced Manufacturing, LLC (collectively, the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Health and Welfare Benefits

The Plan provides health benefits (medical, hospital, surgical, major medical, and dental), life insurance coverage, long-term disability benefits, and death benefits to full-time participants and to their beneficiaries and covered dependents. Prior to June 1, 2019, all employees (salaried and hourly) were eligible to participate after the 90th day following their date of hire. A plan amendment, effective June 1, 2019, entitled salaried exempt and nonexempt employees to be eligible upon their date of hire. Hourly employees continue to have a 90-day waiting period prior to eligibility.

Effective in December 2024, the Plan no longer provides retiree medical coverage, at which point substantially all retiree benefits were distributed to eligible participants, which also terminated the trust. Remaining benefits owed to retirees at December 31, 2024 were distributed in January 2025 and are reported in claims payable in the statement of net assets available for benefits. Prior to this change, retired employees were entitled to similar health benefits (in excess of Medicare coverage) provided they have attained at least age 62 and have 15 years of service with participating employers before retirement.

The Company is self-insured for dental benefits. All dental claims of active and retired participants, dependents, and beneficiaries are processed by the administrator group, but the responsibility for payments to participants and providers is retained by the Plan.

As of December 31, 2024 and 2023, the Company and all subsidiaries described above are self-insured for medical and prescription benefits for certain active and retiree participants. Medical and prescription claims are processed by the administrator group, but the responsibility for payments to participants and providers is retained by the Plan. The Plan has stop-loss reimbursement policies. The Plan had no aggregate stop-loss claims liability as of December 31, 2024 and 2023. The policy states that the Plan will be reimbursed for all claims paid in excess of \$300,000 per employee per year as of December 31, 2024 and 2023.

Contributions

The Plan provides for employer and participant contributions, as determined by the Company. The Company estimates the required premiums annually using actuarial calculations. Employees and retirees contribute specific amounts, determined periodically by the Plan's actuary, for medical benefits and to extend coverage to eligible dependents.

The service years, minimum age, and retiree and spouse monthly premium contributions are as follows to qualify for and to maintain coverage after retirement for the early retiree Employer Group Waiver Plans/Preferred Provider Organization medical insurance plans:

Note 1 - Plan Description (Continued)

Effective January 1, 1998, company contributions toward retiree health insurance premiums for current and future retirees were capped at two times the 1997 level under all retiree health plans. The retiree will pay the balance of retiree health insurance premiums.

Effective January 1, 2006, retirees and their eligible dependent spouses covered under the Early Retiree Health insurance plans offered, who subsequently reach age 65 after retirement, are no longer eligible for company-sponsored retiree medical coverage. Effective April 18, 2008, the Plan's post-65 retiree medical subsidy for employees who retire after December 31, 2010 was discontinued.

In 2016, the post-65 annual cash payment to supplement Medicare medical coverage was cut in half, and, effective January 1, 2017, it was entirely eliminated.

Eligible employees may elect to contribute to the Plan for postretirement medical benefits to pay for their own medical benefits. The monthly contribution for postretirement medical benefits is determined by age at the date of entering the Plan. Upon determination of a terminated participant's ineligibility for postretirement medical benefits, contributions plus interest earned at a guaranteed interest rate, or actual rate of return, whichever is higher, are 100 percent payable to the participant. Employees hired after March 25, 2004 are not eligible to participate in the company-sponsored retiree health coverage.

Administration

Third-party administration of the Plan is performed by an outside third party for general plan administration and claims processing.

Party-in-interest Transactions

Certain plan assets prior to disbursements were made to retirees were in an investment fund managed by Columbia Funds and affiliates (collectively, Columbia). Columbia was the custodian of the plan assets; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, the Plan's board of trustees has the right under the Plan to modify the benefits provided to employees and to terminate the Plan, subject to the provisions set forth in ERISA. If the Plan's board of trustees terminates or partially terminates the Plan, the net assets of the Plan will be used to pay benefit obligations of the Plan.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net realized and unrealized loss includes the Plan's net losses on investments purchased and sold and held during the year.

Benefit Payments

Benefits are recorded when paid.

Postretirement Benefits

Benefit obligations represents the ultimate cost of the Plan of settling claims incurred but not reported for active participants as of December 31, 2024 and 2023.

Note 2 - Summary of Significant Accounting Policies (Continued)

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' service rendered to the date of the financial statements reduced by the actuarial present value of contributions expected to be received in the future from current plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with participating employers. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Company, participants, and existing plan assets. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The health care cost trend rate assumption has a significant effect on the amounts reported. If the assumed rates increased by 1 percentage point, it would increase the obligation by approximately \$70,600 as of December 31, 2023. If the assumed rates decreased by 1 percentage point, it would decrease the obligation by approximately \$66,000 as of December 31, 2023. There would be no effect on the obligation with a 1 percentage point increase or decrease in the assumed rates as of December 31, 2024.

For measurement purposes, the annual rate of increase in the per capita cost of covered health care benefits was and 8 percent in 2023.

The following were other significant assumptions used in the valuations as of December 31, 2023:

Weighted-average discount rate	4.82 percent per annum for 2023
Average retirement age	60.4 years of age in 2023
Mortality	Pri-2012 projected generationally with Scale MP-2021 for 2023

The foregoing assumptions were in place for the year ended December 31, 2023 and were unchanged through discontinuance of the retiree benefits in December 2024.

As of December 31, 2023, the Plan's deficiency of net assets over benefit obligations related primarily to the postretirement benefit obligation. It was expected that the deficiency would be funded through future company contributions.

The Plan provides certain eligible retirees with the opportunity to purchase health care insurance. During the years ended December 31, 2024 and 2023, the Plan received contributions from retirees of \$65,671 and \$47,288, respectively, and made benefit payments on behalf of the retirees of \$105,065 and \$112,797 for a net expense related to the retirees of \$39,394 and \$65,509 for the years ended December 31, 2024 and 2023, respectively.

Claims Incurred but Not Reported

The Plan's liability for incurred but not reported claims is estimated using payments made subsequent to year end in conjunction with historical trend information. Claims can be submitted for payment up to 12 months following the date of service.

Note 2 - Summary of Significant Accounting Policies (Continued)

Administrative Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net investment income.

Risks and Uncertainties

The plan benefit obligations are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics. Due to the changing nature of these assumptions, it is at least reasonably possible that changes in these assumptions will occur in the near term and, due to the uncertainties inherent in setting assumptions, that the effect of such changes could be material to the financial statements. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. It is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the financial statements.

Drug Rebates

Prescription drug rebates and refunds due from the Plan's third-party pharmacy benefit manager are recorded when earned. Rebates and refunds due as of the financial statement date have been reported as rebates receivable in the statement of net assets available for benefits, with the offset being netted against claims paid in the statement of changes in net assets available for benefits.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 9, 2025, which is the date the financial statements were available to be issued.

Note 3 - Tax Status

The trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (the "Code"). Certain investment income of a Section 501(c)(9) trust is subject to state and federal income tax as unrelated business income if the funds held by the trust are in excess of prescribed limits, and such income is earned on funds set aside to pay benefits of participants who are not covered by a collective bargaining agreement.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Note 4 - Fair Value Measurements (Continued)

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The Plan's investments as of December 31, 2024 and 2023 consist of mutual funds, which are valued at fair value using quoted market prices, Level 1 inputs, as described above, on a recurring basis.
