Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Ryan Companies US, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

Notes to Financial Statements

Note 1. Description of the Plan

The following description of Ryan Companies US, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Ryan Companies US, Inc. (the Company) who are age 20 or older and have completed the eligibility requirements as defined in the Plan document. Participants that are eligible for participation in the Plan are also eligible to receive Company matching contributions. Participants must be employed on the last day of the year to receive Company discretionary profit-sharing contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company has appointed Principal Life Insurance Company and Principal Trust Company on behalf of Principal Global Investors Trust Company (Principal) to be the custodians, invest and manage the assets of the Plan and provide administrative services. The Company is responsible for oversight of the Plan. The Plan's Retirement Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions: Participants have the option to contribute to the Plan through pretax and post-tax employee deferrals between 1% and 80% of eligible compensation, as defined by the Plan, up to the maximum permitted by law. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a Principal Lifetime Separate Account based on their expected retirement date until changed by the participant. If participants do not choose a different deferral rate, the percentage will be automatically increased by 1% each year to a maximum percentage of 10%. The Company currently makes a matching contribution equal to 100% of the first 4% of eligible compensation contributed by the participant to the Plan. In addition, the Company may make discretionary profit-sharing contributions. During 2023, the Company approved discretionary profit sharing contributions of \$5,517,458, net of forfeitures, which is included in receivables on the statements of net assets available for benefits as of December 31, 2023. There were no Company approved discretionary profit sharing contributions for the year ended December 31, 2024. Participants may also contribute amounts that represent distributions from other qualified plans (rollover).

Participant accounts: Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of (a) the Company's profit sharing contributions, if any, (b) forfeitures, if any, (c) Plan investment results, including increases or decreases in the fair value of investments and (d) certain administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their accounts into various investment options offered by the Plan.

Vesting: Participants are vested immediately in their contributions and the Company's matching contributions plus actual earnings thereon. Vesting in the profit sharing contributions portion of their account is generally based on the number of years for which an employee is credited with 1,000 hours or more of service, subject to certain other provisions of the Plan. A participant vests according to the following schedule:

Full Years of Employment	Vested Percentage
Less than two	0%
Two	20%
Three	40%
Four	60%
Five	80%
Six or more	100%

A participant becomes 100% vested in his or her account upon early retirement age as defined in the Plan, upon death or total disability during the term of employment, or upon termination of the Plan.

Payment of benefits: Benefits paid to participants represent the amounts paid during the year to withdrawing participants due to death, total disability, retirement or other termination of service. If a terminated participant's vested account balance is less than \$1,000, it will be automatically distributed to the participant in a lump sum within a reasonable amount of time. If a terminated participant has a vested balance between \$1,000 and \$5,000, it will be transferred into a qualified retirement account for the participant within a reasonable amount of time or distributed to the participant in a lump sum at the request of the participant. If a terminated participant has a balance greater than \$5,000, it will be paid out either in a lump sum or in installments over varying periods, as permitted by the Plan. Participants may also withdraw funds derived from their own contributions to the Plan in the event of hardship, as defined by the Plan or withdraw all or part of vested contributions upon attainment of age 59½.

Investment options: Principal manages the Plan's assets. The Plan has selected various investment options, as more fully described in the Plan literature, to which participants may designate the allocation of their account balances. The investment options vary in types of investments, rates of return and investment risk. Participants may elect on a daily basis to have all or part of their account balances and future contributions transferred from one investment option to another or in any combination.

Forfeitures: Forfeited nonvested accounts may be used for the payment of Plan expenses, to fund Company contributions or may be reallocated to participants. During 2024, \$706,551 of forfeitures were utilized to fund a portion of the 2023 discretionary profit-sharing contribution. The Plan had \$716,241 and \$679,613 of forfeitures held in suspense at December 31, 2024 and 2023, respectively.

Note 1. Description of the Plan (Continued)

Notes receivable from participants: Participants may borrow from their fund accounts. The total of any individual participant notes, not to exceed two, must be at least \$1,000 but may never exceed the lesser of (a) \$50,000 or (b) the greater of 50% of the participant's vested account balance or \$10,000, less any outstanding loan balance on the date the new loan is made. The notes are secured by the balance in the participant's account. The rates of interest on existing notes at December 31, 2024, range from 4.25% to 9.50%, with notes maturing at various dates through June 2035. The rate of interest on new notes is determined at the time of issuance. The term of a note may not exceed five years, unless the note qualifies as a home loan. Principal and interest are due each pay period.

Plan termination: Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Use of estimates: The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors and custodians. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

Payment of benefits: Benefit payments are recorded when paid.

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Expenses that relate solely to a specific participant will be charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Risks and uncertainties: The Plan provides for investment in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

Subsequent events: The Plan Administrator has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified or Provided by Principal Life Insurance Company, Principal Trust Company, and Principal Life Insurance Company on Behalf of Principal Global Investors Trust Company

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified or provided by Principal Life Insurance Company, Principal Trust Company, and Principal Life Insurance Company on behalf of Principal Global Investors Trust Company (the custodians). The Plan Administrator has obtained certifications from the custodians that the information provided to the Plan Administrator by the custodians related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to information that appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets.

Note 4. Fair Value Measurements

Accounting standards established the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below.

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Pooled separate accounts are valued at net asset value (NAV) as determined by Principal. The NAV is used as a practical expedient to estimate fair value.

Registered investment companies: Shares of registered investment companies are valued at the quoted market prices for shares held by the Plan at year-end.

Note 4. Fair Value Measurements (Continued)

Collective trust fund: The collective trust fund is valued at the NAV as reported by the investment advisor using the audited financial statements of the fund at year-end. The fund's underlying assets consist of investment contracts and security-backed contracts. The NAV is used as a practical expedient to estimate fair value.

Life insurance contract: Insurance investments are valued at the cash surrender value of the policies held, which approximates fair value.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period. For the year ended December 31, 2024, there were no transfers in or out of Levels 1, 2 or 3.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Related-Party Transactions and Party-in-Interest Transactions

Principal Life Insurance Company, Principal Trust Company, and Principal Life Insurance Company on behalf of Principal Global Investors Trust Company, the custodians, manage the Plan's investments. Transactions related to these investments thereby qualify as party-in-interest transactions.

Note 6. Tax Status

The Plan has adopted a nonstandardized preapproved plan sponsored by Principal Life Insurance Company. Principal Life Insurance Company has received an opinion letter from the Internal Revenue Service as to the preapproved plan's qualified status. The preapproved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
