Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of West Florida Medical Associates, P.A. Note 1 – Description of Plan

The following description of the West Florida Medical Associates P.A. Cash Balance Pension Plan (the Plan) which had an effective date of January 1, 2015, provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

- **General.** The Plan is a cash balance defined benefit plan providing retirement, disability and death benefits to all eligible employees of West Florida Medical Associates (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Board of Trustees is responsible for oversight of the Plan. The Trustees determine the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

All employees not excluded by class are eligible to enter on January 1 or July 1 coincidence with or following the completion of the following requirements: 1 year of service and minimum age of 21. To participate in the Plan, an Employee must be considered an Eligibility Employee as defined in the Plan, must meet the minimum age requirement, and service conditions as defined. All participants are eligible to retire with their full retirement benefit on the latter of the following: attainment of age 65 and completion of 5 years of participation from their hire date. Service years with less than 1,000 hours will be excluded.

- **Participant accounts.** Under the Plan provisions, amounts are credited by the Company to the participants' hypothetical accounts. The accounts are allocated compensation credits and investment credits at the end of every year. The compensation credits are allocated based on a percentage of the participants certified compensation as defined in the plan document for that particular year. The applicable contribution credits range from \$600 to \$200,000.

Participants' hypothetical accounts also receive investment credits at the end of the year. The amount of investment credit is tied to the average of the annual yields on 30-year treasury securities and is adjusted quarterly. As of December 31, 2024 and 2023, the interest rate was 4.92%.

- **Funding policy.** The Plan's funding policy is to contribute an amount which will meet or exceed the annual ERISA minimum funding requirement. During the years ending December 31, 2024 and 2023, the Plan contributed \$209,051 and \$1,204,474, respectively. The Company's contributions for 2024 and 2023 exceeded the minimum funding requirements of ERISA.

Although it has not expressed any intention to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions set forth in ERISA.

- **Pension benefits.** Benefits are determined based on the participants' hypothetical account balance. Plan participants are eligible for their plan benefit after terminating employment with vested rights. Participants become vested in the Plan upon completion of 5 years or more years of service or attainment of the normal retirement age (65). If the employees terminate before rendering 5 years of service, they forfeit the right to receive the portion of their accumulated plan benefits attributable to the Company's contributions. Upon termination of employment, participants have the option of receiving their vested benefit in the form of a one-time lump sum payment for a monthly annuity payable for their lifetime. The maximum monthly benefit is the lesser of \$22,083.33 and 100% of the highest 3-year average salary, subject to service requirements. The normal form of benefit is a benefit payable for the life of the participant.

- **Death and disability benefits.** If a Participant dies prior to his/her Annuity starting date, the Participant's spouse (if any) is entitled to a QPSA benefit in accordance with Section 9.03 of the Plan, unless the Participant has properly waived the QPSA benefit, then the QPSA portion of the death benefit is payable in accordance with the designation made by the Participant on the waiver form. The Employer may elect to provide a Disability benefit for any Participant who becomes disabled prior to becoming eligible to receive a distribution of his/her normal retirement benefit under the Plan.

Note 2 - Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements are prepared on the accrual basis of accounting in conformity with generally accepted accounting principles.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements and the changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Expenses of maintaining the Plan are paid by the Plan or the Company, as provided by the Plan document. Expenses that are paid outside of the Plan are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan, paid by the Plan, are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Note 3 – Investments / Insurance

The Plan has an investment contract with Voya Retirement Insurance and Annuity Company for the purpose of investing Plan assets. Participants can elect to invest amounts allocated to the accounts in either fixed income investment options under a guaranteed investment contract or to purchase participation units in various registered investment company mutual funds held in a Voya registered separate account.

Guaranteed Investment Contract with Voya Retirement Insurance and Annuity Company (Voya)

The Plan invests in an investment contract with Voya. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Voya, as the guaranteed investment contract issuer, is contractually obligated to repay principal and a specified interest rate that is guaranteed to the Plan. The contract value is the relevant measurement attributed for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the net assets available for plan benefits at contract value.

Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. The current interest rate is declared at the beginning of each calendar month and is applicable to new contributions received during the month. Interest is credited to the account daily and compounded at an annual rate. Voya guarantees that all contributions received during a calendar month will receive that month's current interest rate for the remainder of the calendar year. Voya's practice, though not guaranteed, is to continue crediting interest at the same rate for purchase payments for one calendar year. Thereafter, the amounts are consolidated with contributions made during other periods and will be credited with interest at a rate which Voya declares annually on January 1 and guarantees for the remainder of the calendar year.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract. The plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The average yield earned by the guaranteed investment contract based on both actual earnings and interest rate credited to participants was 6.6% and 11.7% for the years ended December 31, 2024 and 2023.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan could access.

Note 4 – Fair Value Measurements (concluded)

Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data. If the asset or liability has a specified contractual term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Guaranteed investment contract with Voya Retirement Insurance and Annuity Company:

Valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

Changes in Fair Value of Level 3 Assets

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Note 5 – Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump sum distributions that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated participants or their beneficiaries, (b) beneficiaries of participants who have died, and (c) present participants or their beneficiaries. Benefits under the plan are accumulated based on the participants' compensation during each year of credited service. The accumulated plan benefits for active employees will equal the accumulation, with interest, of the annual benefit accruals as of the benefit information date. Benefits payable under all circumstances- retirement, death disability, and termination of employment- are included, to the extent they are deemed attributable to employee service rendered to the valuation date. Benefits to be provided via annuity contracts excluded from the plan assets are excluded from accumulated plan benefits. The actuarial present value of accumulated plan benefits is determined by an independent actuary and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The significant actuarial assumptions used in the valuations as of December 31, 2024 and 2023, were (a) life expectancy of participants using the following tables (Male 2023 Static Table-Combined Male Female 2023 Static Table - Combined Female, 2023 Applicable Mortality Table from Notice 2022-22, and 2015 Applicable Mortality Table from Notice 2013-49) (b) retirement age assumptions (the assumed average retirement age was 65) and (c) investment return.

The interest rates used to discount the obligation for 2024 and 2023 was 4.92%, including a reduction of \$70,947 and \$94,488, respectively in Plan administrative expenses. The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated Plan benefits. The computations of the actuarial present value of accumulated plan benefits were made as of January 1, 2025 and 2024. Had the valuations been performed as of December 31, there would be no material differences.

Note 6 – Plan Termination

In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA, and its related regulations, generally to provide the following benefits in the order indicated:

- 1) Benefits attributable to employee contributions, if any.
- 2) Annuity benefits that former employees or their beneficiaries have been receiving for at least 3 years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan.
- 3) Other vested benefits insured by the Pension Benefit Guarantee Corporation (PBGC) (a U.S. Government agency) up to the applicable limitations.
- 4) All non-vested benefits. Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the plan sponsor and the level of benefits guaranteed by the PBGC.


