### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of CRB Group, Inc. 401(k) Plan, (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). ### 1. Description of Plan

The following description of the CRB Group, Inc. 401(k) Plan, (the "Plan"), provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

#### a. General

The Plan, adopted January 1, 1987 and formerly known as Clark Richardson & Biskup Consulting Engineers, Inc. 401(k) Profit Sharing Plan & Trust, is a defined contribution plan covering all eligible employees of CRB Group, Inc., (the "Company"), who are age 21 or older. The Plan also covers all eligible employees of CRB Builders, L.L.C. (Affiliate) and CRB Architects - Engineers, P.C. (Affiliate). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### b. Contributions

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Employees participating in the Plan may enter into an elective deferral agreement authorizing the employer to withhold a portion of such participants' compensation, up to the Code Section 415 limit, to deposit to the Plan. The Company matches participants' deferrals in an amount equal to 50% of the elective deferral. Only elective deferrals up to 6% will be matched. Participants are immediately eligible for employer matching contributions.

The Company may make an annual discretionary contribution to the Plan during the continuance of the Plan in an amount, if any, determined solely by the Company.

#### c. Participant Accounts

Each participant's account is credited with the participant's contribution, the employer matching contribution and allocations of the Company's discretionary contribution and plan earnings. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the amount that can be provided from the participant's vested account.

#### d. Vesting

Vesting in the Company's match on salary deferral, discretionary contribution, and the earnings thereon, is based on years of credited service. A participant is 100% vested after three years of credited service.

#### e. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at 1% over the Prime Rate published in the Wall Street Journal on the first business day of the month the loan is originated. General purpose loans have a term of 12-60 months. Principal residence loans have a term of 61-180 months. The maximum number of loans a participant may have outstanding at one time is two. Principal and interest are paid ratably through payroll deductions.

#### f. Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Benefits are recorded when paid.

#### g. Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$92,942 and \$86,503, respectively. These accounts will be used to reduce future employer contributions or Plan expenses. In 2024, employer contributions were reduced by \$382,250 and plan expenses totaling \$487,228 were paid from forfeited non-vested accounts.

### 2. Summary of Significant Policies

The following are the significant policies followed by the Plan:

#### a. Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

#### b. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results may differ from those estimates.

#### 2. Summary of Significant Policies (Continued)

##### c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### d. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

##### e. Operating Expenses

The plan sponsor bears a significant portion of the administrative costs for the Plan, including the costs of officers and employees who perform certain administrative functions. Expenses that are paid by the Company are excluded from these financial statements. Plan expenses that are paid by the Plan consist of fees charged by the Plan's trustee, investment advisor, auditor, and contract administrator.

##### f. Income Taxes

The Plan's income tax filings are subject to examination by various taxing authorities. The Plan's open examination periods are 2021 and forward.

##### g. Subsequent Events

Subsequent events have been evaluated up to October 10, 2025, the date these financial statements were available to be issued.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy within is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques are used to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies, as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective investment trust:* Valued at the net asset value (NAV) of units of the collective investment trust. The NAV is based on the fair value of the underlying investments and is used as a practical expedient to estimate fair value.

*Self-directed brokerage accounts:* Accounts primarily consist of mutual funds, common stocks and interest-bearing cash equivalents. Mutual funds, common stocks, and unit investment trusts are valued on the basis of readily determinable market prices (level 1). Interest-bearing cash and cash equivalents are valued at cost, which approximates fair value (level 2).
