Independent Auditors' Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of the Ziegler Tire Companies Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of Plan

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a participant-directed defined contribution plan covering all full-time employees of Ziegler Tire and Supply Company and subsidiaries (Company). The subsidiaries include Ziegler Tire of North Canton, Inc., Ziegler Tire Canton Centre, Ziegler Tire of Huron County, G&Z Tire Company, Jost Tire Service, Mighty Tire Wholesale, Inc., Ziegler Oil Company, Ziegler Morgan LLC, and Ziegler Tire Acquisition Co. Employees are eligible to participate following attainment of age 18 and completion of six months of service, as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was established November 1, 1997 and was amended and restated as of January 1, 2021.

Contributions:

The Company allows participants to make both pre-tax contributions and Roth elective deferrals in any amount up to the limitations allowed by the Internal Revenue Code (IRC).

The Company matches contributions equal to 10% of amounts (limited to 6% of compensation) contributed by participants. For Ziegler Tire Acquisition Co. participants, the Company matches 100% of the first 2% of contributions by participants and 2% of pay. The Company contributions were \$41,010 and \$37,465 during 2024 and 2023, respectively. The Company did not utilize any forfeitures for the years ended December 31, 2024 and 2023. The Company has remaining forfeitures in the amounts of \$10,108 and \$4,639 as of December 31, 2024 and 2023, respectively.

Participant Accounts:

Each participant's account is credited with the participant's contributions and Company matching contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1. Description of Plan (Continued)

Vesting:

A participant has a 100% non-forfeitable vested interest in his/her portion of contributions and related earnings. Vesting in the Company's matching contribution is based on years of continuous service as follows:

Payment of Benefits:

A participant or his or her beneficiary, upon termination, death, or retirement, receives his or her vested interest in his or her account in the form of cash distributions. Additionally, the Plan has provisions for an active participant to make hardship withdrawals from his or her account, subject to limitations and restrictions.

Investment Options:

Upon enrollment in the Plan, a participant may direct employer and employee contributions in any percentage increments to any of the available investment options.

Participants may change their investment options at any time.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Ziegler Companies Retirement Savings Plan ("Plan") are prepared on an accrual basis in accordance with accounting principles generally accepted in the United States of America.

Investments – All investments except an investment contract ("Voya Fixed Account") are invested in various pooled separate and money market accounts at Voya Retirement Insurance and Annuity Company ("Voya"), as directed by the participant.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

Note 2. Summary of Significant Accounting Policies (Continued)

The Voya Fixed Account is not considered fully benefit responsive, and the related contract value approximates fair value. Investments are stated at fair value. These amounts are not adjusted for market volatility from December 31, 2024 to the date of our report. See Note 6 for discussion of fair value measurements.

Payment of Benefits – Benefits are recorded when paid.

Income Recognition – Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Fees – Administrative expenses of the Plan are paid by the Plan or the Company at the option of the Company. Fees paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Subsequent Events – The Plan has evaluated subsequent events through October 8, 2025, which is the date the financial statements were available to be issued.

Note 3. Forfeited Accounts

Forfeited accounts may be used to reduce future company contributions or as a discretionary contribution. Forfeitures of \$5,137 and \$216 were incurred by the Plan for the years ended December 31, 2024 and 2023, respectively.

Note 4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right, by action of the Board of Directors, to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants shall be fully vested in their accounts and will receive a total distribution of the balances in their respective accounts.

Note 5. Federal Income Tax Status

The Plan utilizes a Volume Submitter Plan Document offered by the Custodian. The Internal Revenue Service has informed the Custodian by a letter dated June 30, 2020, that the form of the Plan is acceptable under applicable sections of the Internal Revenue Code ("IRC"). Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Company is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.

Note 6. Fair Value Measurements

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. Fair value is defined as the price that would be received to sell an asset or would be paid to transfer a liability in an orderly transaction between market participants at the measurement date. The inputs used to measure fair value are classified into three levels:

- Level 1 – Quoted market prices in active markets for identical assets and liabilities
- Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data
- Level 3 – Unobservable inputs in which little or no market data exists

The following is a description of the valuation methodologies used for Plan assets measured at fair value:

- Investment contract: The investment contract is valued at contract value, which approximates fair value, and represents contributions plus interest at a specified rate, less participant withdrawals and fees. These investments are considered to be Level 2 investments.
- Pooled separate accounts: The fair value of investments held in the pooled separate accounts is based on their reported net asset value ("NAV"). The NAV is based primarily on the market value of the underlying investments. These investments are considered to be Level 2 investments.

Note 6. Fair Value Measurements (Continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. There have been no changes in the methodologies used from 2023 to 2024. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9. Party-in-interest Transactions

Certain Plan investments are shares of funds managed by Voya. Voya is the Custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the Custodian amounted to \$10,003 and \$7,901 for the years ended December 31, 2024 and 2023, respectively.

Note 10. Delinquent Participant Contributions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. The Company had employee contributions of \$15,314 and employer contributions of \$1,202 owed to the Plan from the 2021 plan year. Management calculated lost earnings and remitted both the lost earnings and employee contribution to the Plan during 2024.
