## Independent Auditor's Report

Participants, Plan Administrator and Board of Directors

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of EJOT ATF, LP Wellness & Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### Notes to Financial Statements

---

#### Note 1. Plan Description

The following brief description of the EJOT ATF, LP Wellness & Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering all nonunion employees of EJOT ATF, LP and the related adopting companies, Header Products, Inc. and Surber Investments, Inc. (together, the Companies or Plan Sponsor), who have completed one month of service and are age 18 or older. Employees can begin participating the first day of the month after meeting eligibility requirements. To receive company contributions, an employee must be credited with at least 1,000 hours of service and be employed on the last day of the plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan, through payroll deductions, not to exceed regulatory limits according to the Internal Revenue Code (IRC). Participants aged 50 or older are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Companies' Board of Directors determines the Companies' matching contributions, as well as any annual discretionary Companies' matching and profit sharing contributions. The matching contribution for 2024 was 50% of an employee's deferral up to 4% of eligible compensation, as defined. The Companies' matching contributions for the year ended December 31, 2024, amounted to \$592,407. There were no discretionary profit sharing contributions related to 2024. Contributions are recognized when earned.

**Participant accounts:** Participant accounts are credited with participant contributions, the Companies' matching contributions, if any, and an allocation of the Companies' profit sharing contributions, if any, and investment earnings, and charged with an allocation of administrative expenses. Allocations are based on the participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account, as defined.

**Vesting:** Participant contributions and earnings thereon are immediately 100% vested. For the remaining portions of the participant's account, vesting increases with years of continuous service. A participant's account is 20% vested per year beginning with year one and is 100% vested after five years of service, as defined. Full vesting also occurs at age 65 or upon death or disability.

**Investment options:** Upon enrollment in the Plan, a participant may direct his/her investment into a variety of investment options as more fully described in the Plan's literature. Participants may change investment options daily.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balanced during the prior 12-month period or 50% of their vested account balance. A participant may have no more than two loans outstanding at any given time. Notes receivable terms range from one to five years; however, longer repayment periods, as determined by the Plan Administrator, are permitted when the note is used for the purchase of a primary residence. The notes receivable are collateralized by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan Administrator at the time of loan origination. Interest rates range from 4.25% to 9.50% and 4.25% to 8.50% at December 31, 2024 and 2023, respectively. Principal and interest payments are paid through payroll deductions.

#### Note 1. Plan Description (Continued)

**Payments of benefits:** The Plan provides that if a participant is married, he or she must elect to receive an amount equal to the value of the participant's vested interest in his or her account in a qualified joint and survivor annuity unless the participant elects to waive the joint and survivor annuity in writing, and the participant's spouse consents to such waiver in writing. If the participant is unmarried or the participant and the participant's spouse elect not to take the qualified joint and survivor annuity, the participant can choose to receive the benefit payments in a lump-sum, in installments not to extend past the participant's life expectancy, in an alternative form of annuity, or in a combination of the preceding options. In addition, distributions may be made from the Plan in cases of financial hardship.

**Forfeitures:** Forfeitures of nonvested portions of terminated participants' accounts are to be used to pay any administrative expenses, and any remaining forfeitures can be used to offset any Companies' contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0. During the year ended December 31, 2024 and 2023, \$0 and \$21 were used to pay plan expenses and reduce the Companies' contributions, respectively.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The accompanying financial statements of the Plan are prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC).

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Compensation and Benefits Committee determines the Plan's valuation policies utilizing information provided by the investment custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Capital gain distributions are included in net appreciation (depreciation).

**Valuation of notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Defaulted participant loans are reclassified as distributions based upon the terms of the plan document.

**Payment of benefits:** Benefits are recorded when paid.

**Accounting estimates:** The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Subsequent events:** The Plan has evaluated subsequent events through September 30, 2025, the date the accompanying financial statements were available to be issued. No subsequent events have occurred through that date that required recognition or disclosure in these financial statements.

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Shares of registered investment companies:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Units of pooled separate accounts:** Valued at NAV per unit of the pooled separate accounts. The NAV, as provided by the insurance company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments comprising the pooled separate accounts. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

**Units of common/collective trusts:** Valued based on the NAV of units of the common/collective trusts. The NAV, as provided by the Trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Changes in fair value levels:** To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value to another.

Management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of Level 3.

#### Note 5. Plan Termination

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

#### Note 6. Related-Party and Party-in-Interest Transactions

The Plan's investments are held, invested and maintained by Delaware Charter Guarantee and Trust Company (d/b/a Principal Trust Company), the Trustee, and Principal Life Insurance Company, the Custodian. The Trustee and Custodian also perform administration and recordkeeping services for the Plan. These transactions qualify as party-in-interest transactions. Total administrative expenses paid by the Plan to its service providers was \$76,676 for the year ended December 31, 2024.

Certain employees of the Companies provide administrative services to the Plan. These employees are not paid by the Plan. Certain other administrative expenses are paid by the Companies on behalf of the Plan.

#### Note 7. Income Tax Status

Effective October 12, 2014, the Plan adopted a non-standardized form of a prototype plan sponsored by Principal Life Insurance Company. The prototype plan has received an opinion letter from the Internal Revenue Service (IRS) as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

#### Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
