Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Lipman, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Lipman, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

NOTE 1 DESCRIPTION OF THE PLAN

Organization

Lipman 401(k) Plan (the “Plan”) is a defined contribution plan covering all eligible employees of LFC Enterprises, Inc. (the “Company” or the “Employer”). The Plan was established on January 1, 2013, and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan was most recently amended effective April 1, 2024.

The following brief description of the Plan provides only general information. Participants should refer to the Summary Plan Description or Plan Document for a more complete description of the Plan’s provisions.

General

The Plan covers all eligible employees of the Company as defined by the Plan Document. To participate in the Plan, employees must not be a “highly compensated employee”, not be employed at LFC Agriculture, and not be covered by a collective bargaining agreement. The elective deferral agreement is effective as soon as administratively feasible following the date of entry. There are no age or service requirements.

Contributions

Participants in the Plan may contribute up to 100% of their eligible compensation, not to exceed the maximum allowed by the Internal Revenue Code (the “Code”) for 2024. In addition, the Plan and the Code permit participants age 50 or over during the Plan year to make additional “catch-up contributions.” Participants may also contribute amounts representing distributions from other qualified retirement plans.

The Company shall make Matching Contributions to the Plan. The Matching Contributions are based on participants’ compensation and elective deferrals. Matching Contributions are made after each pay period and are made to all participants who were active at any time during the payroll period. The Company makes Matching Contributions based on the following schedule:

The Company may also make Discretionary Contributions for any plan year in an amount determined by them. There were no Discretionary Contributions made in 2024.

For the year ended December 31, 2024, employer Matching Contributions were approximately \$422,000 and are reflected in the statement of changes in net assets available for benefits.

Investment Options

Upon enrollment, a participant may direct participant and employer contributions to any of the Plan's fund options. Participants may also redirect their contributions or exchange their existing fund account balances on any business day.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of employer contributions and Plan investment results. Allocations of employer contributions are based on participant earnings and allocations of Plan investment results and administrative expenses are based on account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided by the participant's account.

Vesting

Participant's contributions, including rollover contributions, and actual earnings thereon, are 100% vested. Employer contributions and actual earnings thereon are incrementally vested over five years at 20% per year, beginning the second year of vesting service. In the event of death, total or permanent disability, or retirement, participants become fully vested in the Employer contributions.

Payment of Benefits

Upon death, disability, retirement, termination of service, or attainment of age 59.5, participants or their designated beneficiaries may receive a lump-sum payment amount equal to the vested amount of their account.

Notes Receivable from Participants

Loans were transferred from another plan, however no loans are permitted by this Plan.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to amend or discontinue the Plan at any time subject to the provisions of ERISA. Upon termination of the Plan, the account of each participant will be 100% vested.

NOTE 2 SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting and in conformity with generally accepted accounting principles in the United States ("GAAP").

Valuation of Investments

The Plan's investments, comprised of pooled separate accounts, mutual funds, and a common/collective trust, are stated at fair value as reported by Principal Life Insurance Company (the "Custodian") on the last business day of the Plan year.

The units of pooled separate accounts are valued at the Net Asset Value (the "NAV") by the Custodian. The NAV is considered as a readily determinable fair value.

Mutual funds are valued at the NAV reported in the active market where the fund is traded on a daily basis.

The common/collective trust funds are investment funds valued at the NAV of units offered by Principal Life Insurance Company.

Purchases and sales of securities are recorded on a trade-date basis. Gain or loss on sales of securities is based on average cost. Dividend income is recorded on the ex-dividend date. Interest income is recognized as earned on the accrual basis.

The Plan presents, in the statement of changes in net assets available for benefits, the net appreciation in the fair value of its investments. This consists of the realized gains or losses and the unrealized appreciation or depreciation in those investments. Investment management expenses charged to the Plan for investments in pooled separate accounts are deducted from income earned and are not separately reflected. Consequently, investment management expenses are reflected as a reduction of investment return for such investments.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates that affect the amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. No allowance for credit losses has been recorded for 2024 or 2023.

Forfeitures

Forfeitures of terminated non-vested accounts are used to reduce Employer contributions. There were approximately \$34,000 in forfeitures in 2024. The Plan used forfeitures in 2024 to offset employer contributions of approximately \$34,000 in 2024. Forfeiture balance as of December 31, 2024 is \$0.

Excess Contributions

Amounts payable to participants for contributions in excess of amounts allowed by the internal revenue service are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions in 2024 or 2023.

Benefit Payments

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain investment-related expenses and record-keeping expenses are included in the net appreciation in fair value of investments. Investment management and other administrative expenses are paid directly by the Plan

and are included in administrative expenses on the statement of changes in net assets available for benefits.

Subsequent Events

In accordance with Financial Accounting Standards Board Accounting Standards Codification “FASB ASC” Topic 855, *Subsequent Events*, the Plan evaluated subsequent events through October 13, 2025, the date the financial statements were available for issue.

NOTE 3 INFORMATION CERTIFIED BY THE PLAN’S CUSTODIAN

The Plan administrator has elected the method of compliance as permitted by Section 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodians of certain Plan assets have certified as to the completeness and accuracy of the funds held by them as of December 31, 2024 and 2023, as reflected in the accompanying financial statements and supplemental schedules. Principal Life Insurance Company is the certifying entity.

NOTE 4 FAIR VALUE MEASUREMENTS

In accordance with FASB ASC 820, *Fair Value Measurement*, the Plan assessed the guidelines for measuring fair value. These guidelines provide a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. FASB ASC 820 establishes three levels of fair value hierarchy that are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets and quoted prices for identical or similar assets or liabilities in inactive markets. Inputs other than quoted prices that are observable for the asset or liability and inputs that are derived principally from or corroborated by observable market data are also included. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following methods and assumptions were used to estimate fair value of each class of assets that are recognized at fair value:

Pooled Separate Accounts

These investments are public investment vehicles valued using the NAV provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The

NAV is classified within Level 2 of the valuation hierarchy because the NAV's unit price is quoted on a private market that is not active; however, the unit price is based on underlying investments which are traded on an active market.

Mutual Funds

The investments are public investment vehicles valued using the NAV provided by the administrator of the Fund. The NAV is based on the value of the underlying assets owned by the Fund, minus the liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

Common/Collective Trust

These investments are investment vehicles valued using the NAV provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is classified within Level 2 of the valuation hierarchy because the NAV's unit price is quoted on a private market that is not active; however, the unit price is based on underlying investments which are traded on an active market.

NOTE 5 INCOME TAX STATUS

The Plan is a non-standardized pre-approved profit sharing plan through Principal Life Insurance Company (Principal). The Internal Revenue Service (IRS) has determined and informed Principal by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 6 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 PARTIES IN INTEREST AND RELATED PARTY TRANSACTIONS

Certain Plan investments are funds managed by Principal Trust Company (Principal). Principal is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Fees incurred by the Plan for the investment management services are included in net appreciation/(depreciation) in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the third party administrator of approximately \$85,000 for record-keeping and other administrative expenses which was not covered by revenue sharing. The Plan Sponsor pays directly, any other fees related to the Plan's operations.

All of the above party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

The Plan Sponsor has identified certain participant deferrals that were deemed to be remitted late to the Plan, and has included a Schedule H, Line 4a Supplemental Schedule to this report. The financial statements are not adjusted for these late deferrals and the Plan Sponsor corrected most of these late remittances in 2024 and 2025 and expects the remaining corrections to be immaterial to the Plan as a whole. They are currently working with Principal to make the remaining corrective deposits for any lost earnings, if any.
