To the Board of Trustees of the

Retirement Fund

Opinion

We have audited the financial statements of the Roofers Local No. 9 Supplemental Retirement Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits - modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits - modified cash basis for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Roofers Local No. 9 Supplemental Retirement Fund as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with the modified cash basis of accounting described in Note 2.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Plan management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Plan management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing GAAS.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Roofers Local No. 9 Supplemental Retirement Fund (the Plan) provides only general information. Participants should refer to the Plan's plan document for a more complete description of the Plan's provisions.

General - The Plan was established in 1993 under a trust agreement, with amendments since that time, and is maintained pursuant to collective bargaining agreements which provide for the rate of employer contributions, the type of work and areas of work for which contributions are payable, and certain other terms governing contributions. The Plan's purpose is to supplement the benefits of the Roofers Local No. 9 Pension Fund by the establishment of an individual account plan to which contributions are made for each employee working as a roofer in the jurisdiction of the United Union of Roofers, Waterproofers and Allied Workers Local Union No. 9. The Plan is administered by a Board of Trustees consisting of representatives of the employers and the union. The Plan is a non-contributory, defined contribution profit sharing plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Plan Benefits - The Plan provides retirement income benefits for eligible employees and their beneficiaries. Participants are eligible to receive the total value of their accounts, determined as of the relevant Plan valuation date, upon reaching the Plan's normal retirement age (age 60), or having been determined to be eligible for early retirement (age 52 with 15 years of service), a service retirement, disability, or upon termination of employment for a specified time period.

Participants may also receive a limited portion of their accounts due to specified hardships, or if they qualify for an in-service distribution.

An individual will become a participant in the Plan as of the first day he or she has completed at least 400 hours of work in covered employment in an eligibility (a twenty-four consecutive-month) period. A participant shall become a terminated participant when the participant incurs a break in service, as defined by the Plan. A break in service means the failure of a participant to complete at least one hour of service during a period of twelve consecutive months. A terminated participant who does not receive a distribution of the entire value of his or her Plan account shall again become a participant on the day the participant returns to work for at least one hour in covered employment. A terminated participant who receives a distribution of their entire account balance from the Plan must subsequently meet the 400 hour work requirement described above to again become a participant.

NOTE 1. DESCRIPTION OF THE PLAN (continued)

Vesting - Each participant shall be fully vested in the value of the employer contributions allocated to the participant's account, which shall be non-forfeitable but will be subject to adjustment for investment earnings and losses and for allocation of expenses.

Contributions - Contributions to the Plan are made by contributing employers at rates established by collective bargaining agreements. Employee contributions are accounted for as exchange transactions. The contribution rate for each hour worked by covered employees was \$2.60 effective January 1, 2018 provided that the applicable rate could vary for apprentices. Effective June 1, 2023 the contribution rate for each hour worked by covered employees was \$2.75. Effective January 1, 2024 the contribution rate for each hour worked by covered employees was \$2.80. Contributing employers primarily conduct business in the State of Connecticut. Contributions from 3 employers comprised 81% of total 2024 contributions received.

Pursuant to the collective bargaining agreement, if a participant works more than 2,000 hours in covered employment during a plan year, contributions which would have otherwise been made with respect to that participant to the Roofers Local No. 9 Pension Plan for hours in excess of 2,000 are made instead to this Plan. Such contributions totaled \$7,821 and \$11,412 for the years ended December 31, 2024 and 2023, respectively.

Participation and Participant Accounts - An employee becomes a participant in the Plan as of the first day he or she has completed at least 400 hours of work in covered employment in an eligibility period (a twenty-four consecutive month period). Covered employment means employment with a contributing employer in a category of work covered by a collective bargaining agreement requiring contributions to the Plan. The Plan allows participants to direct the investment of all or a portion of their accounts and the employer contributions made on their behalf to any investment option offered under the Plan.

Each participant's account is credited with employer contributions and adjusted by investment results and expenses. Administrative expenses are allocated among those accounts which are in existence on the last day of each quarter during the plan year. This expense allocation is on a per capita basis. Net earnings or losses are allocated on a daily basis based upon the investment results of the investment options in a participant's account.

Plan Amendment - On November 29, 2024, the Board of Trustees adopted the 29th amendment to the Plan. Effective January 1, 2025 a participant with an account balance of \$7,000 or less, the Trustees shall distribute the entire amount in a lump sum. No other optional form of payment shall be available to the Participant and the consent of his Spouse, if any, shall not be required. The amendment as added forfeitures (i.e., amounts which are "turned over" to the Fund's general administrative expense account from a Participant's or Beneficiary's account after a certain amount of time if a Participant has a break in service, or if a Participant or Beneficiary is otherwise becomes eligible for a full distribution of his or her account, and cannot be found by the Fund after a reasonable search). In the event that the applicable Participant or Beneficiary is located subsequently, the Fund must return the forfeited amounts to that individual.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation - The accompanying financial statements have been prepared on the modified cash basis of accounting. Under this basis, except for investments and the net appreciation (depreciation) which are stated at fair value, income is generally recognized when received rather than when earned, and expenses are generally recognized when paid rather than when incurred.

Consequently, contributions receivable, accounts payable and accrued expenses at December 31, 2024 and 2023, have not been recorded in the accompanying financial statements.

Valuation of Investments and Income Recognition - Investments consist of shares in registered investment companies and an investment contract with Empower Annuity Insurance Company of America. Shares of registered investment companies are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. The investment contract with Empower Annuity Insurance Company of America is carried at contract value as reported by the insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

See Note 7 for discussion of Fair Value Measurements.

Use of Estimates - The preparation of financial statements in conformity with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE 3. TERMINATION

The Trustees expect and intend to continue the Plan indefinitely but reserve the right to amend or terminate the Plan. Upon termination of the Plan or complete discontinuance of contributions, each participant or beneficiary will have nonforfeitable rights to their account, after providing for all of the expenses of the Plan at termination.

The Plan is qualified under Section 401(a) of the Internal Revenue Code and the related trust is exempt from federal income tax under Section 501(a).

The Plan obtained its latest determination letter dated June 1, 2015 in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter, however, the Plan's legal counsel believes the Plan is currently designed, and the Plan administrator believes the Plan is currently being operated in compliance with the applicable requirements of the Code. Therefore, they believe that the Plan is qualified, and the related trust is tax exempt as of the financial statement date.

NOTE 4. TAX STATUS

The modified cash basis of accounting requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (asset) if it has taken an uncertain position, that more likely than not, would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5. OPERATING LEASE

The Plan leases its administrative office on a month-to-month basis from a related party. The monthly rent was \$245 effective September 1, 2021. Rent was allocated in accordance with the administrative expense allocation policy described in Note 8.

Rent expense paid by the Plan was \$3,129 and \$3,031 for the years ended December 31, 2024 and 2023, respectively.

Subsequent to year end, the Plan entered into a new lease for its administrative office on a month-to-month basis from a related party. The monthly rent was \$278 effective January 1, 2025.

NOTE 6. CONTRACT ADMINISTRATION

The Plan has a contract with Brescia's Printing Services, a third-party administrator, to administer the Roofers 9 Benefit Funds. The contract provided for a monthly fee of \$14,294 for all Roofers 9 Benefit Funds effective September 1, 2021. The fees are allocated in accordance with the administrative expense allocation policy described in Note 8. The administrative fees paid by the Plan were \$58,732 and \$56,983 for the years ended December 31, 2024 and 2023, respectively.

Subsequent to year end, the Plan entered into a new contract with Brescia's Printing Services. The contract provided for a monthly fee of \$15,695 for all Roofers 9 Benefit Funds effective January 1, 2025.

NOTE 7. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Basis of Fair Value Measurement:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE 7. FAIR VALUE MEASUREMENTS (continued)

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value, as well, as the general classification of such assets and liabilities pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies: Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end and are classified within level 1.

NOTE 8. RELATED PARTIES

The Plan is affiliated with other employee benefit funds of the Roofers Local No. 9. Certain common expenses were allocated to the Plan at a rate of 33% of total expenses for the plan years ended December 31, 2024 and 2023. For the years ended December 31, 2024 and 2023 common expenses totaled \$231,751 and \$222,727, respectively.

In accordance with the common expense allocation the Plan paid \$74,836 and \$71,653 for the years ended December 31, 2024 and 2023, respectively. Subsequent to year end, the difference between the fixed rate allocation and actual payments is adjusted with the affiliated funds.

NOTE 9. PARTY IN INTEREST TRANSACTIONS

Certain investments are managed by Newport Trust Company/Empower for the Plan. Newport Trust Company/Empower is the custodian for the Plan. Additionally, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions qualify as party in interest transactions under ERISA.

NOTE 10. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statement of net assets available for benefits.

NOTE 11. GROUP ANNUITY CONTRACT WITH EMPOWER ANNUITY INSURANCE COMPANY OF AMERICA

The Plan has group annuity contract with Empower Annuity Insurance Company of America (Empower). Empower maintains the contributions in a separate account guaranteed interest contract. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

NOTE 11. GROUP ANNUITY CONTRACT WITH EMPOWER ANNUITY INSURANCE COMPANY OF AMERICA (continued)

The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The credit rating for the 2024 plan year was 1.45%. The crediting rate is reviewed on a quarterly basis for resetting.

The group annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 12. SUBSEQUENT EVENTS

Subsequent events have been evaluated through September 30, 2025, the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.
