Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - PLAN DESCRIPTION

The following brief description of the Athletico, Ltd. Employees' Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Athletico, Ltd., Athletico Management, LLC, Accelerated Rehabilitation Centers LTD, and Accelerated Health Systems LLC (collectively, the Company) who have one hour of service and are age 21 or older.

Effective January 1, 2023, Pivot Physical Therapy 401(k) Plan merged into the Plan. In addition, the Plan became a multiple employer Plan due to addition of non-related participating employers, including Georgialina Physical Therapy Associates, LLC; Pivot Professional Services, P.A.; PT Network, LLC; Pivot Occupational Health, LLC; and Onsite Innovations, LLC.

Employees who are collectively bargained, non-resident aliens, leased employees and employees of an affiliate who is not a participating employer are not eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: Each year, participants may contribute up to 75 percent of annual compensation, as defined in the Plan as pre-tax or Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan includes an auto-enrollment provision whereby employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5 percent of eligible compensation. Contributions are invested in a designated default fund until changed by the participant. Elective deferrals automatically increase by 1 percent each year on the anniversary of a participant's enrollment date until the deferral rate reaches the limit of 10 percent of eligible compensation. A participant may elect not to participate in this automatic escalation feature of the Plan.

The Company may contribute up to 50 percent of the first 5 percent of compensation that a participant contributes to the Plan. During 2024, the Company contributed 25 percent of the first 5 percent of compensation that a participant contributed each quarter. Additional profit-sharing amounts may be contributed at the option of the Company's Board of Directors. No additional profit-sharing contributions were made to the Plan for 2024. Contributions are subject to certain limitations.

Participant Accounts: Each participant's account is credited with the participant's contributions, the Company's matching contributions, as well as allocations of the Company's profit sharing contribution, if any, and an allocation of Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options: Upon enrollment in the Plan, participants are allowed to invest in a variety of investment choices as more fully described in the Plan's literature. Participants may change their investment options at any time.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of service. Prior to January 1, 2022, a participant vested 20 percent after two years of service and was 100 percent vested after six years of service. Beginning January 1, 2022, a participant vests 20 percent after one year of service and is 100 percent vested after five years of service.

Notes Receivable from Participants: No new loans to participants are permitted. Any pre-existing loans to participants resulting from plan mergers in prior years ("grandfathered loans") are permitted to remain in the Plan until they are fully repaid. Loan terms range from one to five years, unless the loan is used solely to acquire a principal residence. The loans are secured by the vested balance in the participant's account. The loan interest rate is set at one percent above the prime rate, as defined, on the first business day of the month before the loan is originated. The interest rate is fixed for the life of the loan. Principal and interest is paid ratably through payroll deductions.

Distribution of Benefits: On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may elect to receive a rollover distribution. In addition, hardship distributions are permitted if certain criteria are met. In-service withdrawals are also permitted for participants age 59 1/2 or older.

Forfeited Accounts: Forfeitures are used first to reduce Company contributions. Any remaining forfeitures are used to pay for Plan administration expenses. The Company contribution receivable at December 31, 2024 and 2023 has been recorded net of forfeitures to reflect the use of all available forfeitures to reduce Company contributions.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Executive Committee determines the Plan's valuation policies utilizing information provided by the investment custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Distribution of Benefits: Benefits are recorded when paid.

NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023 and net appreciation in fair value of investments, and interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by T. Rowe Price Trust Company (the trustee of the Plan).

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of inputs within the fair value hierarchy are defined as follows:

- Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of Registered Investment Companies: Valued at the quoted daily closing price as obtained on nationally recognized securities exchanges (Level 1). Shares of registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission.

Units of Collective Trusts: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under the Department of Labor's regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. T. Rowe Price Trust Company serves as the Plan's recordkeeper; therefore, expenses paid to T. Rowe Price Trust Company for recordkeeping services qualify as party-in-interest transactions. The Plan also holds a money market fund and units of collective trusts which are managed by T. Rowe Price Trust Company. These investments represent parties-in-interest. Additionally, notes receivable from participants also reflect party-in-interest transactions.

NOTE 7 - INCOME TAX STATUS

The Internal Revenue Service issued an opinion letter, most recently dated August 19, 2020, that stated that the prototype plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). The prototype plan opinion letter has been relied upon by this Plan. The Plan has been amended since the adoption date. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the U.S. federal, state, or local tax authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, liquidity, market, liquidity, and risks pertaining to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - SUBSEQUENT EVENTS

The Plan's management has evaluated subsequent events for potential recognition and/or disclosure through October 13, 2025, the date the financial statements were available to be issued.
