INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Easter Seals North Georgia 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Easter Seals North Georgia 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section,

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America;

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Easter Seals North Georgia 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Easter Seals North Georgia 401(k) Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

1. DESCRIPTION OF PLAN

The following brief description of Easter Seals North Georgia 401(k) Plan (the "Plan") is provided for general information purposes only. Participants or other interested parties should refer to the Plan Agreement for a more complete description of the Plan's provisions.

A. General

The Plan is a defined contribution plan covering all eligible employees of Easter Seals North Georgia, Inc. (the "Organization"). The Plan was effective January 1, 2005 and is subject to certain provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan has been amended over the years to comply with tax regulations.

The Organization's executive director is the Plan administrator and trustee. The custodians of the Plan's assets are Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (the "Custodians"). The Organization and the Plan administrator are responsible for the oversight of the Plan. The Plan administrator, utilizing the recommendations of advisors, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

B. Eligibility

Eligible employees can participate in the Plan for purposes of salary deferrals, safe harbor matching contributions and discretionary matching contributions after they have attained the age of twenty-one and completed one year of service with a minimum of 1,000 hours. The entry date into the Plan is the first day of the Plan quarter coinciding with or next following the date the employee satisfies the eligibility requirements.

C. Contributions

Each year, participants may contribute up to 100 percent of their pre-tax compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. For 2024, the maximum contribution limits are \$23,000 for normal contributions and \$7,500 for catch-up contributions. Participants may designate all or a portion of their contributions as after-tax contributions into a Roth account. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Organization provides a safe harbor matching contribution to each eligible participant in an amount equal to 100% of the first three percent of eligible compensation and 50% of the next 2% of eligible compensation that a participant contributes to the Plan.

D. Participant Accounts

Each participant's account is credited with the participant's contribution, the Organization's contributions, and an allocation of investment income (loss). Each participant is charged with fees upon receiving distributions, as well as an allocated portion of plan administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

E. Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Organization's matching contributions plus actual earnings thereon is based on years of continuous service. Participants vest at a rate of 20% per year beginning with the second year of service. A participant is fully vested after six years of service. Notwithstanding the above, a participant becomes fully vested upon death, disability, or attainment of normal retirement age.

F. Payment of Benefits

Upon termination of service, death or disability, a participant or representative may elect to receive the value of the vested interest in his or her account as a lump-sum distribution. Partial or installment distributions will be permitted only to satisfy the required minimum distribution rules. Additionally, Participants may elect to rollover their vested balance to another qualified retirement plan or IRA. Immediate lump-sum distributions may be made to terminated participants if the participant's vested account balance is less than \$1,000. For terminated participants with vested balances of greater than \$1,000 and less than \$5,000, their vested balance may be automatically rolled into an IRA unless otherwise elected. Participants are eligible to receive in-service distributions once the participant reaches the age of 59 1/2.

G. Forfeitures

Forfeited nonvested accounts may be used to reduce administrative expenses or future employer contributions. Total unused forfeited balances as of December 31, 2024 and 2023 were \$5,194 and \$0, respectively. During the year ended December 31, 2024, no forfeitures were used to reduce employer contributions.

H. Notes Receivable from Participants

Participant loans are not permitted under the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

B. Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's Fiduciary Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment appreciation includes the Plan's gains (losses) on investments bought and sold as well as held during the year.

D. Contribution Receivables

Participant contributions and any related employer matching contributions are recognized in the period during which the Organization makes the respective payroll deduction from the participant's compensation.

E. Contributions

Contributions from the Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from the participants.

F. Payment of Benefits

Benefit distributions are recorded when paid.

G. Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. Fees related to the administration of benefits paid to participants are charged directly to the participant account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of the investment accounts.

H. Subsequent Events

The Plan has evaluated subsequent events through October 6, 2025, the date these financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") *Accounting Standards Codification* ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include the following:
 - Quoted prices for similar assets or liabilities in active markets,
 - Quoted prices for identical or similar assets or liabilities in inactive markets,
 - Inputs other than quoted prices that are observable for the asset or the liability,
 - Inputs that are derived principally from, or corroborated by, observable

market data by correlation or other means.

If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

As of December 31, 2024 and 2023, the only assets that are measured at fair value on a recurring basis in periods subsequent to initial recognition are investments. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at fair value:

Registered investment companies: Valued at the closing price reported on the active market on which the individual securities are traded.

Pooled separate accounts: Valued based on the net asset value of the underlying assets as determined by the custodian. The net asset value ("NAV") is not a publicly quoted price in an active market. Currently, all redemptions for the pooled separate accounts are at that day's computed net asset value. NAV as a practical expedient is used to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur once every 30 days at the published NAV. There is no redemption notice period or unfunded commitments.

Collective investment trusts: Valued based on the NAV of the shares/units held by the Plan based on the market value of its underlying investments as determined by the custodian. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants,

4. PRINCIPAL FIXED INCOME GUARANTEED OPTION

During the year ended December 31, 2007, the Plan entered into the Principal Fixed Income Guaranteed Option, a fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company ("Principal"). Principal maintains contributions in a general account. The account is credited with the Composite Crediting Rate and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported by Principal, represents contributions made under the contract, plus earnings, less

participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$27,429 and \$52,266, respectively. The crediting interest rate is the composite crediting rate, which will never be less than the guaranteed minimum interest rate. Such interest rates are reviewed on a semiannual basis for resetting. At December 31, 2024 and 2023, the composite crediting rate equaled 1.65% and 1.55%, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that there are no events that would limit the Plan's ability to transact at contract value with participants.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. This contract does have a surrender charge of 5% that may be charged based on cumulative transfer percentages and advance notice of intent to terminate if a Plan terminates its interest in the contract.

The guaranteed investment contract is a single group annuity contract with a fixed rate of interest. It is not a portfolio of contracts whose yields are based on changes in the fair value of underlying assets as would be found in a stable value fund. As a result, the average yield earned by the Plan is the yield earned (i.e., interest credited) on the group annuity contract.

5. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIANS

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company and Delaware Charter Guarantee & Trust Company (Principal Trust Company), the Custodians have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

The Plan's independent accountants did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the financial statements and supplemental schedule.

6. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Plan investment products are shares of funds managed by the Custodians of the Plan. Any transactions with the Custodians or Organization qualify as party-in-interest transactions. Fees paid by the Plan to the Custodians for services amounted to \$2,659 for the year ended December 31, 2024.

7. PLAN TERMINATION

Although they have not expressed any intent to do so, the Organization has the right under the Plan to discontinue their contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their accounts.

8. TAX STATUS

The Plan adopted a pre-approved profit sharing with a cash or deferred arrangement plan designed by The Retirement Advantage, Inc. with the most recent opinion from the Internal Revenue Service dated June 30, 2020. The Internal Revenue Service requires that plan documents be restated every six years to incorporate changes in laws and regulations that have taken place since the last restatement. The Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any open tax periods.

9. RISKS AND UNCERTAINTIES

The Plan's participants invest in various investment securities, based on the sole discretion made by each participant. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
