Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Eliquent 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Eliquent 401(k) Plan (the Plan) (formerly known as the “Kinsale Holdings 401(k) Plan”) is a contributory, defined contribution plan for the benefit of non-consultant employees of Kinsale Holdings, Inc., dba Eliquent Life Sciences, and its subsidiaries: effective January 1, 2020, the employees of DATAREVIVE USA LLC became eligible to participate in the Plan; effective April 1, 2021, the employees of Talisam LLC became eligible to participate in the Plan; and, effective July 1, 2021, the employees of Greenleaf Health, Inc. and Clinical Outcomes Solutions, LLC, became eligible to participate in the Plan. In March 2024, Clinical Outcomes Solutions, LLC was sold and was no longer a participating employer in the Plan. Kinsale Holdings, Inc. and its subsidiaries are collectively referred to as “the Company”.

The Plan is administered by the Company and the Plan assets are held in a trust by Fidelity Management Trust Company (Fidelity). The funds must be used for the exclusive benefit of Plan participants and their beneficiaries. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan includes a 401(k) feature whereby eligible employees may contribute a portion of their pre or post tax compensation, as defined in the Plan and subject to statutory limitations. Catch-up contributions are permitted for those participants who are at least 50 years of age during the Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Employer matching contributions are discretionary. In 2024 and 2023, a match of 100% of deferrals up to 6% of eligible compensation, as defined, was declared. Contributions of employee deferrals to the Plan are made with each payroll and the match is funded annually.

Non-consultant employees are eligible for participation in the Plan after completion of one month of service. To be eligible for matching contributions, the employee must have at least 1,000 hours of service per year and be employed on the last day of the year.

Each participant's account is credited with the participant's contribution, and allocations of the related matching contribution, if any, and net plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Employer contributions and allocated earnings thereon, if any, vest with individual participants based upon years of service, with 100% cliff vesting after three years of service. Unvested benefits of terminated participants are forfeited and used to reduce employer matching contributions or to pay administrative expenses of the Plan. Balances in the forfeiture account were \$211,849 and \$103,813 at December 31, 2024, and 2023, respectively. In 2024, \$35,079 of forfeitures were used to pay plan expenses.

Note 1 – continued:

Vested benefits are payable upon the retirement, death, disability or termination of a participant. In-service withdrawals are permitted in cases of hardship, or upon the participant attaining age 59-1/2.

Employee contributions, employer matching contributions, if any, and earnings thereon are invested as directed by the participants. The investment options include various mutual funds. Participants may change their investment options at will.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES:

Use of estimates-

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan's Administrator to make estimates and assumptions that affect the reported amounts of assets and net assets available for benefits at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

Valuation of investments-

Quoted market prices in active markets are used to value mutual fund and money market investments. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end.

Recognition of income and expenses-

The Plan records income and expenses on the accrual basis of accounting. In accordance with generally accepted accounting principles, benefits are recorded in the period paid. Purchases and sales of securities are recorded on a trade-date basis.

Net appreciation (depreciation) in fair value of investments represents the net increase in the fair value of investments sold during the year or held at year-end over (1) the fair value of investments held at the prior year-end, or (2) the cost of investments acquired during the current year.

Certain administrative costs of the Plan are borne by the sponsor. In addition, the sponsor may provide services to the Plan for which the sponsor receives no compensation. The costs borne by the Plan include investment advisory fees, third party administration and other direct and indirect administrative costs. These costs are presented net of revenue sharing and other arrangements.

Note 2 – continued:

Notes receivable from participants-

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant’s account and bear interest at the prime rate in effect at loan inception plus 2%. Principal and interest are paid through payroll deductions. Because of the adequate collateral at loan inception, no allowance for credit losses is required.

NOTE 3 - FAIR VALUE MEASUREMENTS:

Fair value is a market-based measurement determined based on assumptions that market participants would use in pricing an asset or liability. There are three levels, which prioritize the inputs used in measuring fair value as follows:

- Level 1: Observable market inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities.
- Level 2: Observable market inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3: Unobservable inputs where there is little or no market data, which require the reporting entity to develop its own assumptions.

NOTE 4 - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE:

The Plan's trustee is Fidelity Management Trust Company. The following information included in the accompanying financial statements and supplemental schedule of assets (held at end of year) was obtained from data that has been prepared and certified to as complete and accurate by the trustee:

1. Value of investments as of December 31, 2024 and 2023,
2. Investment income earned for the year ended December 31, 2024,
3. Notes receivable from participants as of December 31, 2024 and 2023, and,
4. Interest income on notes receivable from participants for the year ended December 31, 2024.

NOTE 5 - FEDERAL INCOME TAXES:

The Plan has adopted a volume submitter plan created by Fidelity. The Internal Revenue Service has determined and informed Fidelity by a letter dated June 30, 2020, that the Plan is acceptable under section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. Plan's management believes that the Plan is designed and currently being operated in compliance with the applicable IRC requirements. Therefore, the Plan's management believes that the Plan is qualified, and the related trust was tax exempt as of the financial statement date.

There are no Internal Revenue Service examinations in progress; years after 2021 remain open for examination. There are no uncertain tax positions that should be disclosed or accrued in the Plan's financial statements.

NOTE 6 - PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS:

Fidelity currently acts as trustee for investments of the Plan. In addition, Fidelity provides services, such as recordkeeping and preparation of Form 5500. Therefore, transactions with Fidelity qualify as party-in-interest transactions.

NOTE 8 - RECONCILIATION TO FORM 5500:

In accordance with U.S. GAAP, for financial reporting purposes, at each December 31, 2024, and 2023, the Plan accrued for contributions receivable for financial reporting purposes. Department of Labor regulations requires a reconciliation of amounts reported on the Form 5500 to the financial statements. The following is a reconciliation of net assets available for benefits as of December 31, 2024 and 2023, and the net increase in net assets available for benefits for the year ended December 31, 2024.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statement of net assets available for benefits.

NOTE 10 - SUBSEQUENT EVENTS:

Management has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.
