### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Chiquita/Fresh Express Savings and Investment Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

### 1. Plan Description

The following description of the Chiquita/Fresh Express Savings and Investment Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan available for participation by substantially all full-time and part-time domestic nonunion employees of Chiquita Brands International, Inc. (the Company or the Plan Sponsor) and its participating subsidiaries who have completed 60 days of service and have attained the age of 21. Eligible employees may enter the Plan on the first day of the month following or coincident with satisfaction of eligibility requirement. Although it is anticipated that the Plan will continue indefinitely, the Board of Directors of the Company can amend, suspend or terminate the Plan at any time, subject to the provisions of the Plan, the Internal Revenue Code of 1986, as amended, (the IRC) and the Employee Retirement Income Security Act of 1974, as amended (ERISA). In the event of Plan termination, active participants become 100% vested in their accounts.

The Plan Document was amended and restated effective January 1, 2016 to include all plan amendments since the last restatement in 2011, which included eliminating the Safe Harbor status of the Plan, changing the Company's basic matching contribution from a 100% match on up to 6% of compensation to a 50% match on up to 6% compensation, implementing a four-year vesting schedule on employer matching contributions, and eliminating the early retirement provision. The Plan was amended in February 2017 to provide for certain administrative changes in connection with a change in the Plan's record-keeper and in March 2021 to adopt the provisions of the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act). In addition, in 2020, the Plan adopted certain provisions in accordance with the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) for which the Plan has yet to be formally amended. The Plan will be formally amended by the applicable deadline to reflect these changes in accordance with amendment requirements of the CARES Act.

On November 25, 2024, the Plan was amended to adopt the Long-Term Part-Time (LTPT) Employees provision of the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act). LTPT employees are considered those employees who have three consecutive years of service after December 31, 2020, at least 500 Hours of Service in each year, and they have attained the same age as other Participants who are eligible to defer. The Plan will be formally amended by the applicable deadline to reflect these changes in accordance with amendment requirements of the SECURE Act.

The Plan appointed Empower Trust Company, LLC as trustee effective February 1, 2022. The Plan's record-keeper is Empower Retirement (Empower). Plan assets invested with Empower may be held and invested under a group annuity contract in Empower's general investment account.

#### *Participant Contributions*

Participants may elect to defer as a before-tax contribution and/or after-tax designated Roth contribution any whole percentage of their compensation, subject to the limitations, as defined in the Plan document, and subject to the non-discrimination standards of the IRC. A participant's compensation is reduced by the amount of before-tax contributions and/or designated Roth contributions, and those amounts are contributed to the Plan on the participant's behalf by the

Company. A participant's before-tax contributions and designated Roth contributions in any one year are also limited to a fixed dollar maximum (\$23,000 for 2024), as specified by the IRC. Participants aged 50 or older can make catch-up contributions if they contributed the maximum elective deferral under the Plan. A participant's catch-up contributions in any one year are limited to a fixed dollar maximum (\$7,500 for 2024), as specified by the IRC.

The Plan accepts rollover contributions (Rollovers) from other qualified plans and from certain individual retirement accounts. Rollovers are credited to a participant's rollover contributions account and are treated in a manner similar to before-tax contributions or after-tax designated Roth contributions for Plan accounting and federal income tax purposes. Rollovers are not eligible for Company matching contributions.

### ***Company Contributions***

The Company makes a basic matching contribution based on eligible participant contributions. The Company's matching contributions are subject to the non-discrimination standards of the IRC.

The basic matching contribution is 50% of a participant's before-tax contributions and/or after-tax designated Roth contributions up to 6% of compensation, as determined each payroll period. All Company matches are made in cash. Under the IRC, a participant's annual before-tax contributions, after-tax designated Roth contributions, and employer matching contributions for any calendar year cannot exceed the lesser of a fixed dollar amount (\$69,000 for 2024) or 50% of the participant's compensation for that calendar year.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and related matching contributions and Plan earnings. Participant accounts are also charged with withdrawals and an allocation of plan losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific requested participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are fully vested in their Employee Accounts and their non-elective contributions accounts. Basic matching contributions made by the Company for periods after January 1, 2016 and the related earnings become vested at a rate of 25% for each year of service to the Company. A participant becomes fully vested in his or her matching contributions account immediately at age 65 while still actively employed or when employment terminates as a result of retirement, death or disability.

### ***Notes Receivable from Participants***

The Plan has a loan feature under which active participants may borrow up to 50% of the value of their vested and non-forfeitable account balance (up to a maximum of \$50,000). The loan must bear interest at a rate reasonable at the time of application. The Company has established a fixed interest rate which is the prime rate plus 1%. Loans are repaid via payroll deduction over a period of not more than five years, except for loans used to purchase a primary residence, which may be repaid over a period of up to ten years. The participant may prepay the entire outstanding balance

of the loan at any time. Upon participant termination, retirement or death, the participant's vested account balance will be reduced by the remaining outstanding loan balance, and any portion of the outstanding loan balance that is not repaid is treated as a distribution to the participant if repayment is not made by the participant within 60 days after notification.

### ***Payment of Benefits***

A participant's account may be withdrawn only in limited circumstances, as permitted by the IRC and the Plan.

Upon termination of service, a participant may apply to receive a distribution of the vested portion of his or her account balance in a lump-sum amount or, if the vested portion is equal to or greater than \$5,000, leave the account balance in the Plan until age 65. If the participant's account is greater than \$1,000 and less than \$5,000, the participant may elect to receive distribution in a single lump-sum in cash and/or direct rollover to another qualified plan. If the participant does not specify an election, the payment will be automatically rolled over to an individual retirement plan designated by the Plan Sponsor. If the participant's account is \$1,000 or less, the participant will receive a lump-sum amount if the participant does not specify an election. In February 2024, the Plan was amended to increase the mandatory distribution limit from \$5,000 to \$7,000 and provide for in service distributions to terminally ill participants that satisfy specific requirements.

### ***Forfeitures***

The non-vested portions of a terminating participant's account are forfeited upon distribution and are used to pay plan expenses and reduce future Company contributions. There were approximately \$488,000 and \$484,000 cumulative forfeitures available to pay plan expenses and offset Company contributions at December 31, 2024 and 2023 respectively. During the year ended December 31, 2024, forfeitures used to pay plan expenses and/or offset Company contributions were approximately \$14,000.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value with the exception of the fully benefit-responsive investment contract. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Employee Benefits Committee determines the Plan's valuation policies utilizing information

provided by the investment advisers, custodians and insurance company. See Note 4 for further discussion of fair value measurements.

The Plan's fully benefit-responsive investment contract (see Note 5) is valued at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued and unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### ***Revenue Credits***

The Plan's trust agreement with Empower Retirement, LLC provides for a participant revenue credit arrangement, whereby the trustee allocates quarterly deposits into the accounts of eligible participants who are invested in certain funds or can be used to pay administrative expenses. Unallocated revenue credits at December 31, 2024 and 2023 are \$72,500 and \$145,000, respectively. During 2024, the Plan received credits of approximately \$72,500, which was used to pay administrative expenses. Revenue credits are presented in net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

## **3. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC, a qualified institution.

### 4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the assets or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in methodologies used at December 31, 2024 or 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts (PSAs)* - Pooled separate accounts are valued at the NAV of the units held. The NAV is based on the fair value of the underlying investments held by the PSA less its liabilities. The fair value of the underlying investments, which can consist of a single mutual fund or multiple securities, is determined using market quotations or prices obtained from independent pricing sources. The NAV, as provided by Empower Annuity Insurance Company is used as a practical expedient to estimate fair value. NAV would not be used if it was probable that the investment would not be traded at NAV. The PSAs provide for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to these investments. All but one of these are direct filing entities. The Capital Group EuroPacific Growth SA investment is not a direct filing entity. This investment aims to provide long-term growth of capital by investing in attractively valued companies in developed and emerging markets that are positioned to benefit

from innovation, economic growth, increasing consumer demand, or a turnaround in business conditions.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. Group Investment Contract

The Plan entered into a benefit-responsive investment contract with Empower through the MassMutual Diversified Separate Account Guaranteed Investment Contract (the SAGIC). Following the close of Empower Retirement's acquisition of MassMutual's retirement plan business on December 31, 2020, Empower Capital Management LLC (ECM) assumed the management of the SAGIC. Empower maintains the contributions in a separate account. The separate account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the SAGIC is fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the SAGIC. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants ordinarily may direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The average crediting interest rate is set quarterly. The SAGIC does not allow the crediting interest rate to fall below 0%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following:

1. Amendments to the Plan documents (including complete or partial Plan termination or merger with another plan).
2. Changes to the Plan's prohibition on competing investment options or deletions of equity wash provisions.
3. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary); that cause a significant withdrawal from the Plan.
4. The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

### **6. Related-Party Transactions and Party-in-Interest Transaction**

Certain Plan investments are in funds and accounts that are managed by Empower. Participant loan and distribution processing fees are paid to Empower by participants. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### **7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

### **8. Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated December 13, 2017, that the Plan and related trust were designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since the date of the determination letter, Plan management believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and continues to be tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

### 9. Delinquent Participant Contributions

During the Plan year ended December 31, 2023, participant contributions and loan repayments totaling approximately \$156,000 were not remitted to the Plan within the period prescribed by DOL regulations. These transactions constitute non-exempt party-in-interest transactions or prohibited transactions as defined by ERISA. The Employer is in the process of correcting these transactions. The related lost earnings are expected to be remitted to the Plan during 2025.

### 10. Risks And Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.
