**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Advanced Dermatology Associates, Ltd. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Advanced Dermatology Associates, Ltd. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

#### 1. Description of Plan:

The following description of the Advanced Dermatology Associates, Ltd. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution profit sharing 401(k) plan covering all employees of Advanced Dermatology Associates, Ltd. (the "Company" or "Employer") who have been with the company for 12 months, completed 1,000 hours of service within that period and have attained 18 years of age.

#### Participant Accounts

Each participant's account is credited with their contribution and an allocation of the Company's profit sharing and matching contributions, plan earnings, and forfeitures of non-vested accounts of terminated employees. Allocations are based on the employees' earnings or account balances, as defined in the plan agreement.

#### 401(k) Salary Reduction Contributions

Participants may contribute 1% to 100% of eligible compensation, up to limits defined by the Internal Revenue Code.

#### Employer Contributions

Non-Elective Safe Harbor – the employer may make a contribution to the account of each eligible participant in an amount equal to 3% of employees' compensation for the year. All such contributions are immediately 100% vested.

Discretionary Match – the employer may make a matching contribution. Matching contributions are allocated during the plan year to all participants who have salary reduction contributions during the period for which matching contributions are being made. In 2024 and 2023, the employer made matching contributions equal to 50% of each participant's salary reduction contribution up to a maximum of 6% of the participant's salary.

Discretionary Profit Sharing – an additional contribution may be made by the employer on a discretionary basis. These contributions are determined and allocated to participant accounts based on participants' compensation. The employer made discretionary profit sharing contributions based on a 3-tier employee group structure,

at a percentage of eligible employee compensation, ranging from 5.0%-10.3334% in 2024 and 5.0%-10.182% in 2023. Terminated employees do not receive a profit sharing contribution.

#### *Payment of Benefits and Withdrawals*

Benefits are payable upon retirement, disability, death or termination of employment in a lump-sum amount equal to the value of the participant's vested interest in his or her account. Benefits are recorded when payable.

The Plan allows participants to make withdrawals at normal retirement age, in-service withdrawals at age 59½, hardship withdrawals from profit sharing, matching contribution or salary reduction accounts, and withdrawals from rollover contributions accounts. There is no minimum amount for a withdrawal.

#### *Notes Receivable from Participants*

Loans to participants are permitted in an amount not to exceed the lesser of one-half of the participant's non-forfeitable interest under the Plan or \$50,000. The minimum loan amount is \$1,000. The loans are secured by the balance in the participant's account.

#### *Vesting*

Participants are vested immediately in their voluntary contributions and employer non-elective Safe Harbor contributions plus actual earnings thereon. Upon the termination of an employee prior to normal retirement date for reasons other than death or permanent and total disability, the portion of the employer discretionary profit sharing and matching contribution account that is vested is as follows:

Less than 2 years	0%

The vesting schedule is based on the number of full years of service which the employee has completed as of the date of termination.

#### ***Investment Options***

Upon enrollment in the Plan, a participant may direct contributions to various mutual funds, stable value fund or a participant self-directed account whereby the participant exercises investment control over those funds by appropriate direction to the Trustee. Participants may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account.

Participants may change their investment options at any time.

#### ***Forfeited Accounts***

Forfeited non-vested accounts totaled \$14,437 and \$7,756 at December 31, 2024 and 2023, respectively. Forfeitures of employer matching contributions are available first to reduce administrative expenses of the Plan with any remaining, as well as forfeitures of employer non-elective contributions, available to reduce future employer contributions to the Plan.

#### ***Expenses of the Plan***

Certain administrative expenses incurred in the operation of the Plan are paid directly by the Company and are not reflected in the accompanying financial statements. However, in 2024 and 2023, professional service fees in the amount of \$5,755 and \$32,423, respectively, were paid with Plan forfeited non-vested accounts.

Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in investment return.

### **2. Summary of Significant Accounting Policies:**

#### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrative committee determines the Plan's valuation policies utilizing information provided by the Investment Advisor and Custodian. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Investment return includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### ***Payment of Benefits***

Distributions to participants are recorded when payable.

#### ***Subsequent Events***

Management has evaluated subsequent events through October 10, 2025 the date on which the financial statements were available to be issued.

### **3. Investment Contract:**

The Plan offers a synthetic fully benefit-responsive investment, the Invesco Stable Value Trust III (the "Fund"), a common collective trust. The Fund is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The synthetic guaranteed investment contract, guaranteed by a group of financial institutions, is contractually obligated to repay the principal and insure that the interest crediting rate does not fall below zero.

As described in Note 2, because the Fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value reported to the Plan represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events may limit the ability of the Plan to transact at contract value with the issuer such as Plan termination or transfer to a successor fund.

The average yields earned were 3.05% in 2024 and 2.5% in 2023.

#### **4. Fair Value Measurements:**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820-10, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 inputs to the valuation methodology include:

- quoted prices for similar assets in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Investments classified within Level 3 whose fair value measurements consider several inputs may include Level 1 and/or Level 2 inputs as components of the overall fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common Stocks, Exchange-Traded and Closed-End Funds: Valued at the closing price reported on the active market on which the individual securities are traded.

Mutual and Money Market Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### 5. Tax Status:

The Plan has been restated as of January 1, 2022 as part of the IRS Cycle 3 restatement requirements. Effective January 1, 2022 the Plan is operating under a non-standardized pre-approved profit-sharing plan which obtained its latest opinion letter on June 30, 2020, addressed to Datair Employee Benefit System, Inc., the sponsor of the non-standardized pre-approved profit-sharing plan. The Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the Internal Revenue Service; however, there are currently no audits for any tax periods in progress.

#### 6. Information Certified by the Trustee:

The financial information included in the Plan financial statements, except for the self-directed investments and returns, contributions receivable, contributions, loans and distributions for withdrawals and terminations, has been derived from information certified as complete and accurate by Ascensus LLC, an affiliate of Ascensus Trust Company, the



