## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the  
Steet Toyota, Inc. 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Steet Toyota, Inc. 401(k) Plan, an employee benefit plan subject to the Employees Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Steet Toyota, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 10 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Steet Toyota, Inc. 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Steet Toyota, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - Description of Plan:

The following brief description of the Steet Toyota, Inc. (“Company”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

- A. General - The Plan is a defined contribution plan covering all eligible employees of the Steet Toyota, Inc. and certain affiliates (collectively the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.
- B. Eligibility – Employees become eligible for participation after completing one year of service consisting of 1,000 hours and attaining age twenty-one (21).
- C. Contributions – Participants may contribute up to 100% of pre-tax annual compensation to a maximum of \$23,000 for 2024. Participants who have attained age 50 before the end of the plan year may make “catch-up” contributions of up to \$7,500. Participants may also make “rollover” contributions from other qualified plans.

The Company elected to make a “safe harbor” contribution equal to 3% of eligible employees’ compensation. The Company may also make a profit-sharing contribution at the Company’s discretion based on employee classes. For the year ended December 31, 2024 and 2023 safe harbor contributions were approximately \$555,000 and \$540,000, respectively. The Company’s profit-sharing contribution was approximately \$40,000 for all years presented.

- D. Participant Accounts - Each participant's separate account is credited with the participant's contribution, their share of Company’s contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan, see Note 2 (F). Participants direct investment of their account into various investment options selected by the Plan's administration. The benefits to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- E. Vesting - Participants are immediately 100% vested in their contributions, employer safe harbor contributions and actual earnings thereon.

Company discretionary profit-sharing contributions and earnings thereon are vested 20% per year starting after the employee completes two years of service and becomes 100% vested after six years of service (six year graded schedule). A participant’s account balance also becomes 100% vested upon reaching normal retirement age, or in the event of death or disability while employed with the Company.

- F. Payment of Benefits - Upon termination of service due to death, disability, or retirement, a participant (or their beneficiaries) will receive a lump sum distribution as soon as administratively feasible following the date on which a distribution is requested or otherwise payable.
- G. Withdrawals - The Plan allows for financial hardship withdrawals for uninsured medical expenses, tuition payments, purchase of a primary residence or prevention of eviction or foreclosure on a primary residence. The Plan also allows for in-service withdrawals to participants attaining age 59 1/2.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)DECEMBER 31, 2024NOTE 1 - Description of Plan (Continued):

- H. Forfeited Accounts - Forfeited nonvested accounts will be used to reduce future Company contributions. Amounts used to reduce the Company's contributions were immaterial for all years presented.
- I. Participant Loans - Participants may borrow (only one loan outstanding at a time) a minimum of \$1,000 up to a maximum of 50% of their vested account balance (not to exceed \$50,000). Repayments are to the participant's account over a period not to exceed 60 months at an interest rate of prime plus 2% fixed at the date of the loan.

NOTE 2 - Summary of Significant Accounting Policies:A. Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles.

B. Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Administrator to make certain estimates and assumptions that affect reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

D. Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments sold during the year as well as the unrealized gains and losses on investments held at year end.

E. Payments of Benefits

Benefit payments to participants are recorded when paid.

F. Expenses

Certain expenses of maintaining the Plan are paid by the Plan. Expenses that are paid by the Company, such as audit fees are excluded from these financial statements. Loan initiation and distribution fees are charged directly to participant accounts.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)DECEMBER 31, 2024NOTE 2 - Summary of Significant Accounting Policies (Continued):G. Date of Management's Review of Subsequent Events

Subsequent events were evaluated through October 13, 2025 the date the financial statements were available to be issued. There were no subsequent events requiring recording or disclosure in the financial statements.

NOTE 3 - Fair Value Measurement:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy give the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are describe as follows:

- Level 1 - Input consist of unadjusted quoted prices in active markets for identical assets that the Plan has the ability to access.
- Level 2 - Inputs consist of quoted prices for similar assets in active markets; quoted prices for identical or similar assets in inactive markets; inputs other than quoted prices that are observable for assets.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

- Level 3 - Inputs to the valuation methodology are unobservable inputs and significant to the fair value measurement.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan will maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used:

Mutual Funds: Are valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1 inputs).

Pooled Separate Accounts: Are based upon the accumulation unit value, which is a combination of the fund's net asset value and separate account charges held by the Plan at year end. These assets are deemed to be Level 2 inputs.

Annuity Options: Are reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider. These assets are deemed to be Level 2 inputs.

NOTE 4 - Tax Status:

The Internal Revenue Service (IRS) has determined that the Pre-Approved Prototype Plan by letter, dated June 30, 2020 is designed in accordance with the applicable section of the Internal Revenue Code (IRC). Although the Plan has been amended and restated since receiving the determination letter, the Plan administrator believes that the Plan, including all amendments, are currently designed and being operating in compliance with the applicable IRC and therefore believe that the Plan qualifies as tax-exempt.

The tax status of the Plan is subject to audit. Generally, years after January 1, 2022 are open to audit.

NOTE 5 - Inactive Accounts:

Accounts of participants who have withdrawn from participation in the Plan but for whom distribution from the Plan have not been made, totaled approximately \$970,000 and \$590,000 at December 31, 2024 and 2023, respectively.

NOTE 6 - Plan Termination:

Although the Company has not expressed any intent to do so, it has the right under the Plan to terminate it at any time, subject to the provisions of ERISA. In the event of termination participants will become 100% vested in their accounts.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)DECEMBER 31, 2024NOTE 7 - Related-Party and Party-In-Interest Transactions:

Certain Plan investments are shares of mutual funds, pooled separate accounts and a fixed annuity contract managed by Empower Retirement. Empower Retirement is the Trustee of the Plan and, therefore, these qualify as party-in-interest transactions. In addition, the Plan issues notes receivable to participants, which are secured by the balances in the participant's accounts. Therefore, these transactions qualify as party-in-interest transactions. The plan uses Osaic Wealth, Inc. and Actuarial Pension Analysts, Inc. as investment advisors and third-party administrators for the Plan. The fees paid by the Plan to these parties qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 8 - Risks, Uncertainties and Concentrations:

The Plan's investments are exposed to various risks such as interest rate, credit, and overall market risk. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and possible that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan's assets, although diversified through investment in several different investments, are all held by a single custodian, Empower Retirement. The Plan is dependent on that Custodian for the safeguarding of its assets.

NOTE 9 - Legal Proceedings/Contingencies:

The Plan may engage legal counsel to defend it against potential litigation matters whether asserted or anticipated as the Plan's management judges necessary in the circumstances. The Plan does not believe that there are any current actions that are either not covered by insurance or would have a material effect on its financial condition.

NOTE 10 - Financial Information Certified by Custodian:

Certain information related to investments and notes receivables from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest, dividends, and interest income on notes receivables from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC, the Plan's trustee and custodian.

NOTE 11 - Prohibited Transactions:

During 2024, the Plan sponsor failed to remit to the Plan's custodian certain employee contributions and participant loan repayments totaling approximately \$14,500 within the period prescribed by ERISA. Delays in remitting the payments were due to administrative errors and the Plan sponsor has made all late contributions, loan repayments and lost earnings to the Plan.
