### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investments information, as described in Note 8 to the financial statements, is complete and accurate.

## **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the California Water Service Company Health Care Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about California Water Service Company Health Care Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we –

- Exercise professional judgement and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures on the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in circumstances, but not for the purpose of expressing an opinion on the effectiveness of the California Water Service Company Health Care Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by the management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgement, there are conditions or events, considered in the aggregate, that raise substantial doubt about the California Water Service Company Health Care Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Other Matters – Supplemental Schedules Required by ERISA**

The supplemental schedules of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, and Schedule H, Line 4j – Schedule of Reportable Transactions for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion –

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respect, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to the assets held by and are certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**1. DESCRIPTION OF PLAN AND SIGNIFICANT ACCOUNTING POLICIES**

The following description of the California Water Service Company Health Care Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** – The Plan is a health and welfare plan adopted by the Board of Directors of California Water Service Company (the Company). The original effective date of the Plan is February 1, 1972. The Plan provides medical, dental, and vision coverage for eligible employees of the Company, eligible retirees, and their dependents. The Plan is designed to comply with the applicable requirements of the Internal Revenue Code (the Code), as amended, and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Employees become eligible for participation the first of the month following date of hire with a minimum of 20 hours per week of work. Retirees are eligible for participation if (a) has completed five years of service after attaining age 35; (b) on or before December 31, 1993, has attained age 60 or who on or after January 1, 1994, has attained age 58; (c) has begun receiving benefits from the Company's pension plan on or after the person's retirement date and is no longer an employee; and (d) is covered under Part B of Medicare, is eligible as of the latest to occur of (a), (b), or (c). The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Effective January 1, 2025, the Plan was amended to clarify the eligibility requirements for retirees. Retirees are eligible for participation if (a) has completed five years of service after attaining age 35; (b) on or before December 31, 1993, has attained age 60 or who on or after January 1, 1994, has attained age 58; (c) is no longer an employee and is eligible to receive retirement benefits from the Company's pension plan on or after the retiree's retirement date; and (d) once Medicare eligible, is covered under Part B of Medicare, is eligible as of the latest to occur of (a), (b), or (c).

Certain Plan assets are held in a Voluntary Employee Beneficiary Association (VEBA) trust. The accounts are at all times subject to the condition that the assets are held for the exclusive purpose of providing benefits to the participants in the Plan and their beneficiaries.

**Administration** – The Company has appointed the Employee Benefit Finance Committee (the Committee) to oversee and manage the operation and administration of the Plan. Medical, dental, and vision claims are processed and paid by third party administrators. The Company reimburses the third-party administrators for paid employee claims from Company assets. The third-party administrators are reimbursed for paid retiree claims from the assets of the Plan. U.S. Bank, N.A. (U.S. Bank) acts as trustee for the 401(h) and VEBA accounts. Non-interest bearing accounts of the Plan also reside with U.S. Bank. The Committee has engaged Mercer

to invest Plan assets in accordance with the Plan's investment policy and the Committee's directives.

**401(h) account** – The Plan includes a medical-benefit component to fund a portion of the postretirement obligation for retirees and their beneficiaries in accordance with Section 401(h) of the Code. A separate account has been established and maintained in the California Water Service Company Pension Plan (the Pension Plan) for such contributions. In accordance with Section 401(h) of the Code, the Plan's investments in the 401(h) account may not be used for or diverted to, any purpose other than providing health benefit for retirees and their beneficiaries. The related obligations for health benefits are not included in the Pension Plan's obligations in the statement of accumulated plan benefits, but are reported as obligations in the financial statements of the Plan.

**Basis of accounting** – The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

**Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, claims incurred but not reported, eligibility credits, claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition** – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 2 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought or sold as well as held during the year.

**Payment of benefits** – Premiums paid by either the Company or the VEBA trust are recorded as insurance premium payments in the accompanying statement of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processors. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of net assets available for benefits.

**Stop loss** – Premiums for stop loss insurance are included in insurance premium payments in the accompanying statement of changes in net assets available for benefits. Stop loss refunds

totaling \$4,451,177 have been netted with benefits paid in the accompanying statement of changes in net assets for the year ended December 31, 2024.

**Refunds** – Refunds due from the Plan’s pharmacy benefit manager are recorded when earned. Refunds due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates totaling \$2,592,824 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

**Medicare subsidy** – The Plan’s postretirement benefit obligation does not reflect an amount associated with the Medicare subsidy allowed under the Medicare Prescription Drug Improvement Act of 2003 because the Plan is not directly entitled to the Medicare subsidy. The Company has included the effects of the Medicare subsidy in measuring its postretirement benefit obligation; therefore, the Plan’s postretirement benefit obligation differs from that of the Company.

**Administrative expenses** – The Plan pays administrative expenses that consist primarily of administrative fees paid for bank service charges. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as fees paid to third party administrators, actuary, the trustee and professional fees, are paid by the Company on behalf of the Plan.

**Risks and Uncertainties** – The value of the postretirement benefit obligation of the Plan require significant management assumptions as described in Note 6. Future actual experience may be different from the assumptions used to arrive at the postretirement benefit obligation.

**Concentrations of Credit Risk** – The Plan’s concentration of credit risk primarily relates to non-interest bearing and interest-bearing cash balances on deposit with a financial institution that are greater than \$250,000. The plan sponsor regularly evaluates such exposure and believes that potential loss, if any, is not material to the financial statements.

**Income taxes** – The Plan has received a tax exemption letter dated December 22, 2017, from the Internal Revenue Service (IRS) for recognition of tax-exempt status as a Voluntary Employee Beneficiary Association (VEBA) under Code Section 501(a)(9). The Company believes that the Plan is operated in accordance with, and qualifies under, the applicable requirements of the Code and related state statutes, and that the trusts, which form a part of the Plan, are exempt from federal income and state franchise taxes.

In accordance with guidance on accounting for uncertainty in income taxes (ASC 740-10), management evaluated the Plan’s tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any

tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

**Subsequent events** – The Plan has evaluated subsequent events through September 26, 2025, which is the date the financial statements were available to be issued.

## **2. FAIR VALUE MEASUREMENTS**

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standard are described below:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted market prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

**Interest-bearing cash:** Valued at the deposited amounts plus accrued interest.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual fund that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common-collective trusts:** Valued at NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by each trust less its liabilities. The practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported NAV.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan had investments in a common-collective trust as of December 31, 2024 and 2023. The common-collective trust files a Form 5500, Annual Return/Report of Employee Benefit Plan, with the U.S. Department of Labor as a direct filing entity. Accordingly, certain disclosure requirements under FASB ASU 2015-12 with respect to investment strategies for investments measured using the net asset value practical expedient are not required in this report. Transactions in the common-collective trust may occur daily. If the Plan initiates a full redemption of the common-collective trust, the trust reserves the right to delay such redemptions in extraordinary market circumstances in order to ensure that securities liquidations will be carried out in an orderly business manner. Otherwise, the full redemption is not subject to a wait period.

The fair value hierarchy of the investments in the 401(h) account are provided in the financial statements of the California Water Service Company Pension Plan.

**3. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

U.S. Bank is the trustee for the Plan's investments in the VEBA trusts and 401(h) account. The Committee has engaged Mercer as its outsourced chief investment officer with discretion to invest Plan assets in accordance with the Plan's investment policy and the Committee's directives. Any purchases and sales of CCTs are conducted at the NAV of the CCTs. Any purchases and sales of mutual funds are performed in the open market at fair value. As described in Note 1, the Plan also has several arrangements with service providers, and these transactions are considered party in interest transactions under ERISA. Such transactions, while considered party in interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party in interest transactions under ERISA.

**4. SELF-INSURED HEALTH CARE BENEFITS**

**Benefits** – The Plan provides for reimbursement of certain medical, prescription drug, dental, and vision expenses incurred by employees, their eligible dependents, and retirees.

When a retiree becomes eligible for Medicare (at age 65, or sooner if due to disability), the Plan assumes that Medicare is the primary medical payer and the Plan is the secondary payer for members enrolled in Medicare supplemental or Medicare Coordination plans for the purpose of processing claims.

The Plan reduces premiums used to calculate retiree contributions by the amount of the Medicare Part D subsidy the Company expects to receive, net of any additional costs the Company expects to incur as a result of receiving the Medicare Part D subsidy.

**Stop loss coverage** – The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

**Participation** – The Plan covers all active employees of the Company in the United States who are on the United States payroll and their eligible dependents. The Plan also covers employees retiring at age 58 or later and qualified dependents.

**Employer and participant contributions** – The aggregate amount of contributions to the Plan is comprised of a participant portion, referred to in the Plan document as the Health Care Plan Premium, as well as employer contribution amounts. The statement of changes in net assets reflects the split of these two components for financial statement reporting purposes. The Plan provides for the employee portion to be made in the form of pre-tax or post-tax payroll withholdings, as elected by the employee. Required payroll withholdings from employees are reviewed and subject to change by the Company. Retiree participants pay monthly contributions to the Company to receive coverage under the Plan. Retirees are charged different monthly premiums depending on whether the Plan is primary or secondary coverage. Retiree premiums are usually set to cover 50% of projected retiree expenses in the upcoming year in each group. Monthly contributions at the end of 2024 for full coverage were \$579 for retirees without other coverage and \$226 for retirees with other coverage. Monthly contributions at the end of 2024 for employee single coverage were \$182 for medical and \$12 for dental and vision. Monthly contributions for Hawaii employee single coverage at the end of 2024 were \$56 for medical and \$12 for dental and vision.

Employer contributions are made to the Plan to fund the benefits of the Plan for eligible employees and their dependents as reduced by employee contributions. Such employer contributions are not deposited in the trust but are paid directly to providers for related claims paid by the Plan. Employer contributions also consist of contributions made to the Plan's VEBA trusts, as determined by the Plan's actuary to fund future benefit obligations.

## **5. OTHER BENEFITS**

The Plan also offers California employees and retirees an alternative health care coverage option provided by a Health Maintenance Organization (HMO). Hawaii employees and retirees are given the option of a local insurance plan or an HMO for health care coverage. The Company contracts with the health care coverage providers and pays the group insurance premiums, thereby providing benefits under the Plan. Services are provided by the HMO or participating health care providers in the Hawaii insurance plan. Employees and retirees can change their health care coverage option annually.

over time and these changes could have a material impact on the Plan's financial statements. Current claims payable and claims incurred but not reported are included in the postretirement benefit obligations reported above, and are estimated at \$2,567,000 and \$3,059,000 at December 31, 2024 and 2023, respectively. The change in current claims payable and claims incurred but not reported from December 31, 2023, to December 31, 2024, is a decrease of \$492,000.

**Postretirement benefit obligations** – Postretirement benefit obligations are based on actuarial assumptions that are subject to change over time and could have a material impact on the Plan's, amounts reported in the accompanying financial statements. If the assumed health care cost trends increased by one percentage point, the benefit obligations as of December 31, 2024 and 2023, would increase by \$23,598,279 and \$26,145,426 respectively.

The postretirement benefit obligations represent the actuarial present value of those estimated future benefits that are attributed to employees' service rendered to the date of the financial statements reduced by the actuarial present value of contributions expected to be received in the future from current Plan participants. Postretirement benefits include future benefits expected to be paid on behalf of: (1) currently retired employees and their covered spouses/domestic partners and (2) active employees and their covered spouses/domestic partners after retirement from service with the Company and certain related entities. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date. The postretirement benefit obligations represent the amount that is to be funded by contributions from the Plan sponsor (Note 1) and from the existing Plan assets.

The actuary determines the actuarial present value of the postretirement benefit obligations by applying actuarial assumptions to historical premium cost data to estimate future annual premiums per participant, discounted for the time value of money, and the probability of payment between the valuation date and the expected date of payment.

In December 2003, the Medicare Modernization Act was signed into law for employers that sponsor postretirement health care plans that provide prescription drug benefits. The Plan's postretirement benefit obligation does not reflect any amount associated with the Medicare Part D subsidy because the Plan is not directly entitled to the subsidy. The Company's accumulated postretirement health benefit obligation differs from that of the Plan because the Company has included the effects of the Medicare Part D subsidy of approximately \$9,615,423 and \$9,566,355 in measuring its obligation at December 31, 2024 and 2023, respectively.

**8. CERTIFIED INFORMATION**

All investment information disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and interest and dividends for the year ended December 31, 2024, including information related to the 401(h) account (see Notes 1 and 7), was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by U.S. Bank in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**9. PLAN TERMINATION OR MODIFICATION**

The Company intends to continue the Plan indefinitely for the benefit of its employees; however, it reserves the right to terminate or modify the Plan at any time by resolution of its Board of Directors and subject to the provisions of ERISA. Any remaining undistributed funds are to be used for the benefit of covered individuals. In the event that benefits due and payable exceed available funds, the Company will contribute to the Plan such amounts as may be necessary to ensure continuance of such benefit payments.

**10. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
