SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT FOR THE 2024 FINANCIAL STATEMENTS

We have performed an audit of the accompanying financial statements of Autism Delaware Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Autism Delaware Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE A - DESCRIPTION OF PLAN

The following description of the Autism Delaware Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering substantially all full-time and part-time employees of Autism Delaware Inc. that have completed three months of service.

Contributions – Participants may contribute up to 100% of eligible compensation, as defined in the Plan document, up to such dollar limit established by the Internal Revenue Service. Participants may designate all or a portion of their deferral contributions as after-tax contribution into a Roth account. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participant contributions are recorded in the period in which the Company makes payroll deductions from the participant's earnings. The Plan permits participants to contribute amounts representing distributions from other defined benefit or defined contributions plans ("rollover contributions"). The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan with Roth contributions unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatically enrolled participants will have their deferral rate increase by 1% annually until their deferral rate reaches 10%. The Company contributes 100% of the first 3% of base compensation that a participant contributes to the Plan. Additional non-elective amounts may be contributed at the option of the Company. For the year ended December 31, 2024, there were no profit sharing contributions to the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant Accounts – Each participant's account is credited with the participant's contribution, the Company's match, profit sharing contribution and Plan earnings. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. Participants direct the investment of their accounts among various investment options offered by the Plan.

Vesting – Participants are vested immediately in their contributions plus actual earnings or losses thereon. Vesting in the Company's contributions plus actual earnings or losses thereon is based on years of credited service. A participant becomes 25% vested after the completion of one year of credited service, and continues to vest in increments of 25% and 50% until becoming 100% vested after 3 years.

Notes Receivable From Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Participants cannot have more than three loans outstanding. The notes are secured by the balance in the participant's account and bear a fixed rate of interest at rates which are commensurate with local prevailing rates at the time the loan is originated. All loans must have a definite repayment schedule, which provides for principal and interest payments to be made ratably through payroll deductions over a period not to exceed five years, except for home loans that may be repaid over a reasonable period of time that may exceed five years. Notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. At December 31, 2024 and 2023, the interest rate of the participant notes was 4.25%.

NOTE A - DESCRIPTION OF PLAN - CONTINUED

Payment Of Benefits – Payments of benefits are permitted in various methods depending upon whether the request for payment results from retirement, death, an event of disability or termination. The Plan administrator may allow distribution of 100% of the participant's contributions and vested portion of employer contributions other than safe harbor matching contributions in cases of hardship. Balances less than \$1,000 may be paid in lump-sum distributions, without requiring participant approval. The Plan also allows in-service distributions for eligible participants.

Forfeited Accounts – Forfeitures result from non-vested Company contributions remaining in the Plan from terminated employees. At December 31, 2024 and 2023, the balance of unallocated forfeited non-vested accounts totaled \$47,517 and \$14,368, respectively. During 2024, no forfeitures were used to reduce Company contributions or pay Plan expenses.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis Of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation And Income Recognition – Investments in registered investment companies are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment Of Benefits – Benefits are recorded when paid.

Notes Receivable From Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Plan Expenses – Certain expenses of maintaining the Plan are paid directly by the Plan sponsor. Expenses that are paid by the Plan sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions from the Plan are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Use Of Estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Subsequent Events – The Plan evaluates the events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through October 9, 2025, the date the financial statements were available to be issued.

NOTE C - CERTIFIED ASSETS

All information on investments and notes receivable from participants included in the accompanying financial statements and supplemental schedules was obtained or derived from information certified as complete and accurate by the custodian Capital Bank and Trust Company as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

NOTE D - FAIR VALUE MEASUREMENTS

The Plan applies generally accepted accounting principles to establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under generally accepted accounting principles are described as follows:

- Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 – inputs to the valuation methodology include quoted prices for identical or similar assets and liabilities in active or inactive markets; inputs that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument’s categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. The Plan had no level 2 or 3 investments in 2024 or 2023.

Money Market Funds - Valued at the quoted net asset value of shares held by the Plan at year-end.

Registered Investment Companies (Mutual Funds) – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE E - PARTY-IN-INTEREST TRANSACTIONS

Certain investments are managed by the custodian, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the plan for the investment management services are included in appreciation in the fair value of the investments.

Certain participants of the Plan have outstanding loans with the Plan at December 31, 2024 and 2023. These loans are considered party-in-interest transactions according to the Department of Labor guidelines. Total outstanding loans as of December 31, 2024 and 2023 were \$1,616 and \$2,273, respectively.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balances.

NOTE G - TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

NOTE H - RISKS AND UNCERTANTIES

The Plan's investments include financial instruments which are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of financial instruments will occur in the near term that could materially affect the participants' account balances and the amounts reported in the accompanying financial statements.

NOTE I - PROHIBITED TRANSACTIONS

Participant contributions of \$29 were withheld from a participant's pay during 2024, but were not remitted to the Plan's trust in a timely fashion. This constituted a loan from the Plan to the Plan Sponsor. The delinquent participant contributions and lost earnings were funded to the Plan during 2025.
