Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. - Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1—Description of the Plan

The following is a summary of Orthopaedic Solutions Management 401(k) Plan (the “Plan”) and provides major Plan provisions. Participants should refer to the Plan document for more complete information.

General Name Change and Change in Plan Sponsor – The Plan was established on January 1, 1992, by Musculoskeletal Institute, Chartered d/b/a Florida Orthopaedic Institute (“MI”) as a defined contribution plan by the name of the Florida Orthopaedic Institute 401(k) Plan. Effective April 2023, the Plan’s name was changed to Orthopaedic Solutions Management 401(k) Plan and the Plan sponsor was changed to Orthopaedic Solutions management, LLC (the “Company” or “Plan Administrator”) including affiliates employers, MI, Florida Orthopaedic Institute Surgery Center, LLC (“FOISC”) and Tallahassee Orthopedic Clinic III, P.L. (“TOC”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Participation – All employees of the Company and related employers, MI, FOISC and TOC, who have attained the age of 21 and have completed 90 days of service are eligible to participate in the Plan. Eligible employees are automatically enrolled in the Plan at a 3% contribution rate unless they notify Plan management that they do not wish to participate in the Plan.

Contributions – Participants are permitted to make pre-tax salary contributions and after-tax contributions to the Plan, not to exceed certain annual compensation limitations, as permitted by the Internal Revenue Code (“IRC”). For each participant who has elected to have a percentage of their compensation deferred to the Plan as an elective contribution, the Plan Administrator automatically increases the participant’s elective contribution by 1% of compensation annually each April until the participant’s elective contribution rate equals 15% of compensation, unless otherwise elected by the participant pursuant to procedures and limitations established by the Plan Administrator. The Plan also allows for pre-tax and after-tax rollover contributions into the Plan from other qualified plans. Employer contributions are based upon amounts authorized by the Board of Directors of the Company. The Company may, at its discretion, make a matching contribution equal to 100% of the participant’s contributions up to 3% of the participant’s compensation. Participants are eligible to receive matching contributions if they have completed 90 days of service and are employed on December 31 when matching contributions are credited to participant accounts. There were no matching contributions during the year ended December 31, 2024.

The Company may also, at its discretion, make profit-sharing contributions which are allocated to participants based upon established employee groupings and specified limitations for such groups. Participants are eligible to receive profit-sharing contributions if they have completed one year of service, as defined, and are employed on December 31. During the year ended December 31, 2024, the Company committed to fund profit-sharing contributions of 3% of each participant’s compensation for non-shareholder employees and certain fixed amounts for shareholder employees. These profit-sharing contributions totaled approximately \$5,831,000 for the year ended December 31, 2024, net of a portion of which was funded through the use of forfeitures. The balance is recorded as employer contributions receivable in the accompanying 2024 statement of net assets available for benefits.

Participants’ Accounts – Each participant’s account is credited or charged with the participant’s contributions and withdrawals and an allocation of Plan earnings and losses, employer contributions, and administrative expenses not paid by the Company. Plan earnings and administrative expenses are allocated to participant accounts based on relative participant account balances.

Forfeitures – Forfeitures are used to reduce employer contributions. At December 31, 2024 and 2023, there were approximately \$348,000 and \$165,000 of forfeitures available to reduce employer contributions, respectively. Approximately \$62,000 of forfeitures available at December 31, 2024 were used to reduce the 2024 employer profit-sharing contributions funded to the Plan during 2024.

Note 1— Description of the Plan (continued)

Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employer-matching and profit-sharing contributions plus actual earnings thereon is based on years of continuous service as defined by the Plan. Vesting is determined according to the following schedule:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 2 years of service	0%
2 years but less than 3 years	20%
3 years but less than 4 years	40%
4 years but less than 5 years	60%
5 years but less than 6 years	80%
6 years or more	100%

Notes Receivable from Participants – Participants may borrow from their individual accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator at the time the note is approved (interest rates of 4.25% to 9.50% as of December 31, 2024). Principal and interest are collected ratably through payroll deductions. Note terms may range from 1 to 10 years or up to 15 years for the purchase of a primary residence.

Payment of Benefits – Upon termination of service due to death, disability, or retirement at the participant's normal retirement date, as defined, a participant or his/her estate may elect to receive an amount equal to the value of the participant's interest in his or her account in either a lump-sum amount or in annual annuity installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or in the form of a direct transfer to an individual retirement account or any qualified plan described in Section 401(a) of the IRC.

Note 2—Summary of significant accounting policies

Basis of Presentation – The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Contribution Receivable – The amounts of participant-related contributions that have been deducted from the participant's payroll as of the end of the year but have not been deposited with the Plan until after the end of the year is reflected as participant contributions receivable in the Plan's financial statements. In addition, any contributions due and payable by the Company are reflected as Company contributions receivable in the Plan's financial statements.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Administrative Expenses – As provided by the Plan Agreement, administrative expenses related to Plan investments and administration are paid by the Plan, and other administrative expenses are paid by the Company.

Note 2—Summary of significant accounting policies (continued)

Investments, Investment Valuation, and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value determinations are made based upon a hierarchy that prioritizes the inputs to valuation techniques. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Three levels of inputs may be used to measure fair value:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodology used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Mutual Funds – These investments are public investment vehicles valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies, or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefits Paid to Participants – Benefits are recorded when processed and paid by the Plan.

Note 3—Information provided and certified by the qualified institution (unaudited)

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, T. Rowe Price Trust Company (the “qualified institution” of the “Plan”) has certified to the completeness and accuracy of the following data included in the accompanying financial statements as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

Investments, at fair value, and notes receivable from participants as of December 31, 2024 and 2023 as shown in the statements of net assets available for benefits.

Net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 5—Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6—Income tax status

The Plan obtained its latest determination letter dated June 30, 2020, in which the Internal Revenue Service (“IRS”) stated the Plan, as designed, is in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7—Party-in-interest transactions

Certain Plan investments are investments in mutual funds managed by T. Rowe Price Associates, Inc. (the parent company of the qualified institution). Therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid during the year for accounting and other services rendered by parties-in-interest were based on customary and reasonable rates for such services.

Note 8—Risks and uncertainties

The Plan provides for various investment options in investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

As the values of the Plan’s individual investments have and will fluctuate in response to changing market conditions, the amount of potential losses that will be recognized in subsequent periods, if any, cannot be determined.

Note 9—Subsequent events

In accordance with U.S. GAAP related to subsequent events, the Plan has evaluated all events subsequent through October 7, 2025, the date these financial statements were available to be issued.
