INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee and participants of the
Cardlytics 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Cardlytics 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. - Conclude whether, in our judgement, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedules, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 and Schedule H, Line 4a – Schedule of Delinquent Participant Contributions for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules

that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the certified investment information in the supplemental schedules agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of Plan

The following description of the Cardlytics 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Cardlytics Inc. and adopting affiliate employers (collectively, the Company or Plan Sponsor). All full-time employees not covered by collective bargaining (union) or non-resident aliens are eligible upon hire. Temporary employees must complete 1,000 hours of service during the Plan year to become eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may make pre-tax and/or Roth contributions of up to 100% of eligible compensation as defined by the Plan document, not to exceed a maximum of \$23,000, plus an additional \$7,500 catch-up deferral for participants over age 50, in 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan allows participants to make after-tax contributions. In 2024, a participant may have total contributions to the Plan in the amount of \$69,000, or \$76,500 including catch-up contributions. Participants are automatically enrolled in the Plan, with a default pre-tax deferral percentage of 5%, unless the participant elects otherwise. No automatic escalation of the deferral percentage is applicable to the Plan.

The Company provides a discretionary matching contribution of 50% of the first 5% of eligible compensation, not to exceed total participant contributions made every payroll period. The Company may also make discretionary non-elective contributions to the Plan. A participant must be employed on the last day of the Plan year to receive the Company discretionary non-elective contributions. If a participant terminated before the last day of the Plan year, they are eligible to receive Company discretionary non-elective contributions if termination was due to death or disability. There were no Company discretionary non-elective contributions made in 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Company contributions, and earnings and losses on the investments in their account, and is charged with certain administrative expenses. Participants direct the investment of their account into various investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their participant contributions, including rollovers and transfers, plus actual earnings thereon. Participants vest 25% per year beginning after 1 year of service and are fully vested after 4 years of service in the Company discretionary matching contributions and discretionary non-elective contributions. Participants receive credit for a year of service based on the elapsed time method. Participants who were employed before August 1, 2021 will receive vesting credit for years of service based on the following:

*Participants receive vesting credit for this period if they were to receive such credit under either the general method (hours of service) or the elapsed time method.

Notes Receivable from Participants

Notes receivable from participants are not permitted for the Plan. Notes receivable from participants transferred from another retirement plan are to be paid off through periodic payroll deductions. The repayment period for notes transferred into the Plan ranged from 1 to 15 years. The notes receivable from participants also qualify as party-in-interest transactions. All participants with notes had terminated prior to 2024. As such, the notes do not accrue interest within the Plan.

Payment of Benefits

At the time of death, disability, termination of service, or retirement, the participant or their beneficiary may receive payment of the vested interest in their account in the form of a lump-sum, partial withdrawal, or installment distribution. The participant's contributions may also be withdrawn for certain hardship situations. Participants may withdraw the vested interest in their account upon attainment of age 59½. Participants with vested account balances of \$7,000 or less will receive distributions as soon as administratively feasible. If the participant's vested account balance is between \$1,000 and \$7,000, the vested balance will be automatically rolled into an individual retirement account (IRA) or annuity on the participant's behalf. Participants with vested account balances of \$1,000 or less will receive a lump-sum distribution unless the participant elects the distribution be rolled over into a different IRA account on their behalf.

Administrative Expenses

Certain administrative expenses of the Plan may be allocated to participants pro rata based on participant balances or paid through forfeitures. Certain transaction fees for withdrawals are charged directly to the respective participant. Certain administrative expenses are permitted to

be paid by the Plan in accordance with the Plan's provisions. Fees paid to service providers of the Plan qualify as party-in-interest transactions. The Company pays all other administrative expenses of the Plan. The Company does not expect reimbursement from the Plan for these expenses.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$6,352 and \$527,823, respectively. These accounts may be used to reduce Company contributions or to pay Plan administrative expenses. During 2024, the Plan used \$674,230 of forfeitures to reduce Company contributions and \$2,951 to pay administrative expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates, and such differences may be material to the financial statements.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Company's discretionary matching contribution is considered payable to the Plan when the related participant's contributions are payable to the Plan. Company discretionary non-elective contributions are considered payable to the Plan after approval by the Administrative Committee. Any unfunded participant or Company contributions are included in the participants or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

In accordance with Financial Accounting Standards Board Accounting Standards Codification 326, *Financial Instruments—Credit Losses*, the Company estimates the current credit risk associated with the employer contribution receivables. After giving consideration to the risk characteristics, including historical payment experience, the Company determined that no allowance for credit loss was necessary and there was no current year activity in the allowance for credit losses as of and for the years ended December 31, 2024 and 2023.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion on fair value measurements.

Net change in fair value of investments includes interest, dividends, realized and unrealized gains and losses on those investments, and fees charged for investment management and administrative services on those investments.

Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedule of assets (held at end of year), including investments held and notes receivable from participants at December 31, 2024 and 2023, and the net change in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company (Fidelity), the Plan's qualified institution.

4. Investments

Certain Plan investments are managed by Fidelity, which is the Plan's qualified institution. Transactions in these investments qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net change in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

Investments are exposed to various risks such as market, currency, interest rate and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cybersecurity attacks, or similar events. It is at least reasonably possible that changes in their fair value will occur in the near term, and such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets or liabilities in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in the money market fund and mutual funds are stated at quoted market prices for the identical security in an active market that the Plan has the ability to access (Level 1).

The stable value fund is carried at net asset value (NAV) and participants transact daily at the NAV of the fund (Level 1). The stable value fund invests in traditional guaranteed investment contracts (GICs), security-backed investment contracts, and separate account GICs which are valued at contract value as well as other short-term investments which are valued at fair value. Subject to certain restrictions, withdrawals from the stable value fund are generally permitted daily at contract value.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions.

6. Income Tax Status

The Plan uses a non-standardized, pre-approved profit sharing plan with CODA (pre-approved plan) sponsored by FMR, LLC (FMR) (an affiliate of Fidelity). FMR received an opinion letter from the Internal Revenue Service, dated June 30, 2020, which states that the pre-approved plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has not obtained an individual determination letter and has been amended since FMR received the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.
