**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Q'Strait / Sure-Lok 401(K) Retirement Plan (the Plan) provides only general information. Participations should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC for eligible employees of Valeda Company, LLC and Sure-Lok International, LLC (the Company). All full-time and part-time employees of the Company who have completed 90 days of continuous service and are aged 18 or older are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974, as amended (ERISA). The Plan became effective May 1, 2001.

Plan Administration: Principal Financial Group provides recordkeeping, administrative services and serves as the trustee for all assets of the Plan.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of a termination, participants would become 100 % vested in their account.

Contributions: The Plan includes an auto-enrollment provision whereby certain newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The contribution percentage will be increased 1% annually, as provided in the Plan document, until it reaches 10% of eligible compensation. The Plan also allows for contributions to be made on an after-tax basis. Eligible employees may elect to defer up to the Internal Revenue Service (IRS) limitations, \$23,000 for 2024, on a pretax and/or Roth basis under the rules of Section 401(k) of the IRC. In addition, participants aged 50 and over have the option to contribute up to an additional \$7,500 for 2024, in pretax contributions through the Plan's catch-up contribution provisions. The Company matches 100% of the first 4% of compensation deferred by a participant.

Participant Accounts: Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the Company's matching contributions and earnings and losses. Withdrawals and administrative expenses are deducted from the participant's account.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. The Company's matching contributions and associated earnings or losses vest immediately after the participant has completed two years of service. All participants vest 100 % upon reaching retirement age, or upon termination of employment due to death or permanent disability.

Forfeitures: Forfeitures of Company contributions are used to reduce administrative expenses and to offset future employer matching contributions and nonelective contributions of the Plan.

Investments: The Plan allows participants to direct contributions into various investment options. These options include mutual funds and collective trust funds.

Notes Receivable From Participants: Participants are allowed to borrow from their accounts in amounts ranging from a minimum of \$1,000 to a maximum of 50 % of the vested account or \$50,000, reduced by any outstanding loan balance. Loan maturities generally range from 1-5 years with one loan available at any time. The loans are collateralized by the balance in the participant's account and are to bear interest at the rates available for similar loans from commercial lending institutions. The interest rate on outstanding balances ranged between 5.25% and 10.50% for 2024 and 2023. Principal and interest is paid ratably through payroll deductions. Upon origination of a loan, participants are charged an administrative fee that is reflected in administrative expenses in the statement of changes in net assets available for benefit. Participant loans are presented as notes receivable from participants in the statements of net assets available for plan benefits.

Payment of Benefits: Benefits are generally payable on termination of employment, retirement, attainment of age 59.5, death, or disability. Benefits may be paid by lump-sum cash payment except as otherwise provided in the Plan document. Hardship distributions are also available from all participants accounts, subject to regulatory requirements. Distributions from participant rollover sources can be withdrawn at any time.

**NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES**

Basis of Presentation: The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates: The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Investment Valuation and Income Recognition: All Plan investments as of December 31, 2024 and 2023 are held by the Trustee and are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Mutual funds are valued at quoted market prices that represent the value of shares held by the Plan at year end. Common collective trust funds and pooled separate account are reported at fair value using net asset value per share (or its equivalent) as a practical expedient. See note 4 for further discussion and disclosure related to fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized and unrealized gains and losses on the Plans investments are included in net appreciation in the fair value of investments in the statements of changes in net assets available for benefits.

Participant notes receivable are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

Payment of Benefits: Benefits are recorded when paid.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

**NOTE 3 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants as disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (trustee of the Plan) and Principal Life Insurance Company (Agent), as an agent for the Principal Global Investors Trust Company.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosure*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

*Level 1* – Unadjusted quoted prices available in active markets for identical investments as of the reporting date.

*Level 2* – Observable inputs to the valuation methodology are other than Level 1 inputs, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* – Valued at quoted prices in an active market which represent net asset value of shares held by the Plan.

*Common Collective Trusts* – Valued at net asset value, which is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding.

Certain Plan investments are held in investments by the Plan trustee and, therefore, these transactions qualify as exempt party-in-interest transactions. Participant loans are also considered party-in-interest transactions. Interest income from participant loans totaled approximately \$25,000 for the year ended December 31, 2024 and is included as part of interest and dividends in the accompanying statement of changes in net assets available for benefits. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

**NOTE 6 - TAX STATUS**

The Plan has received a favorable determination letter dated March 31, 2014, stating that the Plan is qualified under Section 401 of the IRC and is, therefore, exempt from federal income taxes. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable provisions of the IRC. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that would likely not be sustained upon examination by a taxing authority. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
