Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Retirement Plan for Employees of Florida Cardiology, P.A. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1: DESCRIPTION OF THE PLAN

The following description of The Retirement Plan for Employees of Florida Cardiology, P.A. (the Plan), provides only general information. Refer to Plan documents for a more complete description of the Plan provisions.

General

The Plan was established April 1, 1983, and was restated July 1, 2016, as a defined contribution plan under Section 401(k) of the Internal Revenue Code (the IRC), for all employees of Florida Cardiology, P.A. (Plan Sponsor and Plan Administrator), Intellisight, L.L.C., and Dynamic Resource Group, L.L.C. (the Companies or the Employers). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator was appointed by the owners of the Companies is responsible for oversight of the Plan. The Plan's Investment Advisor, Chepenik Financial, determines the appropriateness of the Plan's investment offerings, monitors investment performance and report to the Plan Administrator.

Some administrative functions are performed by employees of the Plan Sponsor. No compensation is remitted to the Plan Sponsor for these services.

Plan assets are held and management by Delaware Charter Guarantee and Trust Company dba Principal Trust Company (Principal), the trustee and the qualified institution for the Plan, which invests contributions and Plan earnings, makes investment transactions as directed by the Plan Administrator and provides certain recordkeeping services. Principal also acts as the third-party administrator for the Plan, which performs certain plan administration and annual ERISA compliance testing.

Eligibility

The Plan covers all full-time and part-time employees of the Companies who have attained age twenty-one and completed two months of service. An eligible employee may enter the Plan on the first day of the month after all entry requirements have been met.

Contributions

Employee Elective Contributions – Each participant may elect to defer up to 90 percent of pretax annual compensation provided the total elective contributions do not exceed \$23,000 in 2024 and non-discrimination tests are met in accordance with the Internal Revenue Code §401(k). Employees over age 50 may make additional \$7,500 catch-up contributions annually. Participants direct the investment of their contributions into various investment options offered by the Plan.

Employer Matched Contributions – Matched contributions are the amounts contributed by the Employers to active participants who have made elective contributions during the Plan year. The Companies did not make any matched contributions during the year ended December 31, 2024.

Contributions (Continued)

Employer Discretionary Profit-Sharing Contributions – The Employers, at their collective discretion, may contribute amounts to the Plan in addition to any matched contributions. These monies will be allocated to Plan participants in the same proportion that such participant’s compensation for the Plan year bears to the total compensation of all participants for the Plan year. A discretionary profit-sharing contribution was not made by the Companies during the year ended December 31, 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and the Companies’ matched and discretionary profit-sharing contributions, if made, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan, if any. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Companies’ contribution portion of their accounts is based on years of continuous service. A participant is 20% vested after 2 years, with a 20% increase each succeeding year until becoming fully vested after the sixth year of service. However, each participant is 100% vested in these contributions if they are employed on or after Normal Retirement age.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000. The maximum amount of loans outstanding cannot exceed the lesser of one-half of the present value of the non-forfeitable accrued benefits of the participant or \$50,000. Participants may not have more than two loans outstanding at a time. The loans are secured by the balance in the participant’s account and bear interest at prime (as stated in the Wall Street Journal at the date of the loan) plus 1%, ranging from 4.3% to 9.6% at December 31, 2024. Principal and interest is paid ratably through bi-weekly payroll deductions over terms ranging from 1 to 5 years.

Note 1: DESCRIPTION OF THE PLAN (Continued)

Benefits Payments

Benefits become payable upon retirement, termination of employment, death, permanent disability, or financial hardship in either a lump sum payment or in annual installments. Benefits payable upon termination of employment, other than retirement, death, or permanent disability, are distributed automatically or upon election by the terminated employee if under \$5,000. The amount of benefits to which a participant is entitled is equal to the vested portion of the participant's account balance. Terminated participants' non-vested account balances are used to pay administrative expenses or reduce employer contributions.

Forfeitures

Forfeitures may be applied to reduce employer contributions or administrative expenses. At December 31, 2024 and 2023, no forfeitures were held by the Plan.

Hardship Withdrawals

As permitted by the Internal Revenue Code (IRC), a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Use of Estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments generally are reported at fair value, but may also be reported at contract value or net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements and NAV. The Plan's Investment Advisor determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributes excess contributions to the applicable participants before March 15 each year.

Payment of Benefits

Distribution to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

Subsequent Events

Management has evaluated subsequent events through the date that the financial statements were available to be issued, October 14, 2025. See Note 9 for relevant disclosures. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

Note 3: INVESTMENTS CERTIFIED BY QUALIFIED INSTITUTION

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, the qualified institution:

- a) Total investments at fair value, included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- b) Notes receivable from participants, included in the statements of net assets available for benefits at December, 31, 2024 and 2023.
- c) Investment income, net appreciation in the value of investments and interest income from notes receivable, information included in in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- d) All amounts included in Note 4, *Fair Value Measurements*.
- e) All information included in the supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024.

Note 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
 - observable; or
 - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts (CCTs): The Plan's CCTs are valued based on NAV per share or unit as a practical expedient as reported by the fund manager, multiplied by the number of shares or units held as of the measurement date. Accordingly, these NAV based investments have been excluded from the fair value hierarchy leveling.

Pooled Separate Accounts: Valued using a unit value system or recording, which indicates the dollar value for one unit. Due to the valuation method, the value of one unit is not identical to the value of the fund if it were purchased outside of the Plan. Therefore, the security is measured at NAV. Assets measured at NAV as a practical expedient are exempt from classification within the fair value hierarchy.

Group Annuity Contract (GAC's): The plan's GAC's are valued based on NAV per share or unit as a practical expedient as reported by the fund manager, multiplied by the number of shares or units held as of the measurement date. Accordingly, these NAV based investments have been excluded from the fair value hierarchy leveling.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

Note 5: TAX STATUS

The IRS has determined and informed the Plan by a letter dated July 16, 2010, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6: RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by Principal and Chepenik Financial who serves as the Plan's Investment Advisor. As such, transactions between the Plan and these entities qualify as party-in-interest transactions.

The Plan paid certain expenses related to plan operations and investment activity to various service providers, as described in Notes 1 and 2. These transactions qualify as party in interest transactions under ERISA.

Note 7: PLAN TERMINATION

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
