## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Trustees of  
Janover, LLC 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Janover, LLC 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 (liquidation basis), and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 (liquidation basis), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5(c) of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, effective October 31, 2023, the Plan Sponsor approved a plan of termination, contributions into the Plan were suspended, and all assets were distributed in 2025. As a result, the Plan has changed its basis of accounting from ongoing basis to the liquidation basis used in presenting the 2024 and 2023 financial statements. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other Matters – Supplemental Schedules Required by ERISA**

The supplemental schedule of assets (held at end of year) and the schedule of delinquent participant contributions as of December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Janover, LLC 401(k) Plan (the “Plan”) provides only general information. The Plan is sponsored by Janover, LLC (the “Plan Sponsor”), and is a multiple employer plan. There are several entities affiliated with the Plan Sponsor participating in the Plan (collectively with the Sponsor known as “Employers”).

Effective January 1, 2023, the Plan was amended to incorporate applicable provisions of the Setting Every Community Up for Retirement (“SECURE”) Act. These amendments include updates to participant eligibility, contribution limits, and catch-up contribution rules.

Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan established on January 1, 1992, as amended when required, covering substantially all employees of the Employers. Employees are eligible to participate after completing six months of service and having attained the age of 21. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as well as all provisions of the federal income tax laws.

The Plan Administrator and Trustees of the Plan are responsible for oversight of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

**Plan Termination**

Effective October 31, 2023, the Plan Sponsor approved the termination of the Plan. As a result, all contributions to the Plan were suspended, and participants retained full ownership of their account balances. Plan assets were either distributed or rolled over in accordance with IRS regulations. Following the termination, the Plan adopted the liquidation basis of accounting for the years ended December 31, 2024 and 2023, replacing the ongoing basis previously used.

Upon termination, all affected participants became fully vested in their accounts. Any unallocated Plan assets will be allocated to participant accounts and distributed in accordance with the Plan’s provisions. Participant and employer contributions ceased as of October 31, 2023.

**Participant Accounts**

Each participant’s account is credited with the participant’s contributions, and matching contributions made by the Employers (if any), as well as allocations of profit-sharing contributions made by the Employers, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Notes Receivable from Participants**

Participants may borrow against their vested account balances a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000 reduced by the excess, if any, of the Participant's highest outstanding balance of loans from the Plan during the one-year period ending on the day before the date on which such loan is made, over the Participant's outstanding balance of loans from the Plan as of the date such loan is made. The loans, in the form of promissory notes, are secured by the balances in the participants' accounts, and bear interest at reasonable rates, which are commensurate with local prevailing rates as determined by the Plan Administrator. Only one loan per participant may be outstanding at any given time. Principal and interest on notes receivable from participants are repaid through payroll deductions.

**Payment of Benefits**

Distributions from the Plan will be made in one lump-sum payment in cash equal to the value of the participant's vested interest in his or her account balance, in partial distributions, or in installments. If a participant's vested benefit in the Plan exceeds \$7,000, the participant must consent to the distribution before it may be made. If the participant's vested interest does not exceed \$1,000, then the participant's benefit will be distributed in a lump-sum as soon as practicable following the event that led to the participant being entitled to a distribution. If a participant's vested benefit is greater than \$1,000 but less than \$7,000 the participant's benefit is automatically rolled to an individual retirement account. The Plan also provides for hardship distributions from certain contributions subject to conditions and limitations provided for in the Plan agreement.

**Forfeited Accounts**

Forfeitures are to be used to reduce contributions to the Plan made by the Employers, or to pay administrative expenses incurred by the Plan and may also be used to restore forfeitures. During the year ended December 31, 2024, there were no balances forfeited and no forfeitures were utilized for administrative expenses or to reduce contributions to the Plan made by the Employers. At December 31, 2024 and 2023, there were no unallocated forfeitures available.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the liquidation basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles ("GAAP") under the liquidation basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment adviser, insurance company, and Charles Schwab Bank ("CSB") which is the Plan's Custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis with dividends being recorded on the ex-dividend date. Certain registered investment companies and other investment funds pay dividends or capital gain distributions that are reinvested into the Plan. Net appreciation includes gains and losses on the Plan's investments bought and sold as well as those held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent notes receivable from participants may be reclassified as distributions based upon the terms of the Plan document.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in the net appreciation of the fair value of investments. During the year ended December 31, 2024, the Plan incurred administrative fees of \$69,263 with its third-party administrator and Custodian. These charges are reflected in the accompanying statement of changes in net assets available for benefits.

**Payment of Benefits**

Benefits are recorded when paid.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, Fair Value Measurements and Disclosures, are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish daily pricing information, and fair value is determined based on the closing price reported by each fund. These investments are classified as Level 1 under the fair value hierarchy. The mutual funds held by the Plan are deemed to be actively traded.

**Money Market Fund**

Valued at the daily closing price as reported by the fund. The fund invests in U.S. government securities and other obligations issued or guaranteed by the U.S. government, its agencies, or instrumentalities. This fund is required to publish its daily net asset value and to transact at that price. The fund held by the Plan is deemed to be actively traded.

**NOTE 4 – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Standard Insurance Company (“Standard”) is the Plan’s third-party administrator. CSB is the Plan’s Custodian. Therefore, transactions with Standard and CSB qualify as party-in-interest transactions. Fees paid by the Plan for administrative services amounted to \$69,263 for the year ended December 31, 2024.

CSB provides certain administrative services to the Plan pursuant to a contract between the Plan Sponsor and CSB. CSB receives revenue from mutual fund service providers for services it provides to the funds. This revenue is used to offset certain amounts owed to CSB for its administrative services to the Plan.

**NOTE 5 – INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the auditors to not perform any auditing procedures with the respect to the information certified by Charles Schwab Trust Bank in 2024 and 2023, except for comparing such information with the related information included in the accompanying financial statements and supplemental schedules.

**NOTE 6 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market risks, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits. It is not possible currently to reasonably estimate the possible loss or range of loss, if any. We further caution that it is not possible to list all such factors, and you should not consider the identified factors as a complete and exhaustive list of all risks and uncertainties.

**NOTE 7 – TAX STATUS**

The Plan adopted a Volume Submitter Plan (“VSP”) with a cash or deferred arrangement (“CODA”) and is relying on an opinion letter rendered by the IRS on June 30, 2022, stating that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (“IRC”). The opinion letter aligns with the Plan’s Cycle 3 amendment effective January 1, 2022.

Accounting principles generally accepted in the United States of America, including those applicable to the liquidation basis of accounting, require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**NOTE 8 – NONEXEMPT PARTY-IN-INTEREST TRANSACTIONS**

The Employers discovered that certain participant contributions totaling \$602,464 were not remitted timely to the Plan as required by the Department of Labor Regulation 2510.3-102 for the year ended December 31, 2023. For the year ended December 31, 2024, The Employers remitted the lost earnings to the Plan, and the amount is reflected in the statements of net assets available for benefits and statement of changes in net assets available for benefits.

**NOTE 9 – SUBSEQUENT EVENTS**

All assets of the Plan were distributed as of October 1, 2025, and the Plan evaluated subsequent events for recognition and disclosure through October 13, 2025, the date the financial statements were issued.
