Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Able Health Care Services, Inc. Employee Retirement Plan (the "Plan") an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and 2023, and the related notes to the financial statements.

1. DESCRIPTION OF PLAN:

The following brief description of the Able Health Care Services, Inc. (the “Company”) Employee Retirement Plan (the “Plan”) provides only general information about the Plan provisions. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions, copies of which may be obtained from the plan sponsor..

General

The Plan is a defined contribution plan covering all full-time, non-union employees of the company who have met certain requirements as to age, length, and location of service. The assets of the plan are maintained in trust managed by Principal Trust Company (the “Trustee”). The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and was established effective January 1, 2018.

Eligibility:

Employees are eligible to participate in the plan if they are employed by Able Healthcare Servies, Inc or any affiliate who has adopted the Plan. Employees will become a participant with respect to pension contributions on the date employees first perform an Hour of Service as an Eligible Employee.

Retirement Contributions:

The company will make a Pension contribution to the plan on the behalf of Participants. Contributions to the plan will be allocated in an amount necessary to meet the company’s requirements under an applicable prevailing wage statute. The prevailing wage contributions are allocated to Participants based on their type of employment and place of employment, among other factors..

Limitations:

Congress limits the annual dollar amount that can be contrbutied to the plan on behalf of participant. For 2023, the limit was \$69,000. In addition, contributions cannot exceed 100% of participant total compensation.

Retirement Benefits:

Employees are entitled to receive distribution equal to his or her account balance beginning at the normal retirement age (age 65). The plan does not have an early retirement feature. A vested

participant who terminates employment prior to attaining normal retirement age is entitled to receive a distribution equal to his or her account balance.

Employees who are entitled to receive benefit due to normal age or termination will be distributed their account balance in the form of 100% “Qualified Joint and Survivor Annuity” unless employees account balance does not exceed \$ 5,000. Employees upon their termination may elect to receive their distribution in the form of lump sum payment.

If the account balance doesn’t exceed \$1000, the participant will be distributed directly in cash upon termination of employment with the company. Likewise upon termination, if the account balance is more than \$1000 but less than \$5,000, the participant may either elect to receive distribution in cash or to roll over the distribution to an individual retirement account (IRA) or the qualified plan of new employer (but only if new employer’s plan allows such rollovers.

If the participant die before distribution of their Account begins, at least 50% of account balances will be automatically be applied to the purchase of a survivor annuity for the beneficiary and for another 50%, the beneficiary will be entitled to a distribution in any form that is available prior to participant death. If the participant die after distribution of Account balance has begun, the remaining portion of participant Account will continue to be distributed under the method of distribution being used prior to death.

Vesting:

Participants are always fully (100%) vested in their pension contribution account and rollover contribution account plus actual earnings thereon.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

The accompanying financial statements of the plan are prepared in compliance with the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA and accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates

The preparation of financial statements in conformity with GAAP and DOL's Rules and Regulations for Reporting and Disclosure under ERISA requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, benefit obligations, and changes therein at the date of the financial statements, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Income Recognition

Purchases and sales of securities are recorded on the trade date. Dividend income is recorded on the ex-dividend date and interest income is recorded on an accrual basis. Realized gains and losses are calculated as the difference between the proceeds from sales and the related investment's fair market value at the beginning of the plan year, or acquisition cost if acquired during the year. Unrealized appreciation and depreciation is calculated as the difference between the fair value of investments at the end of the year less their fair value at the beginning of the year, or acquisition cost, if acquired during the year.

Payments of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

The plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators, the trustee, and actuary. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the company on behalf of the plan.

3. FAIR VALUE MEASUREMENTS:

Financial Accounting Standards board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1:

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2:

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the assets or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term the asset or liability.

Level 3:

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Common stocks: Valued at the closing price reported on the active market on which the individual securities are traded.

Common collective trusts: Investments in common/collective trusts are stated at the redemption prices based on the fair value of the underlying assets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. CONCENTRATION OF CREDIT RISK

In the normal course of business, all of the Plan's assets are transacted with and held by the Trustee. The plan is subject to credit risk to the extent the Trustee is unable to fulfill contractual obligations on its behalf. The company has not experienced and does not expect any loss from this arrangement.

The plan invests in various investments types. Those investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain mutual funds, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

6. PLAN TERMINATION:

Although the company intends to maintain the Plan indefinitely, the company may amend or terminate the Plan at any time in its sole discretion to the provisions of ERISA. If any of these actions is taken, participant will be notified. However, no such action may permit any part of Plan assets to be used for any purpose other than the exclusive benefit of participants and beneficiaries or cause any reduction in participant vested Account balance as of the date of the amendment or termination. In the event of Plan termination, participants will become 100 percent vested in their accounts.

7. TAX STATUS

The underlying nonstandard prototype plan has received an opinion letter from Internal Revenue Service (IRS) dated March 31, 2014, stating that the form of the plan is qualified under section 401 (a) of the code and, therefore, the related trust is tax-exempt. In accordance with Revenue

procedures 2006-6, the plan sponsor has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. Once qualified, the plan is required to operate in conformity with the code to maintain its qualification. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the code and, therefore, believes that the plan is qualified and the related trust is non-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by tax jurisdictions; however, there are currently no audits for any tax periods in progress

8. PARTY-IN-INTEREST

The assets of the plan are invested with and valued by the Trustee, which is considered a party-in-interest as a provider of, administrative investment management and accounting services to the funds. These transactions are exempt from the prohibited transaction rules.

9. INFORMATION PREPARED AND PROVIDED BY TRUSTEE AND/OR PLAN ADMINISTRATOR:

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL'S Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified as complete and accurate by the Trustee as of December 31, 2024 and for the year then ended December 31, 2023.
