## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
Wantable, Inc. 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Wantable, Inc. 401(k) Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

## **Basis for Opinion on the 2024 Financial Statements**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control related matters that we identified during the audit.

#### **ERISA-Required Supplementary Information**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the 2024 financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and is derived from and relates directly to the underlying accounting and other records used to prepare the 2024 financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audit of the 2024 financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the 2024 financial statements or to the 2024 financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion,

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## Report on the 2023 Financial Statement

Plan management is responsible for the preparation and fair presentation of the accompanying 2023 financial statement of the plan, which comprise the statement of net assets available for benefits as of December 31, 2023 and the related notes ("2023 financial statement"), in accordance with GAAP. **1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Method of accounting** - Wantable, Inc. 401(k) Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

**Accounting estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Subsequent events** - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through October 11, 2025, which is the date the financial statements were available to be issued.

**Risks and uncertainties** - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Concentrations** - The plan invests primarily in John Hancock target date separate accounts, which represent approximately 92% and 86% of total plan assets as of December 31, 2024 and 2023. The majority of the target date funds have target retirement dates of 2045 or later and, accordingly, are more heavily allocated to growth-oriented investments rather than conservative fixed income investments. A significant decline in the market value of these investments would significantly affect the net assets available for benefits.

**Key parties of the plan** - Wantable, Inc. is the plan sponsor, employer and the plan administrator. The Retirement Advantage, Inc. ("TRA") is the third party administrator that maintains plan documents and tax counsel that performs various compliance tests. TRA also provides fiduciary services as an Employee Retirement Income Security Act ("ERISA") 3(16) fiduciary. John Hancock Life Insurance Company (U.S.A.) ("John Hancock") is the investment agent and recordkeeper that holds custody of plan investment assets and maintains investment and participant records. Northwestern Mutual Financial Network is the plan's investment advisor. An officer of the plan sponsor is the plan trustee.

**Investments** - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. Participants should refer to the investment account summaries and prospectuses for more information.

At the end of each business day, John Hancock determines the fair value of the investments held in its separate accounts and allocates the fair value to the participants. The net appreciation (depreciation) in the fair values of investments, including investments bought, sold or held during the year, is reflected in the accompanying statement of changes in net assets available for benefits.

**Fair value measurements** - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows.

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodology used for investments measured at fair value.

*John Hancock separate accounts* - The separate accounts are valued at net asset value ("NAV") as provided by John Hancock. The NAV is generally based on the fair value of the underlying investments held by the separate account less its liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the separate account would sell the investment for an amount different than the reported NAV.

The plan administrator determines by level, within the fair value hierarchy, the plan's investments at fair value as set forth below.

## 2. DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan documents for a more complete description of the plan's provisions.

**General** - The plan was adopted effective January 1, 2018 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to provisions of ERISA and subsequent amendments.

**Eligibility** - Employees who have completed two months of service are eligible to participate in the plan. An employee can enter the plan on the first day of the month after meeting the eligibility requirements.

**Contributions** - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferral contributions.
- b. Rollover contributions are accepted by the plan from other qualified plans.
- c. The employer may make matching contributions at the discretion of the employer's board of directors. The employer elected to contribute employer discretionary matching contributions equal to 50% of the first 3% of participants' deferrals, up to 1.50% of eligible compensation during 2024. These contributions were funded coinciding with each payroll with an annual true-up contribution.
- d. Effective January 1, 2025, the plan was amended and now requires safe harbor contributions equal to 100% of the first 4% of employee compensation contributed as elective deferral contributions. These contributions will be funded coinciding with each payroll.
- e. The employer may make non-elective contributions at the discretion of the employer's board of directors. There were no such non-elective contributions in 2024.

**Participant accounts** - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral and rollover contributions and an allocation of any employer contributions. Participants are allowed to change their investment options on a daily basis and change their deferral percentage each pay period.

**Vesting** - Participants are always 100% vested in their elective deferral, rollover and employer safe harbor matching contributions and related earnings. Participants begin vesting in any employer discretionary contributions and related earnings after their first year of service, at which time they are 25% vested. Participants then vest at a rate of 25% for each year thereafter. Upon death, disability or attainment of normal retirement age (defined as the later of attaining age 65 or 5 years of service) while employed participants become 100% vested.

**Payment of benefits** - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or retirement. Distributions are generally made in the form of a single lump-sum payment. In addition, hardship withdrawals are permitted under certain circumstances. In-service withdrawals can commence upon attaining the age of 59 ½.

**Forfeitures** - Forfeited nonvested accounts, which are held in a noninterest-bearing cash account, are used to reduce employer contributions or pay plan fees. There were no forfeitures used in 2024. Unapplied forfeitures were \$5,000 and \$1,000 as of December 31, 2024 and 2023.

**Administrative expenses** - Certain administrative expenses of the plan are paid by the employer and not included in these financial statements. Certain other administrative fees are paid by the plan from plan assets and recorded as administrative expenses in these financial statements. Such expenses include participant directed charges for loan and distribution processing fees and nonparticipant directed charges for service, advisory and administrative fees. The nonparticipant directed charges are allocated to participants on an account value basis.

**Notes receivable from participants** - Participants can take out loans against their accounts with the approval of the plan administrator. The minimum loan amount is \$1,000 and the maximum amount is the lesser of one-half of the participant's vested account balance, or \$50,000. Participants may have one loan outstanding at any given time. The repayment term generally cannot exceed 5 years except when the loan is for the purchase of a principal residence. As of December 31, 2024, the notes receivable from participants had various repayment schedules through January 2027 with interest rates from 5.25% to 10.50%. The notes receivable from participants are valued at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value.

### **3. PARTY-IN-INTEREST TRANSACTIONS**

The plan investments are managed by John Hancock. John Hancock is also the investment agent that holds custody of the plan's investment assets. As such, transactions between John Hancock and the plan qualify as party-in-interest transactions. John Hancock provides certain administrative services to the plan pursuant to a services agreement between the plan sponsor and John Hancock. John Hancock receives revenue in the form of indirect compensation from mutual fund service providers for services John Hancock provides to the funds. This indirect compensation is used to offset certain amounts that would otherwise be owed to John Hancock by the plan for its administrative services to the plan. Direct fees paid to John Hancock were \$24,000 in 2024.

Activity related to notes receivable from participants also qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**4. TERMINATION OF PLAN**

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in any employer discretionary contributions and related earnings.

**5. INCOME TAX STATUS**

The plan is operating under a The Retirement Advantage, Inc. non-standardized pre-approved profit sharing plan that received a favorable opinion letter on June 30, 2020. The opinion letter received from the Internal Revenue Service ("IRS") stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The plan administrator has not obtained a separate IRS opinion or determination letter for the plan; however, the plan administrator and tax counsel believe the plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and, therefore, believe the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

**6. INFORMATION CERTIFIED BY JOHN HANCOCK**

Management has obtained certifications from John Hancock, a qualified institution under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate.

- a. Investments held and the fair values of such, noninterest-bearing cash and notes receivable from participants as of December 31, 2024 and 2023;
- b. Net appreciation (depreciation) in fair values of investments and interest income on notes receivable from participants during 2024 and 2023;
- c. Contributions to, withdrawals from, purchases, sales and inter-fund transfers between accounts during 2024 and 2023; and
- d. The report of individual participant accounts as of and for the years ended December 31, 2024 and 2023.
