**1. Description of Plan**

The following description of the Aclaris Therapeutics, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions. The Plan was originally effective October 1, 2012, and was most recently amended and restated effective January 1, 2022.

**General**

The Plan, sponsored by Aclaris Therapeutics, Inc. (the “Company”), is a 401(k) profit-sharing defined contribution plan covering all employees of the Company. Collectively bargained employees and employees who are nonresident aliens are not eligible to participate in the Plan. There is no age or service requirement. Participants may enter the Plan on the first day of the month upon completion of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions**

Each year, participants may elect to contribute up to the maximum allowable under the Internal Revenue Code (“IRC”). Participants may also designate contributions as Roth contributions. In addition, participants who have attained age 50 before the close of the Plan year are eligible to make “catch-up” contributions up to the amount allowable under the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company provides for a safe harbor matching contribution which is calculated each payroll period. The safe harbor matching contribution is 100% of the participant’s salary deferrals up to 3% plus 50% of the participant’s salary deferrals for the next 2% of eligible compensation contributed to the Plan. The Company also provides a discretionary employer matching contribution which is calculated each payroll period. No discretionary employer matching contributions were made during the year ended December 31, 2024. The Company may also make discretionary nonelective (“Profit Sharing”) contributions to the Plan. No Profit Sharing contributions were made during the year ended December 31, 2024.

**Participant Accounts**

Each participant’s account is credited with the participant’s contributions, Company’s safe harbor matching contributions and discretionary employer matching contributions, if any, as well as allocations of the Company’s Profit Sharing contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that is provided from the participant’s vested account.

**Vesting**

A participant, at all times, has a fully vested (100%) interest in their own contributions and rollover contributions and safe harbor matching contributions, including actual earnings thereon. Vesting in the Company’s discretionary employer matching contribution and Profit Sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants are vested in their discretionary employer matching contribution and Profit Sharing contributions based on their years of service in accordance with the following schedule:

Notwithstanding the above vesting for the Company's discretionary employer matching contribution and Profit Sharing contribution portion of their accounts, a participant will become 100% vested in these accounts upon their attainment of normal retirement age (65) while an employee, death while an employee, or becoming disabled while an employee.

**Forfeited and Unallocated Accounts**

Forfeitures are generally used to pay expenses or reduce employer contributions. Total unallocated forfeitures were \$297, and \$282, as of December 31, 2024 and 2023, respectively. No amounts of previously forfeited accounts were used to pay administrative expenses or used to offset employer contributions during the year ended December 31, 2024. Additionally, as of December 31, 2024 and 2023, the Plan has \$17,230 and \$16,410, respectively, of amounts in unallocated accounts which the Plan can use to pay for administrative expenses or allocate to participants. During the year ended December 31, 2024, \$0 of unallocated accounts were utilized to pay expenses, and \$0 were allocated to participants.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms may not exceed five years unless the purpose of the loan is for the purchase of a primary residence. A participant may only have one loan outstanding at any time. The loans are secured by the balance in the participant's account and bear interest equal to the prime interest rate plus a specific rate determined by the Plan's sponsor. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

Upon termination of service, death, disability, retirement or separation from service, participants or their beneficiaries will receive, in a lump-sum payment, an amount equal to the value of the participant's vested interest in his or her account. If a participant's vested account balance is less than \$7,000 (\$5,000 prior to modification allowed by the Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022, "SECURE Act 2.0") upon termination, the Plan administrator may authorize the benefit payment without the participant's consent. If the participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, then the Plan administrator will pay the distribution in a direct rollover to an individual retirement account designated by the Plan administrator.

In-service withdrawals of all or a portion of a participant's vested account balance may be made by participants who have attained the age of 59-1/2. Participants are also permitted to make hardship withdrawals from their deferral contribution accounts in certain cases of immediate and heavy financial need.

**2. Summary of Significant Accounting Policies**

The following are the significant accounting policies followed by the Plan:

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's

investment committee determines the Plan's valuation policies utilizing information provided by the trustee and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Contributions**

Contributions from Plan participants, safe-harbor matching contributions from the Company and discretionary employer matching contributions, if any, are recorded in the year in which the employee contributions are withheld from compensation. Discretionary nonelective contributions from the Company, if any, are recorded in the year in which the related compensation is earned.

**Payments of Benefits**

Benefit payments to participants are recorded when paid.

**Administrative Expenses**

All reasonable administrative expenses, including custodial, trustee and third party administration fees necessary to operate and administer the Plan, are paid by the Plan, unless otherwise paid by the Company. Expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. A participant's account may be charged for expenses associated with a specific optional feature, including administration of participant loans, elected by that participant, and are included in administrative expenses. Certain investment related expenses are included in the net appreciation in fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

**3. Unaudited Information Certified by a Qualified Institution**

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Reliance Trust Company, a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value and notes receivable from participants as reported in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment activity, including net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The information for all mutual funds, and common collective trust listed in the schedule of assets (held at end of year) as of December 31, 2024 as shown in the ERISA-required supplemental schedule.

#### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

*Mutual funds (registered investment companies):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust:* Valued at the NAV or equivalent based on units of the common collective trust. The NAV, as provided by the trustee of the common collective trust, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the common collective trust less its liabilities. This practical expedient is not used when it is determined to be probable that the common collective trust will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan offers the T. Rowe Price Stable Value Common Trust Fund as a participant directed investment option. The strategy of the T. Rowe Price Stable Value Common Trust Fund is to preserve capital. The NAV, as provided to T. Rowe Price, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the T. Rowe Price Stable Value Common Trust Fund, less its liabilities. It is expected that the T. Rowe Price Stable Value Common Trust Fund will maintain a NAV of \$1 per unit. There are no unfunded commitments related to the trust. The provisions of the T. Rowe Price Stable Value Common Trust Fund provide that withdrawals for other than normal benefit payments and participant-directed transfers may require up to twelve months advance notice.

## **5. Risks and Uncertainties**

The Plan provides for various investment options including mutual funds and a common collective trust. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## **6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts, including any Company contributions in which they are not already vested.

## **7. Tax Status**

Effective January 1, 2022, through the adoption of a DST Retirement Solutions, LLC non-standardized defined contribution pre-approved plan, the Plan was amended and restated. The Internal Revenue Service (“IRS”) issued an opinion letter dated June 30, 2020, stating that the pre-approved defined contribution plan document was designed in accordance with applicable IRC requirements as of that date, and therefore, the related trust is tax-exempt. Although the Plan has been amended since receiving the opinion letter, management of the Plan believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

## **8. Related Party and Party-in-Interest Transactions**

Fees incurred by the Plan for investment management services are included in the net appreciation in fair value of investments. Reliance Trust Company is the trustee of the Plan. The Plan invests in certain mutual funds that are managed by an affiliate of T. Rowe Price, the Plan’s recordkeeper. Transactions with Reliance Trust Company and T. Rowe Price qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. For participants who have elected to take a participant loan, the loans are secured by the respective participant’s account balance. Direct fees paid by the Plan for services provided by T. Rowe Price, the recordkeeper of the Plan, were \$35,488 for the year ended December 31, 2024.

T. Rowe Price, or affiliates generate income to the Plan through revenue sharing agreements. More specifically, T. Rowe Price, or affiliates may receive revenue from mutual fund service providers for services T. Rowe Price, or affiliates provide to the mutual funds. This revenue may be used to offset certain amounts owed to T. Rowe Price, or affiliates for administrative services to the Plan. If the revenue received by T. Rowe Price, or affiliates from such mutual fund service providers exceeds the amount owed as agreed to by T. Rowe Price, or affiliates and the Plan for administrative services, T. Rowe Price, or affiliates is to remit the excess to the Plan. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During the year ended December 31, 2024 the related amounts deposited into the Plan was \$0 (see Note 1 for amounts allocated to participant accounts). Such amounts are also included in the net appreciation in fair value of investments in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024. The Plan or Plan Sponsor may make a payment to T. Rowe Price, or affiliates for administrative expenses not covered by revenue sharing.
