We have performed an audit of the accompanying financial statements of Belle Chasse Academy, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1) Description of plan

The following description of the Belle Chasse Academy, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

a) General

The Plan is a defined contribution plan covering substantially all employees of Belle Chasse Academy, Inc. (the Company or Employer) who are age eighteen or older. Eligible employees do not include those whose employment is governed by a collective bargaining agreement or are non-resident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Participants are eligible to participate upon the first day of the calendar month following turning the age of eighteen.

b) Contributions

Participants may voluntarily make before-tax and after-tax contributions to the Plan under Section 401(k) of the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participant contributions are permitted up to 100% of compensation, subject to certain IRC limitations. In addition, a participant who has attained age 50 before the close of the Plan year shall be eligible to make catch-up contributions in accordance with the limitations under the Internal Revenue Code.

The Plan makes matching contributions equal to 50% of the participants salary deferred up to 3% of compensation. In addition, the Plan allows for a discretionary profit-sharing contribution, to be determined by the Company, out of current or accumulated net profits. There were no profit-sharing contributions made in 2024 and 2023.

c) Participant accounts

Each participant's account is credited with the (1) participant's salary deferral, (2) Employer's contributions, (3) an allocation of the Plan's earnings and losses, and (4) an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

d) Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. A Participant is one hundred percent vested in the Company's contributions upon entering the Plan.

e) Payment of benefits

On termination of employment due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested balance in their account. A participant may withdraw all or part of their rollover contributions at any time. Participants may receive an in-service withdrawal of their vested account balance upon reaching 59 ½ years of age. Participants may also receive hardship distributions, as described in the Plan, from their deferral accounts. Balances under \$5,000 for terminated participants may be paid out at the discretion of the Company.

f) Investment options

Participants direct the allocation of their voluntary contributions and non-elective contributions among investment options offered by Matrix Trust Company, the Custodian of the Plan. Participants monitor and manage their individual accounts.

1) Description of plan (continued)

g) Forfeitures

At December 31, 2024 and 2023 there were no forfeited non-vested accounts.

h) Note receivable - participant loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to 50 percent of their vested account balance or \$50,000. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loan fund. Loan terms range from 1-5 years. The loans are secured by the balance in the participant's vested account and bear interest at 2% over the prime rate as posted in the Wall Street Journal when the loan is made. Principal and interest are paid ratably through payroll deductions. Interest rates range from 5.25% to 10.50%.

2) Summary of accounting policies

a) Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting as of and for the year ended December 31, 2024 and modified cash basis of accounting as of and for the year ended December 31, 2023.

b) Use of estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America, requires the Plan administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

c) Investment valuation and income recognition

The Plan's investments are stated at fair market value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d) Notes receivable – loans to participants

Participant loans are classified as notes receivable – loans to participants and are measured at the unpaid balance plus unpaid accrued interest. The Plan classifies all participant loans in default when any scheduled payment remains unpaid as of the end of the last day of the calendar quarter following the calendar quarter in which the required payment was due and not paid. Defaulted loans are deemed distributed and recorded as benefits paid to participants in the statements of changes in net assets available for benefits. There were \$11,554 and \$5,884 in deemed distributions recorded for Plan year 2024 and 2023, respectively.

e) Payment of benefits

Benefits are recorded when paid. There were not amounts allocated to participants who have elected to withdraw from the Plan but not yet been paid as of December 31, 2024 and 2023.

f) Plan expenses

Expenses of maintaining the Plan are paid from plan assets. Expenses paid using the Plan's assets are allocated among the accounts of all participants in the Plan.

3) Investments

The Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$640,331 and \$789,597 for the years ended December 31, 2024 and 2023, respectively.

4) Federal income tax status

The underlying non-standardized prototype plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code (the Code) and, therefore, the related trust is tax exempt. In accordance with Revenue Procedure 2006-6, the Company has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan has been amended since receiving the letter, including amendments made to comply with recent law changes. The administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor and the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. With few exceptions, the Plan is not subject to income tax examinations beyond three years from filing of returns.

5) Plan termination

Although it has not expressed any intent to do so, the Employer has the right at any time to terminate the Plan by delivering to the custodian and administrator written notice of such termination. Upon any full or partial termination, all amounts credited to the affected participants' accounts shall become 100% vested and shall not be subjected to forfeiture, and all unallocated amounts, including forfeitures, shall be allocated to the accounts of all participants in accordance with the Plan's provisions.

6) Related party transactions

The Plan invests in mutual funds and common collective trusts managed by Matrix Trust Company, the Custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions. The payment of administrative expenses by the Plan constitutes related party fees. Such fees amounted to \$7,595 and \$57,936 for the years ended December 31, 2024 and 2023, respectively.

7) Risks and uncertainties

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits.

8) Information prepared and certified by the Plan's custodian

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and the related net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information prepared and certified as complete and accurate by The Matrix Trust Company, a qualified institution.

9) Fair value measurement

Accounting Standards Codification 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Values at the net asset value of shares held by the plan at year end

*Common collective trusts:* Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer. The net asset value (NAV) is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023:

11) SECURE Act 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0.
