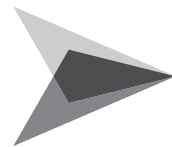

Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

We have performed audits of the financial statements of Prairie View Management, Inc. Employee Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(c) (ERISA Section 103(a)(3)(c) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Prairie View Management, Inc. Employee Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(c), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

Notes to Financial Statements

December 31, 2024 and 2023

Note 1 - Plan Description

The following description of the Prairie View Management, Inc. Employee Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General - The Prairie View Management, Inc. Employee Retirement Plan was established on January 1, 1989. The Plan was last amended effective April 1, 2020 in adopting a pre-approved Plan Document as disclosed in Note 7. The Plan is sponsored by Prairie View Management, Inc. (the ‘Sponsor’) and covers qualified employees of the Sponsor. The Plan’s year ends on December 31. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Directors is responsible for the oversight of the Plan. The plan administrator determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s Board of Directors.

Eligibility - Employees are eligible to participate in the Plan upon beginning employment with the Organization if they are expected to work at least eight hours per week. Employees must be 18 years of age and complete one year of service to be eligible for non-elective employer contributions. A year of service for purposes of eligibility is a consecutive 12-month period during which the employee has 1,000 or more hours of service. Individuals who are hired under vocational training programs are not eligible to receive employer contributions.

Entry Date - Employees may enter the Plan for employee contributions on the first day of employment, and on the last day of the plan year in which the eligibility requirements are met for employer contributions. Employee deferrals begin on the first payroll subsequent to enrollment.

Contributions - Each year, participants may elect to contribute amounts up to the maximum allowed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Sponsor contributes 3% of eligible compensation to the Plan for employees who meet the eligibility requirements for employer contributions. To receive the employer contribution the employee must be employed the last day of the plan year and have met the 6-month waiting period requirement. Participants with 15 years of service may make special 403(b) catch-up contributions. The Plan offers several mutual funds and a fixed annuity investment contract as investment options for the plan participants.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts - Each participant’s account is credited with the participant’s elective contribution and the plan sponsor’s employer contributions, as well as plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined by the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided by the participant’s vested account.

Vesting - Participants are immediately vested in their elective contributions, rollover contributions, and the employer contributions, plus actual earnings thereon.

Note 1 - Plan Description (Continued)

Benefit Payments - Participants may elect to receive either a lump-sum amount equal to the value of their vested interest, annuity payments or annual installments as defined in the Plan Document upon retirement, termination of service, death, or disability. A terminated employee with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 and \$5,000 can still be automatically paid out if their balance is rolled into a qualified Individual Retirement Account. The Plan allows for in-service distributions if the participant reaches 59½ or has incurred a hardship as defined in the Plan Document.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of the participant's vested account balance, not to exceed \$50,000. The notes are secured by the participant's vested account balance and bear interest at rates commensurate with local prevailing rates at the time funds are borrowed (5.25% to 10.00% as of December 31, 2024), as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions over a maximum period of five years for all loans, unless the proceeds of the loan were used to acquire the participant's residence, in which case the loan terms can range up to 15 years. A participant may have no more than four outstanding loans at any time.

Plan Termination - Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with U.S. generally accepted accounting principles.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value (except fully benefit responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in. Fair value is defined as the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Note 2 - Summary of Significant Accounting Policies

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are recorded as distributions based upon the terms of the Plan Document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits - Benefits payments to participants are recorded upon distribution.

Plan Expenses - The Plan's expenses are paid by either the Plan or the Plan Sponsor, as provided in the Plan Document. Expenses that are paid directly by the Plan Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Subsequent Events - The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

Note 3 - Certification of Investment Information

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustees have certified all investments and investment income information to be complete and accurate. The following investment information has been certified by ReliaStar Life Insurance Company, Protective Life Insurance Company, MassMutual Ascend Life Insurance Company, T. Rowe Price Trust Company, and Lincoln Investment Planning, LLC as agent for UMB Bank, the custodians of the Plan, as of December 31, 2024 and 2023:

Note 4 - Fair Value of Investments

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commissions. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment funds - Valued at fair value based on the NAV of units held of the collective fund. The NAV is based on the observable market prices of the underlying investments within the fund less liabilities. The NAV for the underlying assets of the fund is a readily determinable measure of their fair value and is the basis used by the fund for current transactions.

Note 5 - Contract with Insurance Company - Guaranteed Interest Accounts

The Plan has entered into investment contracts with ReliaStar Life Insurance Company, Protective Life Insurance Company, and MassMutual Ascend Life Insurance Company. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuers but may not be less than the guaranteed rate. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contracts do not permit the insurance companies to terminate the agreement prior to the scheduled maturity date.

The contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by ReliaStar, Protective, and MassMutual, represents contributions made under the contracts, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuers' ability to meet their financial obligations. The issuers' ability to meet their contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuers. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contracts.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuers to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investments guidelines, (2) a breach of material obligation under the contracts, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

Note 6 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

Note 7 - Plan Tax Status

The Plan adopted a pre-approved Plan Document sponsored by Midwest Group Benefits, Inc which received an advisory letter from the Internal Revenue Service (IRS) dated March 31, 2017 stating that the pre-approved document satisfies the applicable provisions of the IRC. Plan management believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Loans

Participants may borrow from Lincoln Investments ReliaStar Life Insurance Company as described in Note 1. The loans bear interest at a reasonable rate determined by Lincoln and ReliaStar. In the event of default, foreclosure on the participant's account balance will not occur until a distributable event occurs in the Plan.

Outstanding loans between plan participants and the custodians totaled \$44,114 and \$20,847 as of December 31, 2024 and 2023, respectively, and were collateralized by approximately the same amount of investments included in the statements of net assets available for benefits.

Note 9 - Related Party and Party-in-Interest Transactions

Certain plan investments are guaranteed interest accounts and collective investment funds managed by the custodians as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under the ERISA.

The custodians provide certain administrative services to the Plan pursuant to a service agreement between the Plan and the custodian. The custodian receives revenue from mutual fund service providers for services provided to the funds. This revenue is used to offset certain amounts owed to the custodian for its administrative services to the Plan.

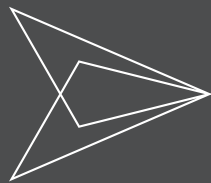
