I have performed an audit of the financial statements of J.D. Ott Co., Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules (DOL) and Regulations for Reporting and Disclosure under ERISA. **NOTE 1      DESCRIPTION OF PLAN**

The following description of the J.D. Ott Co., Inc. Retirement Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's Provisions.

General

The Plan is a defined contribution plan covering substantially all eligible employees of J.D. Ott Co., Inc. (the Company). The Plan was restated, effective January 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan Trustees are responsible for oversight of the Plan, which includes determining the appropriateness of the Plan's investment offerings, monitoring investment performance, and reporting to the Company's Board of Directors.

Eligibility

Employees of the Company are eligible to participate in the Plan upon reaching age 18 and after completing one month of service, except for union and non-resident aliens. Employees enter the Plan on scheduled enrollment dates following their completion of the eligibility requirements.

Contributions

Participants – Each year, participants may contribute up to 100 percent of eligible compensation to the Plan, as defined by the Plan, and subject to certain Internal Revenue Service (IRS) limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants aged 50 and over may elect to defer additional amounts (catch-up contributions) to the Plan. Participant contributions are remitted after each pay-date.

Employer safe harbor matching – The Company provides for a safe harbor matching contribution equal to 100 percent of the first 3 percent of eligible compensation of the participant, as defined by the Plan. Participants must be employed as of the last day of the Plan year, to be eligible to receive such contributions. Safe harbor matching contributions were \$209,090, for the year ended December 31, 2024. The contribution is paid once a year, subsequent to year-end.

Employer discretionary matching – The Company may elect to make discretionary matching contributions to the Plan, at the option of the Company's Board of Directors. The Plan limits these discretionary matching contributions to a maximum of 6 percent of a participant's eligible compensation, as defined by the Plan. Participants must be employed as of the last day of the Plan year, to be eligible to receive such contributions. Employer discretionary matching contributions were \$68,492, for the year ended December 31, 2024. The contribution is paid once a year, subsequent to year-end.

Employer discretionary profit sharing – The Company may elect to make discretionary profit sharing contributions to the Plan, at the option of the Company's Board of Directors. Participants must complete 1,000 hours of service during the Plan year and be employed as of the last day of the Plan year, to be eligible to receive profit sharing contributions. Employer discretionary profit sharing contributions were \$47,418, for the year ended December 31, 2024. The contribution is paid once a year, subsequent to year-end.

Participant Accounts

Separate accounts are maintained for each participant. Each participant's account is credited with the participant's contribution and Company's safe harbor matching contributions, as well as an allocation of the Company's discretionary matching and profit sharing contributions, if any, and plan earnings, and charged with an allocation of investment losses, withdrawals, and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of their and the Company's contributions into various investment options offered by the Plan. Participants may move portions of their accounts between investment options at any time.

Vesting

Participants are vested immediately in their deferral contributions plus actual earnings thereon. Participants are also vested immediately in the Company's safe harbor matching contributions. Vesting in the Company's discretionary matching and profit sharing contribution portion of their accounts is based on years of service. A participant becomes 100 percent vested after six years of credited service.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, as defined by the Plan, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. Participants with vested account balances of less than \$5,000 and more than \$1,000 receive an automatic distribution to an Individual Retirement Account (IRA), while any account less than \$1,000 will be distributed as a lump sum cash distribution without the participant's consent.

In-service withdrawals are allowed and are available from all vested account balances. Hardship withdrawals are not permitted by the Plan.

Forfeiture Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$891 and \$381, respectively. These accounts will be used to pay administrative expenses under the Plan or reduce future employer contributions. In 2024, forfeitures of \$381, were used as additional employer profit sharing contributions.

**NOTE 2      SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator and Company's management determine the Plan's valuation policies utilizing information provided by the investment advisors and third-party administrator. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments consists of both the realized gains or losses and unrealized appreciation and depreciation on investments bought and sold as well as held during the year.

Contributions

Contributions from participants and the Company in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued.

**NOTE 3      FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds:**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Collective Trust Funds:**

Composed primarily of fully-benefit responsive investment contracts that are valued at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. The NAV per unit is calculated as of the close of trading for securities traded on a national or regional securities exchange. The NAV per unit is computed by dividing the total fair value of the assets in the fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in the fund and included in the determination of unit values.

**NOTE 4 CERTIFIED INVESTMENT INFORMATION**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule related to investments held at December 31, 2024, and net appreciation in fair value of investments, and interest and dividend income, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank (the trustee of the Plan), a qualified institution. The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing the information with the information included in the financial statements and supplemental schedule.

**NOTE 5 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Company is a party-in-interest to the Plan. However, there were no transactions with the Company other than employer contributions and the payment of certain administrative expenses on behalf of the Plan. The Plan uses third-party service providers for administration and custodian services. These transactions qualify as exempt party-in-interest transactions.

**NOTE 6 TAX STATUS**

The Company has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved Plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in all their employer contributions.

**NOTE 8      RISKS, UNCERTAINTIES, AND CONCENTRATIONS**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

At December 31, 2024, approximately 52 percent and 20 percent of the Plan's investments were invested in the Sloy, Dahl & Holst Aggressive Collective Trust Fund and the Sloy, Dahl & Holst Balance Collective Trust Fund, respectively.
