## Independent Auditor's Report

### Opinion

We have audited the financial statements of the Showplace Wood Products, Inc. Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**Note 1 - Description of Plan**

The following brief description of the Showplace Wood Products, Inc. Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

Showplace Wood Products, Inc. (the Company) established the Showplace Wood Products, Inc. Employee Stock Ownership Plan effective January 1, 2006. The Plan operates as an employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (Code) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is administered by the ESOP Committee, which appoints the Plan's trustee.

**Eligibility**

Each employee who was an active employee of the Company on October 27, 2006 (date of execution of the Plan Document) automatically became a participant in the Plan as of the later of (i) January 1, 2006 or (ii) the employee's date of hire, provided such employee had attained age 18. Thereafter, each employee of the Company is generally eligible to participate in the Plan as of the Plan entry date coincident with or immediately following:

- (a) the date on which the employee completed one year of service (1,000 hours in a consecutive 12-month period), and
- (b) the date the employee attains age 18.

An employee is ineligible if such employee is (i) a member of a collective bargaining unit with retirement benefits; (ii) is employed by a related employer of the Company that is not a participating employer; (iii) is not on the payroll of the Company regardless of whether such individual is considered a "leased employee"; and/or (iv) is a non-resident alien.

Participants who do not have at least 1,000 hours of service during the Plan year or are not employed on the last working day of the Plan year are generally not eligible to receive an allocation of Company contributions for such year.

**Entry Date**

Employees may enter the Plan on the first day of January, April, July, or October coinciding with or following the date on which the employee meets the Plan's eligibility requirements.

## Contributions

The Company may contribute to the Plan an amount which its Board of Directors may from time to time deem advisable and not an amount that would exceed the participant's maximum permissible amount as described in the Plan Document. Contributions may be made in cash or Company securities. Contributions are allocated according to the pro rata share of each participant's compensation to total eligible compensation. During the year ended December 31, 2024, the Company made discretionary contributions of \$4,400,229. Discretionary contributions included 5,768 shares of Company common stock contributed to the Plan.

## Voting Rights

Full and fractional shares of stock in the trust shall be voted by the trustee. The trustee shall follow a participant's instructions for voting of full and fractional shares of stock allocated to the participant's account with respect to the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets of a trade or business, or such similar transaction as may be provided in regulations.

The trustee will vote shares of stock allocated to participants' accounts for which instructions are not received from the participants, and stock contributed to or acquired by the Plan that is not yet allocated, in accordance with instructions from the ESOP Committee that are in the best interests of the participants and that comply with the Code and ERISA.

## Put Option

Under federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market or is subject to trading limitations, must include a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

## Participant Accounts

The Plan is a defined contribution plan under which a separate account is established for each participant. Each participant's account is credited as of the last day of the Plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated accounts, if any, and forfeitures of terminated participants' non-vested accounts, the Company's contribution and Plan earnings. Each participant's account is charged with withdrawals and an allocation of Plan losses and administrative expenses. Stock and forfeiture allocations are based on the participant's eligible compensation, relative to total eligible compensation. Plan earnings and expenses are allocated to each participant's account based on the ratio of the participant's beginning of the year account balance to all participants' beginning of the year account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Vesting in the Company's contributions is based on years of continuous service. Participants vest 20% per year of service starting with the second full year of service and are 100% vested after six years of service.

Notwithstanding the foregoing, a participant's vested percentage will be 100% upon occurrence of any of the following events: (1) participant's reaching of the Plan's normal retirement age; (2) separation from service due to disability; (3) death; (4) termination of the Plan; (5) partial termination of the Plan affecting the participant; or (6) complete discontinuance by the Company of contributions.

### **Forfeitures**

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. Forfeitures of terminated non-vested account balances allocated to remaining participants at December 31, 2024 and 2023 totaled \$298,509 and \$340,104, respectively, representing 293 shares and \$120,342 at December 31, 2024 and 468 shares and \$89,883 at December 31, 2023.

### **Payment of Benefits**

Notwithstanding the availability of distributions to achieve diversification available to participants satisfying certain eligibility conditions, no distributions from the Plan will be made until a participant retires, becomes disabled, dies (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representatives), or otherwise terminates employment with the Company. Distributions are made in the form of Company common shares plus cash for any fractional share or, if a participant elects, in cash.

For a participant whose separation from service results from death, disability, or attainment of normal retirement age, and whose vested account balance exceeds \$1,000 but does not exceed \$7,000, the ESOP Committee will direct the trustee to distribute the participant's account balance in a direct rollover to an eligible retirement plan, unless otherwise requested by the participant. For a terminated participant whose vested account balance does not exceed \$1,000, the ESOP Committee will direct the trustee to distribute the participant's account balance as soon as administratively possible following the end of the Plan year in which the participant incurred a separation from service.

A participant whose separation from service results from reasons other than death, disability or attainment of normal retirement age, and whose vested benefit exceeds \$7,000 can elect to have their vested benefit paid in a single lump sum or paid in a direct rollover to an eligible retirement plan. However, the ESOP Committee may, at its sole discretion and contrary to any participant election, distribute the vested balance attributable to employer securities in substantially equal installments over a period not longer than 5 years, depending on the account balance.

Under the provisions of the Plan, the Company is obligated to repurchase participant shares which have been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations. During the year ended December 31, 2024, the Company repurchased from participants 15,769 shares at prices determined by an independent appraiser.

### **Death Benefits**

The designated beneficiary is entitled to a death benefit distribution equal to the participant's vested account balance.

### **Diversification**

Diversification is offered to participants nearing retirement so that they may have the opportunity to move part of the value of their investment in the Company's common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six year period. In each of the first five years, a participant may diversify up to 25 percent of the Company's stock held. In the sixth year, the participant may elect an amount up to 50 percent of the Company's stock held.

### **Plan Termination**

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan and the Code.

## **Note 2 - Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The ESOP Committee determines the Plan's valuation policies utilizing information provided by the independent appraiser and other third parties.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

## Payment of Benefits

Benefit payments to participants are recorded upon distribution.

## Expenses

All expenses of or relating to the administration of the Plan shall be paid by the Company if not paid by the Plan. Expenses that are paid directly by the Company are excluded from these financial statements.

## Subsequent Events

The Plan Sponsor has evaluated subsequent events through October 1, 2025, the date which the financial statements were available to be issued.

## Note 3 - Investments

The Plan maintained no unallocated shares as of December 31, 2024 and 2023. The Plan's investment in Showplace Wood Products, Inc. common shares is as follows:

During the year ended December 31, 2024, the Plan purchased 5,768 shares and distributed 15,769 shares of Showplace Wood Products, Inc. common stock. The value of these transactions was determined by an independent appraisal. The Plan recorded employer contributions and benefits paid to participants of \$3,921,375 and \$9,575,220, respectively, as a result of these transactions during the year ended December 31, 2024.

**Note 4 - Fair Value Measurement**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market deposit accounts: Valued at carrying value, which approximates fair value, based upon the amount of net contributions plus any investment earnings allocated to the account.

Common stock: The fair value of the Company's common stock held by the Plan is determined based upon an independent appraisal. This appraisal considers a combination of the income, market and asset (or cost) valuation techniques, with an emphasis on the income-based approach. The appraiser takes into account historical and projected cash flows and net income, return on assets, return on equity, market comparability, and fair value of Company assets and liabilities. Plan management has concluded that a market participant would also recognize a discount for lack of marketability.

The valuation process involves the trustee's selection of an independent appraiser. Plan management accumulates the data for the appraiser from the audited financial statement of the Company. The appraiser prepares a preliminary report, which Plan management, along with the trustee and ESOP Committee, review in detail, discuss and approve. The results of this process are documented in minutes of the ESOP Committee.

### Note 5 - Administration of Plan Assets

The Plan's assets, which consist of Showplace Wood Products, Inc. common shares and liquid investments, are held by the trustee of the Plan. Company contributions are held and managed by the trustee, which invests cash received, interest, and dividend income and makes distributions to participants. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses for the trustee's fees are paid directly by the Company.

**Note 6 - Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated December 13, 2017, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. Subsequent to the issuance of the determination letter, the Plan was amended and restated. However, the Company, Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and, therefore believe the Plan is qualified and the related trust continues to be tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7 - Risks and Uncertainties**

The Plan invests primarily in the Company's common stock. Private companies' common stock is exposed to various risks such as interest rate, market, and credit risks as well as valuation assumptions based on earnings, cash flows, and/or other such techniques. Market risks include global events which could impact the value of investments, such as a pandemic or international conflict. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimates and assumptions, it is at least reasonably possible that changes in the value of the stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**Note 8 - Related Party and Party-In-Interest Transactions**

Certain Plan assets, including Showplace Wood Products, Inc. common shares, are held by the trustee of the Plan. These are related party and party-in-interest transactions.

Various recordkeeping and administration services are provided by service providers. Such parties are parties-in-interest under ERISA. Fees for these services are paid by the Company.

**Note 9 - Right of First Refusal**

Company stock that has been distributed to a participant and not immediately repurchased by the Company or trust, may be subject to a right of first refusal as determined by the Company. Prior to any subsequent transfer, the shares must first be offered by written offer to the Company, and then, if refused by the Company, to the trust at fair market value as determined by an independent appraiser appointed by the ESOP Committee.

**Note 10 - Plan Amendments**

Effective January 1, 2024, the Plan was amended to increase the non-elective distribution limit from \$5,000 to \$7,000.

Effective January 1, 2024, the Plan was amended to change the Required Minimum Distribution age from 70 ½ to 70 ½ (if the participant was born before July 1, 1949), age 72 (if the participant was born on or after July 1, 1949, and turned 72 before December 31, 2022) or age 73 (if the participant turns 72 after December 31, 2022).
