Basis for Opinion

Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. THE PLAN

The following description of the Community, Work and Independence, Inc. (the Company) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time union employees of the Company. The Plan provides for an annual fixed employer contribution. Employees who have at least 6 months of service are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Union employees of the Company who have completed the minimum requirements of 6 months of service are eligible to participate in the Plan. Employees of consumer directed programs, all consumer employees and non-bargaining group employees are excluded from the Plan. An employee is credited with one year of service for each twelve consecutive months in which the participant has completed 1,000 hours of service. Upon meeting all eligibility requirements, an employee becomes eligible on the first day of the plan year. An employee must be employed as of the last day of the year to be eligible for a contribution.

Contributions and Contributions Receivable

The Company will contribute a money purchase contribution to the Plan for each employee that meets the eligibility requirements. The Company's contribution during 2024 and 2023 was 3% of eligible participants' annual compensation, which meets the minimum funding requirement. The Plan also allows rollover contributions from other qualified plans. Contributions are remitted to the custodian and are invested in accordance with the provisions of the Plan.

Investments

The Plan utilizes one custodian. The Plan currently offers several mutual funds, and one money market fund through an investment company. Participants direct the investment of all funds and they may change their investment options daily.

Participant Accounts

Each participant's account is credited with an allocation of (a) the Company's contribution, (b) Plan earnings (losses), and in some cases, (c) forfeitures of terminated participants' non-vested accounts. Allocations are based on participant earnings or account balances, as defined. The entitled benefit is the participant's account balance subject to vesting.

Vesting

Vesting in the Company's contribution portion of the participants' accounts, plus earnings/losses thereon, is based on years of continuous service. A participant is vested 100% in Company contributions after three years of service. In the event the Plan becomes top heavy, an accelerated vesting schedule will apply.

1. THE PLAN (Continued)

Forfeitures

Per the plan document, forfeitures are first used to reduce the employer contribution. During 2024 and 2023, employer contributions were reduced by \$222 and \$53, respectively. The employer contributions were reduced using forfeited non-vested amounts. There were no forfeitures available for use at December 31, 2024 and 2023.

Payment of Benefits

Upon termination or retirement, a participant is entitled to receive an amount equal to the value of his/her vested balance in their account in a lump sum amount, installment payments, or an annuity. The Plan offers in-service distributions of a portion of a participant's account after attaining normal retirement age as an option for payment of benefits while still employed. Benefits to participants are recorded when paid.

Administrative Expenses

The majority of the administrative expenses of the Plan are paid by the Company. Certain participant transaction fees are paid by the Plan participant. Administrative service fees are also charged to inactive and terminated participants.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

Risks and Uncertainties

Investments in mutual fund securities and money market funds are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with these investments, it is at least reasonably possible that changes in values will occur in the near term and those changes could materially affect the amounts reported in the statements of assets available for benefits.

Investment Valuation and Income Recognition

Investments are stated at fair value based upon quoted market prices. Changes in the current value of investments, including realized and unrealized gains and losses on assets sold/held during the year, are reflected in the statements of changes in assets available for benefits as net appreciation (depreciation) in fair value of investments. Dividends are recorded on the ex-dividend date and purchases and sales of securities are recorded on a trade-date basis (the date the order to buy or sell is executed). Interest income is recognized on the accrual basis.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurements

The Plan has financial instruments, which are recorded at fair value in the accompanying statements of net assets available for benefits. The Plan makes estimates regarding the valuation of assets measured at fair value in the financial statements. These assets include the investments in mutual funds and money market funds.

Fair Value Measurement - Definition and Hierarchy

U.S. GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan uses various valuation techniques in determining fair value. U.S. GAAP establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available. Observable inputs are inputs that market participants would use in pricing the asset or liability developed based on market data obtained from sources independent of the Plan. Unobservable inputs are inputs that reflect the Plan's assumptions about the assumptions market participants would use in pricing the asset or liability, developed based on the best information available in the circumstances. The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.

The Plan's investments in mutual funds and money market funds are primarily valued utilizing Level 1 inputs.

- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.

The Plan currently has no investments utilizing Level 2 inputs.

- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The Plan currently has no investments utilizing Level 3 inputs.

The availability of observable inputs can vary and is affected by a wide variety of factors. To the extent that valuation is based on models or inputs that are less observable or unobservable in the market, the determination of fair value requires more judgment. Accordingly, the degree of judgment exercised by the Plan in determining fair value is greatest for instruments categorized in Level 3. In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes the level in the fair value hierarchy within which the fair value measurement in its entirety falls is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

A description of where the Plan's investments fall within the fair value hierarchy is provided in Note 4.

The following is a description of the valuation methodology used for assets measured at fair value.

Mutual funds and money market fund: Valued based on the amount reported by Glens Falls National Bank and Trust Company, based on the quoted market price of the investments.

There were no changes in valuation techniques during 2024 or 2023.

4. FAIR VALUE MEASUREMENTS (Continued)

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Company believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. TAX STATUS

The Plan is tax-exempt under Section 401(a) of the Internal Revenue Code. The Plan is required to operate in conformity with the Internal Revenue Code to maintain its tax-exempt status for Plan participants. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

7. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.
