NOTES TO FINANCIAL STATEMENTS

Note 1 - Description of Plan

The following description of the Big Springs/Chambers (the Company) 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution, employer plan covering all employees of the Company, except collectively bargained employees, who have worked at least five hundred hours during the first six months of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Beginning January 1, 2009, the Trustee of the Plan became Capital Bank & Trust Company, and the Plan's investment options consisted primarily of American Funds. Further, beginning September 5, 2024, the Trustee of the Plan became EPIC retirement plan services, and the investment options consisted primarily of Vanguard Funds.

Contributions: Each year, participants may contribute up to fifteen percent (15%) of annual pay, as defined in the Plan. Participants may elect to make all pre-tax deferrals, all roth deferrals, or a combination of these deferral types each pay period. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Company contributes fifty percent (50%) of the participant's deferred contribution up to five percent (5%). Deferred contributions in excess of five-percent (5%) are not matched. Additional amounts may be contributed at the option of the Company's board of directors. Contributions are subject to certain limitations.

Participant Accounts: Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution; (b) Plan earnings; and (c) forfeitures of terminated participants' non-vested accounts and charged with an allocation of administrative expenses. Allocations are based on participant account balances, as defined. Forfeited balances of terminated participants' non-vested accounts are used to offset administrative expenses and the Company's contribution to the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts is based on years of continuous service. A participant is one hundred percent (100%) vested in matching and discretionary contributions after three years of credited service.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or one-half of their vested account balance. The notes receivable from participants are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%. The maximum number of Plan loans that a participant may have outstanding at any given time is one. Note terms may generally not exceed 5 years. Repayments of the amount of such loan shall be credited directly to such borrower's account in a manner consistent with the borrower's current investment elections.

Payment of Benefits: Upon termination of employment, a participant may elect to receive either a lump-sum amount equal to the value of his or her account or the value of the benefits in the form of a joint and survivor annuity. The joint and survivor annuity shall be equal to a single life annuity.

Investment Options - Participants direct contributions, including employer matching and discretionary contributions, into any of the investment options available under the Plan. Participants may change their investment elections daily online.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting: The accompanying financial statements have been prepared on the accrual basis of accounting.

Administrative Expenses: Forfeitures are used to offset administrative expenses and the Company's contributions to the Plan. Administrative expenses charged to the individual investments represent service charge deductions.

Related Party Transactions: All of the Plan's investments are managed by Pinnacle Financial Partners. All of the investment transactions related to the investments managed by Pinnacle Financial Partners qualify as party-in-interest transactions.

Contributions: Employee elective contributions are recorded in the period in which the employer makes the deductions from the participant's payroll. Employer matching contributions are recorded in the same period.

Net Appreciation in Fair Value of Investments: Realized gains (losses) and unrealized appreciation are recorded in the accompanying financial statements as net appreciation in fair value of investments.

Payment of Benefits: Benefits are recorded when paid.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Investments are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent loans are treated as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates. The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the financial statements.

Date of Management's Review: Subsequent events were evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

Note 3 - Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none">• quoted prices for similar assets or liabilities in active markets;• quoted prices for identical or similar assets or liabilities in inactive markets;• inputs other than quoted prices that are observable for the asset or liability;• inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common stocks, corporate bonds and U.S. government securities: Valued at the closing price reported on the active market on which the individual securities are traded.

Mutual funds: Valued at the net asset value (NAV) of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be one hundred percent (100%) vested in their accounts.

Note 6 - Tax Status

The Plan obtained its latest determination letter on June 30, 2020 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The determination letter is applicable for the amendments and restatements adopted as of January 1, 2023 & September 5, 2024. The plan administrator and the plan's tax counsel believe that the plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 7 - Information Certified by Trustee

The accompanying information included in these financial statements and supplemental schedule relating to investments and investment transactions as of December 31, 2024 and 2023 was provided, and certified as complete and accurate, by Mid Atlantic Trust Company, as Trustee with the exception of receivables, whose balances are not part of the trust statements. No audit work was performed with respect to the certified information except for comparing such information with the related information included in the financial statements and supplemental schedule:
