Basis for Opinion

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. THE PLAN

The following description of the Community, Work and Independence, Inc. (the Company) 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution and profit-sharing plan intended to qualify as a cash or deferred arrangement under Section 401(k) of the Internal Revenue Code. The Plan covers substantially all full-time administrative employees of the Company. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Administrative employees and non-bargaining group employees of the Company are eligible to participate in the Plan. Employees of consumer directed programs, union employees, and all consumer employees are excluded from the Plan. There are no age or service requirements for an employee to make elective deferral contributions. In order to be eligible for a matching contribution or profit-sharing contribution, a participant must be employed on the last day of the plan year and have completed at least 1,000 hours of service.

Contributions and Contributions Receivable

Participants may elect to contribute, on a pre-tax basis (elective deferrals), from 1% to 100% of their compensation up to a maximum calendar year limit, as defined by the IRS. The Company may make a qualified matching contribution to the Plan on behalf of the participants equal to a discretionary percentage of the employees' salary deferrals. The matching contribution may also be limited to salary deferrals of a certain amount or a certain percentage of each employees' compensation. In 2024 and 2023, the matching contribution was 100% of employees' salary deferrals, up to 2% of employees' compensation.

At its discretion, the Company may also contribute a profit-sharing contribution to the Plan for each employee that meets the eligibility requirements. The Company's profit-sharing contribution was 3% of each employees' compensation for both 2024 and 2023.

Investments

The Plan utilizes one custodian. The Plan currently offers several mutual funds and a money market fund through an investment company. Participants direct the investment of all funds and they may change their investment options daily.

1. THE PLAN (Continued)

Participant Accounts

Each participant's account is credited with an allocation of (a) the Company's contribution, (b) Plan earnings (losses), and in some cases (c) forfeitures of terminated participants' non-vested accounts. Allocations are based on participant earnings or account balances, as defined. The entitled benefit is the participant's account balance subject to vesting.

Vesting

Participants are immediately vested in their voluntary contribution, plus actual earnings/losses thereon. Vesting in the Company profit sharing contribution and employer matching contribution portion of individual accounts, plus earnings thereon, is based on years of continuous service. For the employer matching contribution and the profit-sharing contribution, a participant becomes 100% vested after three years of service. The Company does not have an incremental vesting schedule; therefore, participants are fully vested after they complete the minimum years of service.

Forfeitures

Per the plan document, forfeitures are used to reduce the employer profit sharing contribution. During 2024 and 2023, employer contributions were reduced by approximately \$2,451 and \$1,120, respectively. The employer contributions were reduced using forfeited non-vested amounts. At December 31, 2024 and 2023, the forfeited nonvested accounts totaled \$2,451 and \$21, respectively.

Payment of Benefits

Upon termination or retirement, a participant is entitled to receive an amount equal to the value of the participant's vested interest in their account in a lump sum amount, installment payments, or an annuity. The Plan offers in-service distributions of a portion of a participant's account after attaining normal retirement age as an option for payment of benefits while still employed. Benefits to participants are recorded when paid.

Administrative Expenses

The majority of the administrative expenses of the Plan are paid by the Company. Certain participant transaction fees are paid by the Plan participants. Administrative service fees are also charged to inactive and terminated employees.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

Risks and Uncertainties

Investments in mutual fund securities and money market funds are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with these investments, it is at least reasonably possible that changes in values will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

Investments are stated at fair value based upon quoted market prices. Changes in the current value of investments, including realized and unrealized gains and losses on assets sold during the year, are reflected in the statements of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments. Dividends are recorded on the ex-dividend date and purchases and sales of securities are recorded on a trade-date basis (the date the order to buy or sell is executed). Interest income is recognized on the accrual basis.

Financial Instruments Measured at Fair Value

The Plan has financial instruments which are recorded at fair value in the accompanying statements of net assets available for benefits. The Plan makes estimates regarding the valuation of assets measured at fair value in the financial statements. These assets include the investments in mutual funds and money market funds.

Fair Value Measurement - Definition and Hierarchy

U.S. GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan uses various valuation techniques in determining fair value. U.S. GAAP establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available. Observable inputs are inputs that market participants would use in pricing the asset or liability developed based on market data obtained from sources independent of the Plan. Unobservable inputs are inputs that reflect the Plan's assumptions about the assumptions market participants would use in pricing the asset or liability, developed based on the best information available in the circumstances. The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.

The Plan's investments in mutual funds and money market funds are primarily valued utilizing Level 1 inputs.

- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.

The Plan currently has no investments utilizing Level 2 inputs.

- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The Plan currently has no investments utilizing Level 3 inputs.

The availability of observable inputs can vary and is affected by a wide variety of factors. To the extent that valuation is based on models or inputs that are less observable or unobservable in the market, the determination of fair value requires more judgment.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Financial Instruments Measured at Fair Value (Continued)

Accordingly, the degree of judgment exercised by the Plan in determining fair value is greatest for instruments categorized in Level 3. In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes the level in the fair value hierarchy within which the fair value measurement in its entirety falls is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

A description of where the Plan's investments fall within the fair value hierarchy is provided in Note 4.

The following is a description of the valuation methodology used for assets measured at fair value.

Money market funds and mutual fund: Valued based on the amount reported by Glens Falls National Bank and Trust Company, based on the quoted market price of the respective money market and mutual funds.

There were no changes in valuation techniques during 2024 or 2023.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. TAX STATUS

The Plan is tax-exempt under Section 401(a) of the Internal Revenue Code. A prototype document was used by the Plan to obtain its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.
