Opinion

1. Description of Plan

The following description of the Gustman Chevrolet Sales, Inc. Employee Benefit Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a contributory plan established effective January 1, 1990, as restated January 1, 2020, sponsored by the following companies, collectively known as the Gustman Group (the Companies): Gustman Chevrolet Sales, Inc., Gustman Motor Company, Inc. and Gustman Subaru, Inc. The Plan provides medical, dental and optical benefits covering substantially all full-time hourly and salaried employees of the Companies (and, where applicable, their enrolled eligible dependents) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Companies' employee benefit plan committee is responsible for oversight of the Plan.

Eligibility

All full-time employees of the Companies are eligible to be covered under the Plan after completing 90 days of continuous active employment. In general, all coverage under the Plan is terminated upon employee failure to pay required contributions; termination of full-time employment; cancellation of coverage; loss of dependency status; or termination of any part or all of the Plan. Specific exclusions are detailed in the Plan. Upon termination of employment for any reason, except disability or misconduct on the job, a medical expense benefits continuation privilege is provided for covered persons for medical, dental and optical benefits in accordance with provisions of the Consolidated Omnibus Budget Reconciliation Act (COBRA) of 1986.

Contributions

The Plan is a self-insured health and welfare plan that is funded through employee and employer contributions made directly to the Plan by the Companies, the trustees of the Plan. All claims and expenses are funded directly from employee and employer contributions via the trustees to the third-party claims administrator. Employee contributions consist of premiums charged per the Companies. Management targets having the employees fund between 25% and 35% of the costs of the Plan, depending on the specific plan option that is chosen. Employer contributions are any payments to cover additional claims above and beyond the premiums cost.

Payment of Benefits

The Plan covers medical, sickness and accident, dental, optical, life, dependent life, disability and prescription drug coverage of eligible employees enrolled in the Plan and their eligible spouses and dependents as specified in the Plan. Benefit payments are processed by third-party administrators. The third-party administrators process claims submitted by participants and determine the benefits to be paid based on the provisions of the Plan.

Stop-Loss Coverage

The Plan has an agreement with an insurance company for stop-loss coverage for health and dental claims in an effort to limit its exposure for self-insurance benefits. Coverage for plan years ended December 31, 2024 and 2023 provides for reimbursement annual costs in excess of \$125,000. As of December 31, 2024 and 2023, no amounts were due to the Plan for stop-loss coverage.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. The Plan pays third-party administrators for their assistance in handling and processing claims information. In addition to the third-party administrator fees, the Plan also pays for audit fees and various bank charges incurred.

2. Summary of Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared on the accrual basis of accounting. The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from these estimates.

Cash and Cash Equivalents

The Plan defines cash and cash equivalents as highly liquid, noninterest bearing, short-term investments with a maturity at the date of acquisition of three months or less. The Plan maintains its cash balances at financial institutions, which, at times, may exceed federally insured limits. The Plan has not experienced any losses in these accounts and believes it is not exposed to any significant risk of loss.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by investment advisors of the Plan. Refer to Note 3, *Fair Value Measurements*, for details on inputs, valuation techniques and fair value measurement level within the fair value hierarchy.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Payment of Benefits

Premiums paid by either the Companies or employees are recorded as contributions in the accompanying Statement of Changes in Plan Benefit Obligations and Net Assets Available for Benefits. Claim payments are recorded when paid by the third-party claims administrators.

Stop-Loss

Premiums for stop loss insurance totaling \$354,879 are separately stated in the accompanying Statement of Changes in Plan Benefit Obligations and Net Assets Available for Benefits. There were no stop loss refunds netted with claims paid in the accompanying Statement of Changes in Plan Benefit Obligations and Net Assets Available for Benefits for the year ended December 31, 2024.

Refunds

Refunds due from the Plan's prescription drug plan are recorded when earned. Refunds due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. The Plan was due \$57,460 and \$45,920 for rebates related to the prescription drug plan as of December 31, 2024 and 2023, respectively.

Claims Payable and Incurred but Not Reported

The Plan's liability for claims payable and incurred but not reported is estimated based on information provided by the third-party administrators of the Plan. The information consists of actual payments made subsequent to the financial statement date that were incurred prior to or on the financial statement date. The estimate also takes into consideration prior claims experience and the expected time period from the date such claims are incurred to the date the related claims are submitted and paid. The plan sponsors believe this information is sufficient to make a reasonable estimate of the claims payable and incurred but not reported for current benefit coverage. It is possible that significant changes from the estimates could occur.

The Plan's liability for claims payable and incurred but not reported is \$80,000 and \$64,000 as of December 31, 2024 and 2023, respectively, which is gross of any stop-loss reimbursements.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, which is the date that the financial statements were approved and available to be issued, for events requiring recording or disclosure in the Plan's financial statements.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Money market funds: Valued at the quoted net asset value (NAV) of shares held by the Plan at year-end.

Certificate of deposit accounts: These investments are interest-bearing cash accounts stated at cost, which approximates fair value.

4. Concentrations

5. Related-Party and Party In Interest Transactions

Fees for claims processing and other services rendered by parties-in-interest are paid by the Plan. Plan management believes that the fees paid to parties-in-interest were based upon customary and reasonable rates for such services.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

6. Plan Termination

Although it has not expressed any intent to do so, the Companies have the right under the Plan to modify the benefits provided to and contributions required of, participants and dependents, to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan is terminated, any covered expenses which have been incurred prior to the date of termination will be payable in accordance with the terms and conditions of the Plan. Plan assets will first be allocated to the payment of claims and thereafter in a manner that is for the exclusive benefit of the participants, except for any taxes and administrative expenses that may be made from plan assets. No assets of the Plan may revert to the Companies or be used for purposes other than for the exclusive benefit of the Plan's participants.

7. Tax Status

The Trust that has been established to collect funds from the Companies and pay claims and plan expenses is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC) and, accordingly, is a nontaxable trust.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Plan Benefit Obligations and Net Assets Available for Benefits.
