### NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

#### 1. Description of Plan

The following description of Editorial Projects in Education 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### *General -*

The Plan is a defined contribution plan covering substantially all full-time employees of Editorial Projects in Education, Inc. (the Plan Sponsor). The Plan was established on January 1, 1978, and was most recently amended and restated effective January 1, 2022. In addition, the Plan was further amended to incorporate the CARES Act changes on March 2, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### *Eligibility -*

All employees, except for certain nonresident aliens who have no earned income from sources within the United States, leased employees and interns, are eligible to make elective deferrals into the Plan and receive employer contributions beginning on their date of hire. There is no minimum age or service period that an employee must attain to become a participant in the Plan. However, certain vesting requirements apply for the employer contributions.

##### *Contributions -*

Under the terms of the Plan, participants may make voluntary contributions to the Plan up to 100% of their annual compensation as defined by the Plan, subject to Federal limitations. The Plan also allows for catch up contributions for participants who are 50 and older. All contributions are subject to certain IRS limitations. The Plan includes auto-enrollment with a default contribution rate of 5% and auto-escalation of 1% per year, up to a maximum of 10% of compensation. Participants are provided proper notice and time to opt out, or make a deferral election, other than the auto-enrollment default contribution rate. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan Sponsor may make a flexible discretionary employer match of the same percentage for each participant. The match was 3% during the years ended December 31, 2024 and 2023. The Plan Sponsor may also make additional discretionary employer contributions, but there were none for the years ended December 31, 2024 and 2023.

##### *Vesting -*

Participants are fully vested in their elective deferral contributions and employee rollover contributions, plus actual earnings thereon.

#### 1. Description of Plan (Continued)

##### *Vesting (continued) -*

Participants are vested in employer contributions based on years of continuous service. A participant is fully vested after four years of credited service as follows:

1	25%
2	50%
3	75%
4	100%

##### *Participant Accounts -*

Each participant's account includes (a) investment earnings and losses, (b) the employee's contributions, and (c) the employer's contributions. Participants' accounts are also charged with an allocation of administrative fees that are paid by the Plan. Allocations of investment earnings and losses and administrative fees are based on either a participant's account balance or specific participant transactions, as defined in the Plan document.

##### *Investment Elections -*

Contributions to the Plan are invested according to participant instructions. The Plan Sponsor has selected a list of investment options and has provided participants with information describing these investment options.

##### *Payment of Benefits -*

Benefits provided by the Plan are paid from net assets available for benefits. The benefit to which a Plan participant is entitled is the benefit that can be provided by the contributions and net earnings thereon allocated to such participant's account. Benefit payments are made in the form of participant directed lump sum, installment, or annuity payments upon separation, retirement, total and permanent disability, or death, as applicable. Benefits are recorded when paid whether directly to or on behalf of a participant.

If the total vested value is below \$1,000 in a participant's account at the time of termination, then a distribution will be made to the participant regardless of whether they consent to receive it. If the total vested value is greater than \$1,000, but less than \$5,000, the participant has the option of either 1) rolling over their balance into a qualified individual retirement account, or 2) receiving a distribution. If the vested value is greater than \$5,000, the participant may remain in the Plan.

### NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

#### 1. Description of Plan (Continued)

##### *Payment of Benefits (continued) -*

Hardship distributions to employees are permitted if certain conditions are met.

The Plan also provides for minimum required distributions per IRS regulations by April 1 of the calendar year following the later of the calendar year in which the participant reaches age 73 or the calendar year the participant retires. In addition, participants may elect in-service withdrawals of their vested account balances after reaching age 59½.

##### *Forfeited Non-Vested Accounts -*

Forfeited balances of terminated participants' non-vested accounts may be used to reduce the employer contributions. The Plan Sponsor used \$6,592 and \$5,108 of the forfeiture balance to reduce employer contributions during the years ended December 31, 2024 and 2023, respectively. There were no forfeited non-vested account balances as of December 31, 2024 and 2023.

##### *Notes Receivable from Participants -*

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Principal and interest is paid ratably through payroll deductions. Note terms are up to five years, except for notes to fund the purchase of a principal residence, for which the note may be repaid over a reasonable period that may exceed five years. All notes receivable from participants are secured by the balance in the participant's account. Interest rates on loans to participants range from 3.25% to 8.50% with maturities through March 31, 2036.

##### *Plan Termination -*

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their accounts.

#### 2. Summary of Accounting Policies

##### *Basis of Accounting -*

The financial statements are prepared on the accrual basis of accounting and in accordance with FASB ASC 962, *Plan Accounting Defined Contribution Pension Plans*.

##### *Use of Estimates -*

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Sponsor to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

##### *Valuation of Investments -*

Investments in registered investment companies are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion on fair value measurements.

Investments in the guaranteed investment contract that is non benefit-responsive are stated at fair value, which is determined by the insurance carrier by discounting the related cash flows based on current yields of similar instruments with comparable durations and considering the creditworthiness of the issuers. Participants transact at contract value during the year, but fair value is determined annually for financial statement reporting purposes.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains on investments bought and sold as well as held during the year.

##### *Notes Receivable from Participants -*

Notes receivable from participants are measured at their unpaid principal balance, plus accrued interest. Delinquent loans are treated as distributions based upon the terms of the Plan document. Delinquent loans are loans for which any scheduled repayment remains unpaid at the end of the period specified in the loan documents and any loans for which there is an outstanding principal balance existing after the last scheduled repayment date.

##### *Payment of Benefits -*

Benefits are recorded when paid.

##### *Administrative Fees -*

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and some are paid by the Plan, which are included in these financial statements. Investment-related expenses are included as a reduction in the net appreciation of fair value of investments presented in the accompanying Statements of Changes in Net Assets Available for Benefits. Expenses that are paid by the Plan Sponsor are excluded from these financial statements.

##### *Subsequent Events -*

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 9, 2025, the date the financial statements were available to be issued.

#### 3. Income Tax Status

The Plan was established as a qualified plan under Section 401(k) of the Internal Revenue Code (IRC). The prototype plan obtained its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service (the IRS) indicated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC and was qualified and tax-exempt. The Plan was amended and restated on January 1, 2022, and most recently amended on March 2, 2023. Management of the Plan, in consultation with its legal counsel, believes that the Plan continues to meet the requirements of Section 401 of the IRC. Therefore, the Plan Administrator believes that the Plan was qualified and tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 4. Information Certified by Qualified Institution

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan's Administrator instructed the Plan's independent auditors not to perform, and they did not perform, such auditing procedures with respect to the information certified by the qualified institution.

For the 2024 and 2023 Plan years, Matrix Trust Company, the qualified institution, issued Certification Statements. The Certification Statements issued by the qualified institution certified the investments and notes receivable from participants presented in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the investment income presented in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023.

#### 5. Party-In-Interest Transactions

The Plan's investments are held by Matrix Trust Company, the custodian, which provides record keeping, Plan management, and day-to-day support to the Plan. Therefore, transactions with the custodian qualify as party-in-interest transactions.

The Plan has engaged Cuna Mutual Group to prepare the Plan's Form 5500 and provide third party administrator services. Therefore, transactions with Cuna Mutual Group qualify as party-in-interest transactions.

#### 6. Risks and Uncertainties

The Plan invests in investment securities, which are exposed to various risks such as interest rates, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

#### 7. Non Benefit-Responsive Investment Contract

The Plan has a non benefit-responsive investment contract with Cuna Mutual Group, the insurance carrier, called CMGF Stable Value, which is a deposit administration group annuity contract. The insurance carrier maintains the contributions in a general account. The general account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative fees. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Fair value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the non benefit-responsive contract. Fair value, as reported by the insurance carrier to the Plan, represents the discounted cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuers. The fair value of the non benefit-responsive contract totaled \$38,565 and \$33,511 as of December 31, 2024 and 2023, respectively.

The market rate, which is used in determining the fair value of the non benefit-responsive investment contract, is a U.S. Corporate Bond Index with a range of maturities from 7 to 10 years and the lowest investment grade quality credit rating published by an independent third party.

#### 8. Fair Value Measurements

In accordance with FASB ASC 820, Fair Value Measurement, the Plan has categorized its financial instruments, based on the priority of the inputs to the valuation technique, into a three-level fair value hierarchy. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). If the inputs used to measure the financial instruments fall within different levels of hierarchy, the categorization is based on the lowest level input that is significant to the fair value measurement of the instrument.

Investments recorded in the Statements of Net Assets Available for Benefits are categorized based on the inputs to valuation techniques as follows:

**Level 1.** These are investments where values are based on unadjusted quoted prices for identical assets in an active market the Plan has the ability to access.

**Level 2.** These are investments where values are based on quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, or model-based valuation techniques that utilize inputs that are observable either directly or indirectly for substantially the full-term of the investments.

**Level 3.** These are investments where inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for investments.

- *Registered Investment Companies (Mutual Funds)* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. Mutual funds are required to publish their daily value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.
- *Non Benefit-Responsive Investment Contract* - Valued at fair value and includes CMFG Stable Value. Fair value is determined by the insurance carrier, by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuers. Because the participants transact at contract value, fair value is determined annually for financial statement reporting purposes. Benefits under the non benefit responsive options have liquidity restrictions. Distributions, withdrawals, and transfers out of the non benefit-responsive option are made in accordance with the terms of the contract.
