## Notes to Financial Statements

### **Note 1. Description of Plan**

The following description of the MEBA 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan Regulations for a more comprehensive description of the Plan's provisions.

#### **General**

The Plan is a multiemployer defined contribution and profit-sharing plan covering Licensed Officers covered thereunder and to Port Engineers, Port Electricians and Hull Inspectors, established under the provisions of an Agreement and Declaration of Trust among National Marine Engineers' Beneficial Association, AFL-CIO and various Employers of Licensed Officers having collective bargaining agreements with District No. 1-PCD, MEBA (Union). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Contributions**

Participants' elective contributions represent amounts paid by an employer, at the election of the employee, in lieu of cash compensation and include contributions that are made pursuant to a salary reduction agreement. Participants may contribute, in whole percentage or dollar amount, pre-tax annual compensation, as well as after tax and Roth contributions up to the amounts permissible under Internal Revenue Code Section 402(g). The Plan also accepts participant rollover contributions, catch-up contributions, employer matching contributions, employer non-elective contributions, and make-up contributions by returning veterans.

Effective July 1, 2016, the bargaining parties agreed to an annual reallocation of up to \$1.82 per man day plus Feinberg employer payment from the MEBA Medical and Benefits Plan to the Plan to be applied to the Plan's administrative expenses, with the remaining portion allocated to the MEBA Training Plan. The Plan is allocated the portion of the \$1.82 per man day plus Feinberg that is determined by the Union, based on an estimate of the amount needed to cover the administrative costs of the Plan for the plan year that will not be covered by the Plan's revenue sharing agreement with Fidelity Management Trust Company (refer to Note 5). The amount allocated to the Plan is subject to adjustment after an annual reconciliation to be performed as soon as practicable after the close of each plan year to determine the amount, if any, by which the portion of the allocated \$1.82 per man day plus Feinberg directed by the Union exceeded or was insufficient to cover the net administrative expenses of the Plan for that plan year. Such amount, if any, shall be paid by the MEBA 401(k) Plan or MEBA Training Plan to the other as soon thereafter as the amount can be determined.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, employer contributions, and allocation of Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon.

## **Notes to Financial Statements**

### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of the fair market value of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loans fund. Loan terms are up to 5 years for general purposes or up to 20 years for the purchase of a principal residence. The loans are collateralized by the balance in the participant's account and bear interest at a rate equal to 1% above the prime rate as calculated by Reuters on the last day of the month preceding the month in which application for the loan is made.

### **Payment of Benefits**

Upon retirement, termination, or disability, a participant may elect to receive either a lump-sum amount equal to the value of the participant's account or have the balance paid in monthly installments over 36, 60 or 120 months until the account is exhausted. In the event of a participant's death, a lump-sum amount equal to the value of the participant's account will be paid to the surviving spouse, unless the participant and the surviving spouse have designated in writing another beneficiary. In the event of hardship, as defined by the Plan, a participant has the right to withdraw up to the amount of the hardship, all or a part of his elective contributions account, but not in excess of the actual contributions on his behalf determined as of the date of distribution.

## **Note 2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The Plan's financial statements are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (US GAAP) requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Advisory Committee determines the Plan's valuation policies and procedures, utilizing information provided by the investment advisers and custodians, and reports to the Plan's Board of Trustees. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Cash**

The Plan considers all non-interest bearing cash deposits to be cash.

### **Contributions**

Contributions from Plan participants and employers are recorded in the year in which the employee contributions are withheld from compensation.

## Notes to Financial Statements

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

### Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

### Payment of Benefits

Benefits are recorded when paid.

### Expenses

All costs and fees incurred in administering the Plan (costs and fees that are not deductions from investment funds) are paid by the Plan with employer contributions directed to the Plan by the bargaining parties and are reflected in these financial statements.

### Plan Management's Review of Subsequent Events

The Plan has evaluated subsequent events and transactions through October 13, 2025, the date the financial statements were available to be issued.

## Note 3. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2      Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

### Notes to Financial Statements

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Participant-directed brokerage accounts: Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

#### **Note 4. Related Party Transactions and Party in Interest Transactions**

The Plan operates in the same office as related plans and other entities. Since these plans and other entities coexist in the same premises, utilizing mutual resources and personnel to effectuate cost savings and to minimize duplication of efforts, interfund relationships have been established on a continuing basis.

The amount charged to the Plan for its share of payroll and related expenses and rent expenses incurred on behalf of the Plan was \$149,998 and \$102,152 for the years ended December 31, 2024 and 2023, respectively.

Certain plan investments are shares of registered investment companies managed by Fidelity Management Trust Company (Fidelity). Plan administrative expenses of \$95,871 and \$92,560 were paid by the Plan to Fidelity, the trustee of the Plan, for the plan years ended December 31, 2024 and 2023, respectively. In addition, the Plan received \$48,937 and \$33,139 from Fidelity for the plan years ended December 31, 2024 and 2023, respectively, related to revenue sharing, which is a return of service fees that Fidelity receives from the Plan's investment funds. These transactions qualify as exempt party-in-interest transactions.

#### **Note 5. Plan Termination**

The right to terminate the Plan is reserved to the Trustees. In the event of termination, benefits will be distributed to the participants and their beneficiaries in accordance with the Plan's provision.

#### **Note 6. Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Plan by a letter dated November 6, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code and, therefore, the related trust is exempt from taxation. The Plan was amended since receiving the determination letter. However, the plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code. Therefore, the plan administrator believes that the Plan was qualified, and the related trust was tax exempt as of the financial statements date.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## Notes to Financial Statements

### Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Note 8. Prohibited Transactions

During 2024 and 2023, participant contributions of \$194,672 and \$112,987, respectively, were not transferred to the Plan within the time period described in 29 CFR 2520.3-102. The contributions were remitted to the Plan as soon as the error was discovered, and lost earnings were or are in the process of being remitted to the participants' accounts.


