## Independent Auditors' Report

To the Participants and Plan Administrator of  
PPL Retirement Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of PPL Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

## 1. PLAN DESCRIPTION

The PPL Retirement Savings Plan (the "Plan") is a defined contribution plan designed to comply with the requirements of the Employee Retirement Income Security Act of 1974, as amended ("ERISA") and the requirements for qualification under Section 401(a) of the Internal Revenue Code (the "Code") and includes a cash or deferral arrangement that is intended to comply with the requirements for qualification under Section 401(k) of the Code, allowing for pre-tax contributions. The Plan is administered by the Employee Benefit Plan Board (the "Plan Administrator") of PPL Corporation ("PPL"). The Plan is sponsored by PPL Services Corporation (the "Company"). The Company has reserved the right to amend or terminate the Plan at any time.

An employee of the Company and each other affiliated company which is designated by the Plan Administrator to adopt the Plan (a "Participating Company" and, collectively, "Participating Companies") who is classified by their employer as a common law employee and either (a) was hired on or after January 1, 2012, and is not covered by a collective bargaining agreement ("Salaried Employee") or (b) is covered by a collective bargaining agreement with IBEW Local 1600 and initially hired on or after July 1, 2014 ("Bargaining Unit Employee") is eligible to participate in the Plan (Bargaining Unit Employees are eligible on the first day of the month following the date of employment). With the consent of the Plan Administrator, an employee may make rollover contributions to the Plan of the amounts distributed from other plans which are qualified under Section 401(a) of the Code.

Salaried Employee participants may elect a percentage reduction in their compensation of between 2% to 20% and Bargaining Unit Employee participants may elect a percentage reduction in their eligible compensation of between 2% to 50%, and have this salary reduction in compensation remitted to the Plan by the Participating Company as pre-tax, after-tax and/or Roth contributions. Participants who do not make an election to contribute or who do not affirmatively opt out of participating are automatically enrolled in the Plan with a pre-tax contribution of 6% of compensation. If a Salaried Employee participant who is automatically enrolled does not affirmatively change the election percentage before the anniversary of their automatic enrollment at 6%, such automatic election will then be increased to 7% of compensation and will increase by 1% each anniversary thereafter up to 10%. Under the Code, the maximum amount participants could contribute on a pre-tax and Roth basis for 2024 was \$23,000 and for 2023 was \$22,500. Participants that are age 50 or older by the end of the year can make additional catch-up contributions up to 75% of their compensation. Under the Code, the maximum amount of catch-up contributions was \$7,500 for 2024 and 2023. Compensation means the base pay of a participant plus overtime and, for Salaried Employee participants, any short-term incentive, including any salary reduction contributions or pre-tax contributions to the PPL Cafeteria Plan.

Prior to the 2023 plan year, Participating Companies contributed an amount equal to 100% of the first 3% of a participant's compensation for each pay period, regardless of any pre-tax, after-tax and/or Roth 401(k) contributions participants elected to make. These contributions have continued for Bargaining Unit Employees participants, whereas, effective January 1, 2023, for Salaried Employee participants, Participating Companies make contributions based on the following schedule:

Less than 6	3%
6 but less than 11	4%

For Salaried Employee participants, the matching contribution is 100% of the participant's pre-tax, after-tax and/or Roth 401(k) contributions up to 3% of the participant's compensation and then 50% of such contributions up to the next 3% of the participant's compensation. For a Bargaining Unit Employee participant, the matching contribution is 75% of the participant's pre-tax, after-tax, and/or Roth 401(k) contributions up to 6% of the participant's compensation.

Participants can change the amount they contribute and their investment options at any time. Contributions are allocated to the participant's investment fund accounts based upon the participant's election or, if no such election is made, to the Plan's Qualified Default Investment Alternative ("QDIA"). The Plan provides, in certain cases, for limits on contributions in accordance with applicable income tax rules and regulations.

Participants are always fully vested in their contributions. Bargaining Unit Employee participants are always fully vested in the company fixed contribution of 3% and are fully vested in their matching contributions after two (2) years of credited service. Salaried Employee participants are fully vested in the company contribution and in their matching contributions after two (2) years of credited service.

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$323,739 and \$79,431. Forfeited nonvested accounts used to reduce Participating Company contributions in 2024 was \$110,008.

The Plan provides for loans to participants, which are secured by the balance in the participant's account. These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules. A participant may have no more than two loans outstanding at a time. Loans must be for at least \$1,000, and the total balance of all of a participant's loans may not be more than the lesser of 50% of their vested account balance or \$50,000. Loans bear interest at a rate established by the Plan Administrator in accordance with applicable law. The interest rate for new

loans in 2024 ranged between 8.50% and 9.50% and ranged from 8.00% and 9.50% in 2023. Loans may be repaid through payroll deductions and must be repaid within five (5) years of the date of the loan. Loans may be repaid in full at any time.

A participant who has retired or whose employment has terminated for any reason may elect to receive a lump sum, defer the distribution or receive the distribution in installments, provided the participant's account balance exceeds, or exceeded at the time of any prior distribution, \$1,000. If the participant's account balance is \$1,000 or less, they will receive a single-sum cash payment of their account balance. Upon termination of service, a participant may also elect to transfer his or her vested interest in the Plan to the qualified plan of a new employer or rollover his or her funds into an Individual Retirement Account.

Separate accounts are maintained for each participant. Each participant is credited with the participant's contribution, allocations of any Participating Company contribution and earnings thereon. Participants are entitled to their vested account balance. Participants direct Fidelity Management Trust Company (the "Trustee") to invest their contributions and accumulated balances in their accounts into various investments provided through the PPL Defined Contribution Master Trust (the "Master Trust").

If a participant becomes employed by a subsidiary or affiliate of the Company that is not a Participating Company, such participant is no longer covered by the Plan as of the date of their change in employer and instead becomes eligible to participate in a defined contribution plan maintained by the non-Participating Company, and their account in the Plan is transferred to an account for them under the other plan. If an eligible employee transfers employment from a subsidiary or affiliate of the Company that is not a Participating Company, their period of employment with such non-Participating Company is recognized for purposes of determining eligibility to participate and vesting in the Plan, and their account under the non-Participating Company's defined contribution plan transfers to an account for the participant under the Plan. As of the date of their transfer, the participant's rights and obligations with respect to the transfer account are governed by the terms of this Plan, except that the participant's vested interest in the transfer account is determined by the terms of the plan from which it was transferred.

Provisions of the Plan regarding vesting, distributions, loans and other matters are more fully described in the Plan document.

The Trustee of the Plan holds the Plan's investments in the Master Trust, and invests the cash received, interest, and dividend income, and makes distributions to participants. The Plan pays investment and administrative expenses directly.

Certain administrative functions of the Plan are performed by employees of the Company. No such employee receives compensation from the Plan.

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and other participant-based fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments and are reflected in Plan interest in net investment income (loss) of the

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The accompanying financial statements have been prepared under the accrual basis of accounting.

For the following note disclosures, dollar amounts are presented in thousands.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

The Plan's investments are stated at fair value as discussed in Note 4 except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the gains and losses on investments bought and sold as well as held during the year and is reflected in Plan interest in net investment income (loss) of the PPL Defined Contribution Master Trust on the Statement of Changes in Net Assets Available for Benefits.

Distributions to participants who terminate service for reasons other than retirement, disability or death are recorded in the period during which service is terminated unless such participants defer the distributions. Single sum distributions for active, retired, deceased, disabled and deferred terminated participants are recorded as distributed. Installment payments are recorded as distributed.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

### Subsequent Events

The Plan has evaluated subsequent events through August 19, 2025, the date the financial statements were available to be issued.

3. INTEREST IN PPL DEFINED CONTRIBUTION MASTER TRUST

PPL maintains a Master Trust with the Trustee to pool the investments of its defined contribution benefit plans. Each participating plan has a divided interest in the Master Trust. The assets of the Master Trust are held by the Trustee. The value of the Plan's interest in the Master Trust is based on the beginning of year value of the Plan's interest in the Master Trust plus actual contributions and allocated investment income less actual distributions and allocated administrative expenses. Investment income and administrative expenses relating to the Master Trust are allocated to the individual plans based on participants' individual account balances in each plan, calculated within the daily valuation process.

Investment at contract value represents those directed by participants to the Blended Interest Rate Fund (the "Fund") within the Master Trust which is combined with similar investments applicable to other plans participating in the Master Trust and invested in high-grade investment contracts issued by insurance companies and banks, as well as other high-quality debt obligations and short-term money market instruments. Wrapper contracts are purchased from another party, which are agreements that allow for the Fund to maintain a constant Net Asset Value ("NAV") per share and

provide for participant transactions to be made at contract value. In a typical wrapper contract, the wrapper issuer agrees to pay the Fund the difference between the contract value and the market value of the covered assets if the market value becomes totally exhausted as a result of significant participant redemptions. Purchasing wrapper contracts is similar to buying insurance, in that the Fund pays a relatively small amount to protect against the relatively unlikely event of participant redemption of most of the shares of the Fund. The fair value of the wrapper contracts is determined using the replacement cost methodology that incorporates various inputs including the difference between the market for wrapper fees and the actual wrapper fees currently charged.

Wrapper contracts accrue interest using a formula called the "crediting rate". Wrapper contracts use the crediting rate formula to convert market value changes in the covered assets into income distributions in order to minimize the difference between the market and contract value of the covered assets over time. Using the crediting rate formula, an estimated future market value is calculated by compounding the Fund's current market value at the Fund's current yield to maturity for a period equal to the Fund's duration. The crediting rate is the discount rate that equates estimated future market value with the Fund's current contract value. Crediting rates are reset monthly.

The crediting rate, and hence the Fund's return, may be affected by many factors, including purchases and redemptions by shareholders. The precise impact on the Fund depends on whether the market value of the covered assets is higher or lower than the contract value of those assets. If the market value of the covered assets is higher than their contract value, the crediting rate will ordinarily be higher than the yield of the covered assets. Under these circumstances, cash from new investors will tend to lower the crediting rate and the Fund's return, and redemptions by existing shareholders will tend to increase the crediting rate and the Fund's return.

If the market value of the covered assets is lower than their contract value, the crediting rate will ordinarily be lower than the yield of the covered assets. When market value is lower than contract value, the Fund will have, for example, less than \$10.00 in cash and bonds for every \$10.00 in NAV. Under these circumstances, cash from new investors will tend to increase the market value attributed to the covered assets and to increase the crediting rate and the Fund's return. Redemptions by existing shareholders will have the opposite effect, and will tend to reduce the market value attributed to remaining covered assets and to reduce the crediting rate and the Fund's return. Generally, the market value of covered assets will tend to be higher than contract value after interest rates have fallen due to higher bond prices. Conversely, the market value of covered assets will tend to be lower than their contract value after interest rates have risen due to lower bond prices.

If the Fund experiences significant redemptions when the market value is below the contract value, the Fund's yield may be reduced significantly, to a level that is not competitive with other investment options. This may result in additional redemptions, which would tend to lower the crediting rate further. If redemptions continued, the Fund's yield could be reduced to zero. If redemptions continued thereafter, the Fund might have insufficient assets to meet redemption requests, at which point the Fund would require payments from the issuer to pay further shareholder redemptions. The wrapper contracts provide a guarantee that the crediting rate will not fall below 0%.

The Fund is credited with earnings on the underlying investments and charged for plan withdrawals and administrative expenses charged by the contract issuers. Contract value is the relevant measurement for the Fund (which represents contributions made under the contract, plus earnings,

less withdrawals and administrative expenses), because the contracts held by the Fund are fully benefit-responsive. For example, within the Fund participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Fund to transact at contract value with the issuer. Such events include the following: (1) amendments to the participating plan documents (including complete or partial plan termination or merger with another plan), (2) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures, spinoffs of a subsidiary, or other events impacting a significant number of participants as defined in the contracts) that cause a significant withdrawal from the participating plans, or (3) the failure of the Master Trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The investment contract can be terminated by issuers and settled at amounts different from contract value if certain events occur. Such events include the following: (1) the Fund does not meet its obligations under the contract, (2) the participating plans do not meet the qualification requirements of Section 401(a) of the Code, or (3) the participating plans are terminated and assets distributed to participants. The Plan Administrator does not believe that the occurrence of any such event, which would result in termination of the contracts and limit the Fund's ability to transact at contract value with participants, is probable.

#### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable. Management believes such inputs are predicated on the assumptions market participants would use to measure the asset at fair value.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

(a) In accordance with accounting guidance certain investments that are measured at fair value using the NAV, or its equivalent, practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the disclosure of total investments at fair value of the Master Trust in Note 3.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The common collective trust funds are valued at the NAV of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There are no unfunded commitments. Participant transactions (purchases and sales) may occur daily. If the Plan was to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business fashion.

## 5. INFORMATION CERTIFIED BY TRUSTEE

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024

and 2023. Accordingly, the Trustee of the Plan has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

## 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Participating Company contributions and would receive distribution of their accounts.

## 7. TAX STATUS

The Plan obtained its latest determination letter on June 26, 2018, in which the Internal Revenue Service (IRS) stated that the Plan and its amendments dated through December 1, 2016, as then designed, were in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan has been amended since December 1, 2016. However, the Plan Administrator, and the Plan's internal tax counsel believe that the Plan is currently designed in compliance with the applicable requirements of the Code, and the Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 8. RISK AND UNCERTAINTIES

The Plan's interest in the Master Trust provides for various investment options in various combinations of investment funds. Investment funds are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

At December 31, 2024 and 2023, the Master Trust includes certain commingled trust fund investments whose respective fair values are in excess of 10% of total Master Trust assets. The Plan's concentration in these funds is dependent upon the investment allocations selected by the Plan's participants.
