**1. Description of the Plan**

The following is a brief description of the Virginia Dare Extract Co., Inc. 401(k) Plan (the “Plan”) which is provided for general information purposes only. The Plan document, related adoption agreement and individual statements provided to each Plan participant should be referred to for more complete information.

**General**

The Plan is a qualified defined contribution pension plan covering eligible employees of Virginia Dare Extract Company, Inc. (the “Company”). The Plan provides for elective deferral of wages and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). John Hancock Life Insurance Company of New York is the investment custodian of the Plan (the “Investment Custodian”). The Investment Custodian is a qualified institution in accordance with 29 CFR 2520.103-5 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. The Plan administrator is responsible for overseeing and ensuring compliance with the Plan document. The Investment Custodian and the Plan administrator are appointed by the Company.

**Eligibility**

The Plan covers all eligible employees of the Company who have completed six months of service and have attained the age of 21. The Plan excludes those employees who are: (1) non-resident aliens and (2) Union Employees. Entrance in the Plan is the first day of the month coincident with or next following the date the eligibility requirements is met.

**Participant Contributions**

Compensation for Plan purposes include income reported on form W-2 with all pre-tax contributions included. The Plan allows participants to make Roth contributions. Participants may elect to defer 100% of compensation on a pre-tax basis.

For 2024, the maximum amount of compensation that may be considered for deferral purposes by participants and employer contributions is \$345,000. For 2024, total participant contributions are limited to a maximum of \$23,000. For 2024, individuals who are at least 50 years of age can make an additional “catch-up” contribution not to exceed \$7,500. The maximum annual addition for 2024 that may be contributed or allocated to a participant’s account under the Plan shall not exceed the lesser of 100% of a participant’s compensation or \$69,000 for employees under age 50 and \$76,500 for employees over the age of 50.

**1. Description of the Plan**

**Employer Contributions**

The Company provides for Safe Harbor matching contributions of 100% of elective deferrals that do not exceed 3% of compensation plus 50% of the amount of the elective deferrals that exceed 3% but does not exceed 5% of total compensation, up to the maximum covered compensation level. For 2024, the maximum Safe Harbor matching contribution was limited to \$13,800. The Company also has the option of electing an employer profit sharing contribution based on a discretionary percentage of compensation. The Company did not elect a profit-sharing contribution in 2024.

**Rollover Contributions**

A Plan participant may make a transfer to the Plan of a benefit from a qualified retirement plan of another employer, referred to as a rollover, with certain restrictions.

**Investments**

Participants direct the investment of their contributions into various investment options offered by the Plan.

**Vesting**

Participants are immediately vested in their contributions and employer Safe Harbor matching contributions as well as any earnings thereon. Regarding the profit-sharing contribution, there is no vesting in the first 2 years of service and the participant becomes 100% vested after 3 years of service.

**Participant Accounts**

The Plan administrator establishes and maintains a separate account for each participant, which is credited for voluntary and rollover contributions the participants make, employer contributions and Plan earnings. Income earned and net appreciation or depreciation on Plan investments, for a given investment, are allocated in proportion to the participant's accounts balances in that investment. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants**

Each participant may borrow up to the lesser of: (1) 50% of the present value of the participant's vested interest in the account or (2) \$50,000. No note shall be less than \$1, and only two notes can be outstanding at one time. The notes are secured by the vested balance in the participant's account. The notes shall bear a reasonable rate of interest as determined by the Plan administrator.

**1. Description of the Plan**

**Notes Receivable from Participants**

The interest rate on notes outstanding at December 31, 2024, ranged between 4.25% to 9.75% per annum. Any such borrowings are to be repaid within five years. Principal and interest are to be repaid by payroll deductions.

**Forfeitures**

Upon termination of employment participants forfeit their non-vested balances. These accounts may be used to reduce future Company contributions or to pay administrative expenses. At December 31, 2024 and 2023, there were no forfeited non-vested accounts. No forfeited amounts were used to reduce Company contributions or to pay administrative expenses for the year ended December 31, 2024.

**Retirement**

The normal retirement age is defined as the later of the two events, either when a participant reaches the age of 59 1/2 or the 5th anniversary of their participation in the Plan. A participant, who becomes disabled, as defined in the Plan document, is eligible for a disability retirement.

**Distribution of Benefits**

On termination of service prior to the normal retirement age, the participant may elect to receive a distribution of his or her vested benefit or may choose to rollover the benefit to another qualified plan or IRA account. Upon retirement, termination, death, disability, or attainment of age 59 1/2, vested benefits may be distributed via a lump sum payment. The Plan does not allow for hardship withdrawals. Participants must begin receiving Required Minimum Distributions, under IRS guidelines, upon reaching the age of 73.

**Administrative Expenses**

Administrative expenses may be paid out of the Plan or by the Company. During 2024, the Company incurred certain administrative expenses relating to the Plan without charge to the Plan.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates and Assumptions**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements. Purchases and sales of securities are reflected on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is accrued when earned. The Plan presents, in the Statement of Changes in Net Assets Available for Benefits, the net appreciation (depreciation) of the fair value of its investments, which includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024, or 2023.

**Payment of Benefits**

Benefit payments to participants or beneficiaries are recorded when paid.

**Risks and Uncertainties**

The Plan provides for various investment options. Investment securities are exposed to various risks including, but not limited to, interest rates, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances, and the amounts reported in the Statements of Net Assets Available for Benefits.

**2. Summary of Significant Accounting Policies**

**Income Tax Status**

The Plan is an adoption of a non-standardized pre-approved plan that received an IRS opinion letter dated June 30, 2020, stating that the pre-approved plan, as then designed, was then in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). An employer adopting this pre-approved plan is considered to have a plan qualified under section 401(a) of the IRC. Once qualified the Plan is required to operate in conformity with the IRC to maintain its qualified status. The Plan administrator and the Plan’s legal counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan continues to be qualified, and the trust established under the Plan is tax-exempt. No provision for income taxes has been included in the financial statements since the Plan has no unrelated business income tax.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the Department of Labor (“DOL”). The Plan administrator has analyzed the tax positions taken by the Plan and concluded that as of December 31, 2024, and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the IRS and the DOL, however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Subsequent Events**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

**3. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100 percent vested in their employer contributions.

**4. Investments**

For the year ended December 31, 2024 the Plan's investments appreciated (including gains and losses on investments bought and sold, as well as held during the year) in value by \$4,412,348.

**5. Fair Value Measurements**

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

**5. Fair Value Measurements**

**Pooled separate accounts:** Valued at the net asset value (“NAV”) of units of the underlying insurance company maintained pooled separate account. The NAV, as provided by the Investment Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participants transactions (purchases or sales) may occur daily. There are currently no redemption restrictions or unfunded commitments on these investments. The primary investment strategy of the various pooled separate accounts are to first grow and then later preserve principal. These pooled accounts contain a mix of U.S. and international common stocks and bonds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
