## Independent Auditor's Report

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter - Basis of Accounting**

As discussed in Note 6 to the financial statements, the Plan sponsor elected during 2024 to terminate the Plan, and management determined liquidation was imminent. As a result, the Plan's 2024 and 2023 financial statements are prepared on the liquidation basis of accounting. Also, as described in Note 6, the net assets of the Plan were fully distributed as of December 20, 2024. Our opinion is not modified with respect to these matters.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Sorrento Therapeutics, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Sorrento Therapeutics, Inc. 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Sorrento Therapeutics, Inc. 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Note 1 - Description of Plan:**

The following description of the Sorrento Therapeutics, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement and the Summary Plan Description for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering eligible employees of Sorrento Therapeutics, Inc. (the “Employer” and “Company”) who are at least 21 years of age, and who elect to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Company has appointed Voya Institutional Trust Company (“VITC”) as Trustee of the Plan assets with authority over management and investment of Plan assets and Plan accounting and reporting and has adopted the Non-Standardized Voya Retirement Insurance and Annuity Company Prototype 401(k) Profit Sharing Plan, effective June 24, 2020.

The Employer is a member of a controlled group and four participating employers are included in the Plan. The Plan was modified effective September 21, 2023 for the cessation of one of these participating employers, Silex Pharmaceutical Inc.’s (Silex), from participating in the Plan. The assets of Silex were transferred out to a different Plan in September 2023 and March 2024.

**Contributions**

Participants may make elective deferral contributions up to the maximum dollar amount established by the Internal Revenue Code (IRC) of pretax annual compensation, as defined in the Plan. Participants age 50 and older may make catch-up contributions to a maximum dollar amount established by the IRC. Participants may elect to designate all or any portion of their elective deferral contributions as Roth elective deferrals. Participants may also contribute amounts representing distributions from other tax qualified plans (rollovers).

The Company in its discretion may make qualified matching contributions. The qualified matching contributions are equal to 4% of the employee elective deferral contributions, and totaled \$119,489 for the period January 1, 2024 to December 20, 2024.

Employees that have completed 1,000 hours of service and are employed on the last day of the Plan year are eligible to receive an allocation of the Company’s annual profit-sharing contribution. The Company did not make a profit-sharing contribution for the period January 1, 2024 to December 20, 2024.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution, allocation of the participant’s share of the Company’s matching contributions (including profit-sharing and discretionary contributions, if any), and the participant’s share of the Plan’s earnings and losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds held in pooled separate accounts and one money market account.

**Forfeitures**

Forfeitures are used to reduce Company contributions or to pay Plan expenses. \$16,711 in forfeitures were used to reduce the Company contributions for the period January 1, 2024 to December 20, 2024. Forfeited balances totaled \$-0- and \$15,669 at December 20, 2024 and December 31, 2023, respectively.

**Vesting**

Participants are immediately 100% vested in their contributions to the Plan and employer qualified matching contributions. Vesting in all other Company contributions is based on years of continuous service as follows:

**Notes Receivable from Participants**

Participants may borrow from their vested accounts up to a maximum of \$50,000 (reduced by the amount, if any, of the highest outstanding balance of loans from the Plan during the preceding one-year period ending on the day before the date on which the loan is made) or 50% of their vested account balance, whichever is less, subject to certain restrictions, in accordance with borrowing procedures established by the Company. The loans are secured by up to one-half of the vested account balance in the participant's account, and such other security as the Company may require under certain circumstances. Interest rates on all outstanding loans were 4.25% to 9.50%, at December 31, 2023. There were no outstanding loans at December 20, 2024.

**Payment of Benefits**

On termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or in installments based on the life expectancy of the participant or designated beneficiary. Participants with vested benefits of greater than \$5,000 may elect to delay their distributions, but distributions are required to begin no later than April 1st following the end of the year in which the Participant reaches age 73.

The Plan permits hardship withdrawals.

**Note 2 - Significant Accounting Policies:**

**Accounting Method**

Due to the decision to terminate the Plan in March 2024, the Plan's financial statements have been prepared using the liquidation basis of accounting.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

**Fair Value Measurements**

Fair value accounting standards define fair value, establish a framework for measuring fair value, outline a fair value hierarchy based on inputs used to measure fair value and enhance disclosure requirements for fair value measurements. The fair value hierarchy distinguishes between market participant assumptions based on market data obtained from sources independent of the reporting entity (observable inputs that are classified within Level 1 or 2 of the hierarchy) and the reporting entity's own assumptions about market participant assumptions (unobservable inputs classified within Level 3 of the hierarchy).

- Level 1 inputs are quoted prices in active markets for identical investments that the Plan has the ability to access at the measurement date.
- Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable for the investment, either directly or indirectly.
- Level 3 inputs are unobservable inputs for the investment.

The Plan's statements of net assets available for benefits includes the following financial instruments that are required to be measured at fair value on a recurring basis:

- Investments in mutual funds are considered Level 1 assets, and are reported at fair value based on quoted net asset values of the shares held by the Plan at year-end.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable From Participants**

Participant loans are reported at their unpaid principal balances plus any accrued and unpaid interest.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Expenses to the Plan, including legal, audit, administrative, and Trustee expenses, are generally paid by the Company, with the exception of certain administrative expenses, which includes fees for investment services, which are paid for by the Plan and charged to participants' accounts. The Plan incurred \$114,185 of administrative expenses for the period January 1, 2024 to December 20, 2024.

**Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term, and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

**Subsequent Events**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 13, 2025, the date the financial statements were available to be issued, and concluded that there were no events or transactions that needed to be disclosed, except as disclosed in Note 6.

**Note 4 - Information Prepared and Certified by the Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to the Plan's investments disclosed in the accompanying financial statements, including investments held at December 20, 2024 and December 31, 2023, net appreciation in fair value of investments, interest and dividend income, and notes receivable for the year ended December 31, 2023, was obtained or derived from information certified as complete and accurate by Voya Institutional Trust Company, the trustee of the Plan.

**Note 5 - Party-In-Interest Transaction:**

Certain Plan investments are shares of mutual funds managed by Voya Institutional Trust Company, the Trustee, as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included in net depreciation in fair values of investments.

**Note 6 - Plan Termination:**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

Effective March 29, 2024 the Plan was terminated. As a result, employee and employer contributions into the Plan ceased on March 29, 2024. Participant investment accounts continued to earn interest and dividends and appreciated (depreciated) in value until such time the participants' account balance was distributed. All assets of the Plan were fully distributed as of December 20, 2024.

**Note 7 - Tax Status:**

The Company has adopted the Prototype Non-Standard Profit-Sharing Plan with CODA Plan offered through Voya Retirement Insurance and Annuity Company Non-Standard 401(k) Profit Sharing Plan. This Plan received a favorable opinion letter from the Internal Revenue Service (“IRC”) on March 31, 2008, which stated that the Plan and related Trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The Company adopted the amended Plan document effective January 1, 2015.

The Plan believes that it has appropriate support for any tax position taken, and, as such, does not have any uncertain tax positions that are material to the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examination for years prior to 2020.
