(the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of 403(b) Thrift Plan of East Missouri Action Agency, Inc.'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of 403(b) Thrift Plan of East Missouri Action Agency, Inc. Because of the significance of the matter discussed in the Basis for Disclaimer of Opinion section of this report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer Opinion

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about 403(b) Thrift Plan of East Missouri Action Agency, Inc.'s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of 403(b) Thrift Plan of East Missouri Action Agency, Inc.'s financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of 403(b) Thrift Plan of East Missouri Action Agency, Inc. and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedule.

Notes to the financial statements

Note 1: Description of Plan

The following description of the 403(b) Thrift Plan of East Missouri Action Agency, Inc. (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by East Missouri Action Agency, Inc. (the "Employer") on October 11, 1999, to provide employees with a means of savings and investing for the future. All full-time employees of the Employer are eligible to enroll in the plan. All investments are participant-directed. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year, participants may contribute up to 100% of eligible compensation as defined in the Plan. Participants who have attained age 50 and have 15 years of service with the Employer before the end of the Plan year are eligible to make catch-up contributions, as defined in the Plan document. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer makes a base contribution of 2% eligible compensation to all employees of the Employer who have 1 year of service. Employees do not need to make elective deferrals in order to receive the Employer base contribution.

The Employer also makes matching contributions according to the following criteria:

1. After 11 years of employment with the Employer, the employee will receive a match of up to 2% of eligible compensation.
2. After 20 years of employment with the Employer, the employee will receive a match up to an additional 2% of eligible compensation (total match up 4%).

Contributions may not exceed the annual maximum allowed by the Internal Revenue Service (IRS).

Participant Accounts

Each participant's account is credited with the participant's contributions, Employer base and matching contributions and allocations of plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to the financial statements

Note 1: Description of Plan (Continued)

Vesting

Participants are fully and immediately vested in their contributions, plus actual earnings thereon. Participants hired before January 1, 2020 are 100% vested in Employer base and matching contributions, plus actual earnings thereon. Participants hired on or after January 1, 2020 are vested in the Employer base and matching contributions and earnings thereon according to the following schedule:

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,003 and \$463, respectively. These accounts will be used to reduce future Employer contributions in accordance with the Plan document. During 2024, forfeitures of \$5,294 were used to reduce Employer contributions.

Notes Receivable From Participants

The Plan does not allow for participant loans.

Payment of Benefits

A participant may withdraw funds from any of their accounts under the Plan prior to their benefit commencement date for any of the following reasons: severance of employment, death, disability, reaching age 59 1/2, hardship, or after completing five years of service with the Employer. Payment options include lump-sum and direct rollover. Various annuity options are available for those participants who terminated due to death, disability, or reaching age 59 1/2. Payments may not exceed the value of the participant's interest in their account.

Participants with balances less than \$5,000 who terminate service will have the value of their accounts distributed to them upon termination.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Expenses of maintaining the Plan that are paid by the Employer are excluded from these financial statements. Fees related to investment advisory and recordkeeping are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in total investment income.

Scope Limitation - Excluded Contracts and Accounts

The Plan maintains investment contracts with American Funds, in accordance with DOL Field Assistance Bulletin 2009-02, Annual Reporting Requirements for 403(b) Plans, has elected to exclude such contracts with which it has not been involved subsequent to January 1, 2009. If these contracts were included, net assets available for benefits would increase by approximately \$95,000 and \$81,000 as of December 31, 2024 and 2023. Also, the net increase in the Statement of Changes in Net Assets Available for Benefits would have been increased by approximately \$14,000.

Note 2: Summary of Significant Accounting Policies (Continued)

Reclassification

Certain amounts as previously reported in the 2023 financial statements have been reclassified to conform to the 2024 presentation. Such reclassifications have no effect on reported amounts of net assets available for benefits or change in net assets available for benefits.

Subsequent Events

Subsequent events were evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Annuities: Reported at the fair value of the underlying investments held by Kansas City Life.

Money market fund: Valued at the quoted net asset value of shares held by the Plan at year-end.

Mutual funds held in pooled separate accounts: Fair value of mutual funds held in pooled separate accounts is based on quoted net asset values of underlying investments held by the pooled separate accounts, adjusted by an asset charge. The underlying mutual funds held in the pooled separate accounts are open-end mutual funds registered with the U.S. Securities and Exchanged Commission. The funds must publish their daily net asset value and transact at that price.

Note 4: Information Prepared and Certified by the Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, and including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Mutual of America Life Insurance Company and Kansas City Life, the Custodians of the Plan.

Note 5: Related-Party Transactions and Party-In-Interest Transactions

Certain plan investments are managed by Mutual of America Life Insurance Company, a Custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred and paid by the Plan for administrative services to Mutual of America Life Insurance Company was \$2,532 and for Kansas City Life was \$210 for the year ended December 31, 2024.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Employer contributions.

Note 7: Tax Status

The Employer adopted a non-standardized pre-approved Plan, which the IRS has determined and informed the Employer by a letter that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
